ACCESS AND CONSTRUCTION EASEMENT FOR WATER LINE PURPOSES AT 12752 TRASK

AVENUE, GARDEN GROVE

### **OBJECTIVE**

It is requested that the City Council authorize the acceptance of an easement deed and temporary construction easement deed for property located at 12752 Trask Avenue, Garden Grove.

### BACKGROUND/DISCUSSION

The City's Water Master Plan identified a fire flow deficiency area at 12752 Trask Avenue (Doig Intermediate School). The Lilly Street/Trask Avenue Water Improvement Project's objective is to install a pipeline connecting the nearby existing pipes to provide a looping water system to resolve this fire flow deficiency. The Garden Grove Unified School District Board has granted an easement and a temporary construction and access easement to facilitate the Project.

### FINANCIAL IMPACT

There will be no compensation paid, as the property will benefit from improved water flow. There is no impact to the General Fund for the acceptance of the easement and temporary construction easement.

## **RECOMMENDATION**

Staff recommends that the City Council:

· Authorize the City Clerk to accept, on behalf of the City, the easement and temporary access and construction easement for property located at 12752 Trask Avenue, Garden Grove.

does hereby GRANT to

CITY OF GARDEN GROVE, a municipal corporation ("Grantee"), a permanent easement and right-of-way to establish, construct, reconstruct, install, enlarge, repair, refurbish, rehabilitate, inspect, operate, maintain and use for all time water pipeline(s), and all appurtenances thereto, including ingress and egress for said purposes, over and through that certain real property situated in the City of Garden Grove, County of Orange, State of California, more particularly described as follows:

## PER LEGAL DESCRIPTION SHOWN IN EXHIBIT "A", AND DELINEATED ON PLOT MAP SHOWN AS EXHIBIT "B", BOTH OF WHICH ARE ATTACHED HERETO AND MADE A PART HEREOF

Together with the right to enter upon and to pass and repass over and along said easement and right of way to deposit tools, implements, and other materials thereon, by the Grantee and by any contractor, its agents and employees, engaged by said Grantee, whenever necessary for the purpose above set forth.

THIS GRANT is made by the Grantor under the full understanding and condition that the Grantee, by acceptance of this grant, has the right to permanently remove all things thereon that interfere with the purposes for which said easement is granted. Further, it is agreed by the Grantor that any structure place upon, or tree, plant or shrub planted on, along, or adjacent to said easement which injures the water pipeline(s) or interferes with the use, operation or maintenance, repair, enlargement, reconstruction, refurbishment, inspection, rehabilitation, or replacement thereof shall be removed by the Grantor at its expense.

It is understood that each undersigned grantor grants only that portion of the above described land said grantor has an interest.



FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

# GARDEN GROVE UNIFIED SCHOOL DISTRICT, who took title as GARDEN GROVE SCHOOL DISTRICT, a California public entity ("Grantor"),

does hereby GRANT to

CITY OF GARDEN GROVE, a municipal corporation, (hereinafter called "Grantee"), a Temporary Construction and Access Easement, for the purposes of constructing, installing, using, repairing, a water line and other appurtenant structures as part of the Lilly Street/Trask Avenue Water Improvement Project (the "Project"), across the following described real property shown in Exhibit "A" and Exhibit "B", attached hereto and made a part hereof:

TO HAVE AND TO HOLD said easement to said Grantee, for the use and purpose herein above described.

It is further understood that:

- 1. The rights granted herein shall not be construed to interfere with or restrict use of the premises by Grantor(s), their heirs or assigns, with respect to the construction and maintenance of property improvements along and adjacent to the premises herein described, so long as the same are so constructed as to not impair or interfere with the use and maintenance of access of utilities herein above authorized.
- 2. The Grantee hereby agrees to restore the easement area to its original condition, as close as is practical to do so, upon acceptance of the completion of the Project by the Garden Grove City Council.
- 3. This temporary construction easement shall be terminated upon recordation of a quitclaim deed after formal acceptance of Project completion by the Garden Grove City Council.
- 4. The Grantee agrees to indemnify and hold harmless the Grantor herein from liability arising out of the use of the property pursuant to this temporary Construction Easement.
