Date: October 22, 2013

OBJECTIVE

To hold a Public Hearing for receipt of objections to the Weed Abatement Notices mailed to parcel owners on September 11, 2013.

BACKGROUND

On September 10, 2013, City Council adopted Resolution No. 9202-13 pursuant to Section 39500, et seq. of the California Government Code declaring a nuisance exists in connection with the presence of weeds, rubbish, and debris on certain properties within the City of Garden Grove. A Public Hearing has been scheduled for October 22, 2013, to receive any objections to the Weed Abatement Notices.

Parcel owners had until October 09, 2013, to clear their properties. The City's Weed Abatement Official re-inspected these parcels on October 10, 2013; uncleared parcels are identified in the updated "Exhibit A."

DISCUSSION

The City's contractor is to begin clearing privately owned properties that are not in compliance on October 23, 2013, with work slated for completion within 30 days.

FINANCIAL IMPACT

There is no financial impact.

It is recommended that the City Council hold a Public Hearing, receive testimony, and take one of the following actions:

- Uphold the objections and order individual properties to be removed from the scheduled abatement process;
- Overrule the objections and direct staff to proceed with the scheduled weed abatement; or
- If there are no objections, direct staff to proceed with the scheduled weed abatement.
