OBJECTIVE

For City Council to accept Project No. IFB S-1121 – 2013 Residential Street Rehabilitation Project as complete, and authorize the City Manager to execute the Notice of Completion of Public Improvement and Work.

BACKGROUND

This is to certify that R.J. Noble Company, contractor for the above project, has completed the project. The project was awarded to R.J. Noble Company on August 13, 2013. The total bid amount was \$632,699.99.

The work consisted of grinding and asphalt overlay on forty (40) residential streets representing 3.89 center lane miles. The project was funded from Gas Tax monies.

Credits in the amount of \$69,116.50 to the original contract consist of work that was deleted.


FINANCIAL IMPACT

It is recommended that the City Council:




