AGREEMENT WITH VALI COOPER & ASSOCIATES, INC. FOR ON-CALL

INSPECTION SERVICES

OBJECTIVE

To request City Council approval of Amendment No. 1 to the Agreement approved by the City Council on August 28, 2012, with Vali Cooper & Associates, Inc. for on-call construction inspection services.

BACKGROUND/DISCUSSION

Engineering Services has a construction inspector position that is currently vacant due to budget reductions from prior fiscal years. Without construction inspection, quality control and quality assurance would be lost on crucial, federally funded capital projects, thus jeopardizing the quality and longevity of infrastructure improvements in the City.

The current agreement is set to expire by February 2014. The proposed Amendment will amend the existing Agreement to add \$70,000 to the current Purchase Order, thus allowing inspection work to continue without service delays.

FINANCIAL IMPACT

There is no impact to the General Fund. The additional \$70,000 will derive from grant funds, Measure M2 and Gas Tax revenues.

RECOMMENDATION

Staff recommends that the City Council:

- Approve Amendment No. 1 to the Agreement with Vali Cooper & Associates, Inc.
 in the amount of \$70,000 to provide construction inspections services for Public
 Works projects; and
- Authorize the City Manager to execute Amendment No. 1 to the Agreement with Vali Cooper & Associates, Inc. on behalf of the city, and to make minor modifications as appropriate.

To: Professional Services Agreement to Provide On-Call Inspection Services

This Amendment No.1 to Professional Services Agreement to Provide On-Call Inspection Services is made and entered into this ____ day of _____ 2014, by and between the CITY OF GARDEN GROVE, hereinafter referred to as "CITY", and Vali Cooper and Associates, Inc., hereinafter referred to as "CONSULTANT".

RECITALS

The following recitals are a substantive part of this Agreement:

- 1. WHEREAS, CONSULTANT and CITY entered into a Professional Services Agreement pursuant to Garden Grove Council authorization dated August 28, 2012.
- 2. WHEREAS, CITY desires to continue to utilize the services of CONSULTANT to provide On-Call Inspection Services for additional work beyond that originally contemplated.
- 3. CONSULTANT is willing to perform additional On-Call Inspection Services.

AGREEMENT

THE PARTIES MUTUALLY AGREE AS FOLLOWS:

1. Section 3.0, Compensation, shall be revised as follows:

The contract Price is hereby increased from \$300,000 to a new Firm Fixed Price of \$370,000. This is an increase of \$70,000. Pricing shall be per the fee schedule attached as Exhibit A to the August 28, 2012 Agreement.

2. Except as expressly amended pursuant to this First Amendment, all other provisions of the Agreement shall remain in full force and effect.
