OBJECTIVE

For the Garden Grove City Council to accept Project No. 7372 – Buaro Street and Haster Street Water Improvements as complete, and authorize the City Manager to execute the Notice of Completion of Public Improvements and Work.

BACKGROUND

The Buaro Street and Haster Street Water Improvements Project consisted of installation of 1,780 feet of 12-inch and 1,329 feet of 8-inch diameter polyvinyl chloride (PVC) domestic water pipe and 366 feet of 8-inch diameter ductile iron (DI) domestic water pipe. It also included the construction of approximately seven (7) hydrant assemblies, thirty-eight (38) water service connections and eight (8) connections to existing water mains. This project also requires removal and/or abandonment of existing water mains. This project has relieved fire flow capacity deficiencies in the areas along Buaro Street from Twintree Avenue to Chapman Avenue, Haster Street from Ascot Drive to Simmons Avenue, and Simmons Avenue.

DISCUSSION

The contractor, John T. Malloy, Inc., has completed this project in accordance with the plans, specifications and other contract documents.

FINANCIAL IMPACT

The project was funded with Water Funds and was completed within budget and on schedule. The retention payment will be released after recordation of the Notice of Completion with the County of Orange.
