### **OBJECTIVE**

For the City Council to adopt a resolution accepting grant funds from the "Clean Transportation Local Government Match Program" by the Mobile Source Air Pollution Reduction Review Committee (MSRC).

#### BACKGROUND

In February 2007, the Mobile Source Air Pollution Reduction Review Committee (MSRC) announced funding for the "Clean Transportation Local Government Match Program." The program is available to cities and counties within the South Coast Air Quality Management District (AQMD) and provides funding assistance for the purchase of heavy-duty alternative fuel vehicles, up to \$25,000 per vehicle.

### DISCUSSION

Staff submitted an application to the MSRC for the purchase of three heavy-duty Compressed Natural Gas (CNG) vehicles and was subsequently awarded a total of \$75,000. Funds will be used to purchase two heavy-duty CNG dump trucks that will primarily be used for roadway construction projects and one CNG construction truck. City Council approved the purchase of the two dump trucks in November 2007 for the amount of \$355,000. The third vehicle is scheduled for purchase in 2009.

### FINANCIAL IMPACT

The total cost of the three vehicles is \$513,000. Grant funds will offset the cost by \$75,000. The remaining cost of \$438,000 to the Vehicle Maintenance Replacement Fund is available in the adopted budget. There is no impact to the General Fund.

- Authorize the Mayor and City Clerk to execute the resolution on behalf of the City Council.
