On Tuesday, May 17, 2016, an email correspondence was sent to the local business community from the Crime Prevention Division of the Garden Grove Police Department. The purpose of the open letter was to inform the business community of an upcoming community forum on May 18, 2016 that City Council's Medical Marijuana Task Force was convening. The letter contained a list of issues and information surrounding medical marijuana businesses as seen from a Public Safety perspective.

Unfortunately, neither Chief Elgin nor I got the chance to review the correspondence in advance, and it was not consistent with the news release that the City Administration had sent out to notify the community about the public forum. Chief Elgin and I agree that the open letter may have been perceived as an attempt to slant the opinion of business owners with regard to upholding the current ban on Medical Marijuana Dispensaries. It was not the intent of the City Administration or the GGPD to overstep our authority and influence or set policy.

The City Administration is committed to working collaboratively with the City Council to offer important information that the Council can use as it considers policy related to the possible regulation of medical marijuana. In fact, you have a report on this topic for consideration at the May 24, 2016 City Council meeting. Our most important task is to carry out the policies established by the City Council.

There are two immediate actions we are taking to strengthen our management controls:

 I have directed Ana Pulido, our public information officer, to review our current information dissemination policies, and make recommendations if necessary. She will also convene the various department representatives that work in this area, to ensure that public information is properly vetted through POLICY ON INFORMATION DISSEMINATION May 24, 2016 Page 2 of 2

the department directors and ultimately through my office. Once completed, I will share that Administrative policy with you.

2. The memorandum will be included in the May 26, 2016 Manager's Memo for public review. We also want to make available the audio recording of the May 18, 2016 public forum, so that people who were unable to attend can listen to all the comments that were shared. The Administration regrets any misunderstanding or confusion that the email correspondence from the GGPD Crime Prevention Division may have caused, and we will certainly refocus our efforts to ensure coordinated and consistent dissemination of public information. Strawberry Festival again should be fruitful for charities

GARDEN GROVE • Get ready for a berry good time this weekend – especially if you have a sweet tooth.

Strawberry shortcake, strawberry ice cream, strawberry everything will take center stage during Memorial Day weekend during the 58th annual Garden Grove Strawberry Festival, which is expected to attract 300,000 people over four days and raise

\$100,000 for local nonprofit organizations.

The festival is meant to honor the history of central Orange County's former strawberry fields – and to

"bring the community together," said Lon Cahill, this year's president of the Strawberry

Festival Association's board of di-

rectors.

Besides the common attractions - carnival rides and games, corn on the cob

and junk food – television celebrities will hand out 2,000 slices of free strawberry shortcake during a Friday evening cake-cutting ceremony.

The festival also will feature a 5K race and a parade Saturday morning, the Berry Berry Beautiful Baby competition and other contests, and a chance to meet Miss Garden Grove 2016 Raena Ramirez and her court.

"I didn't make it last year, but I think it will be awesome," said Ramirez, who is training for the Miss California competition in July. "Past queens have told me it's a lot of fun and worth the tiring moments."

This year's festival theme honors local sports heroes. Several Olympians will be honored during the parade, including 96-year-old Gold Medal diver Sammy Lee and eight-time swimming medalist Shirley Babashoff.

A male and female athlete from each of Garden Grove's seven high schools also will be honored.

"I'm a big sports fan," Cahill said. "And it's a community festival. Having the local high schools put up athletes to be honored is a great thing."

Last year, the festival donated \$90,000 – a decrease from past years – to 12 nonprofits. The awards ranged from \$3,000 to \$19,000. Since 1958, the Strawberry Festival Association has donated more than \$6.5 mil-

lion to nonprofits.

The 6 p.m. Friday cakecutting ceremony – kicking off the festival in earnest – and the parade at 10 a.m. Saturday are two of the biggest draws. Both will prominently feature Ramirez.

"The only other parade I've been in was a Fourth of July parade, and I was the Chick-fil-A cow," Ramirez said with a laugh. "This time, I'll get to wave to people. It should be a better experience."

To which a city official re-



In Garden Grove, meanwhile, the Promenade shopping center at Chapman and Brookhurst streets continues its revitalization.

Five years ago it got new landscaping and a pair of bigger stores, PetSmart and Party City, and two years ago a Wal-Mart opened there. Now a trio of fast-casual restaurant chains have arrived with a few more still to come.

Blaze Pizza and Wingstop opened this month, and Chipotle will open soon. Yogurtland and Panda Express are expected to open by the end of the summer. The shopping center also is getting an Aldi, the German discount grocer that's now making a push into the United States, with that store replacing the old Smart & Final and Anna's Linens.

New businesses certain to spice up Promenade

Shoppers are in store for added convenience and a better economic outlook for Garden Grove with the arrival of new businesses to the Promenade in Garden Grove, located at Chapman and Brookhurst streets.

The center added three, new, quick-serve restaurant chains to its shopping plaza: Blaze Pizza, Wingstop, and Chipotle. Blaze Pizza and Wingstop are now open for business, and Chipotle will celebrate its grand opening this month (For more on the Wingston opening, see Page 3).

Construction of a Yogurtland and Panda Express is currently underway, replacing the former Pizza Hut that was located on the north side of Chapman Avenue. Both establishments are anticipated to open in the late summer.

Aldi's, the German discount grocer, is also joining the plaza, replacing the former Smart & Final and Anna's Linens, at 9901 Chapman Avenue. Garden Grove will be the fourth city in Orange County to receive an Aldi's, which

Shoppers are in store for added is expected to be the junior anonyenience and a better eco-chor tenant in the plaza.

Regal Cinemas finished a complete remodel of its theatre earlier this year, which included replacing all its seating with larger, plush, electric reclining seats and upgrading sound and projector equipment.

In 2011, the Promenade underwent major landscaping improvements that renewed and beautified the look of the shopping center, as well as celebrated the grand openings of two major retail stores, Party City and PetSmart.

In 2014, Garden Grove's second Wal-Mart store opened on the west-end of the Promenade, at 11822 Gilbert St. Since then, leasing activities have gone up considerably.

Firefighter injured

Firefighters were dispatched to a commercial structure fire last week.

Damage to the structure is estimated at \$2,000 and unknown to the equipment. The cause of the fire is under investigation.





Many local dignitaries also attend. Garden Grove Mayor Bao Nguyen will cut the first piece and present the giant strawberry cake top to Miss Garden Grove Raena Ramirez.

During the four-day Memorial Day weekend event, more than 300,000 annual attendees head for the festival's 200-plus food and commercial booths where they find treasures to buy and all kinds of treats to try. Booths open at 1 p.m. on Friday May 27 and at 10 a.m. on May 28 through May 30.

The 2016 Festival Theme is "Celebrating Our Local Sports Heroes." Fourteen outstanding boy and girl athletes from each of the Garden Grove high schools will ride in the 10 a.m. Saturday parade. This year, 12 charities will be selling food to fill their coffers: Garden Grove's Assistance League, Boys and Girls Club, Emblem Club, High School Band Boosters, High School Baseball Boosters, Kiwanis Club and Lions Club, in addition to the Guardettes of Orange County, Job's Daughters, Pacifica High School Girls Softball and Shakelectively, the food booths bring in approximately \$90,000 for their charities.

Offerings include strawberry treats such as strawberry smoothies, cheesecake, crepes, bowls of strawberries with soft ice cream, strawberry sundae, strawberry shortcake, strawberry bread, strawberry royals, tart cups, chocolate covered strawberries and boxes of strawberries. Fairgoers will also find nacho supremes, pizza, chicken wings, hamburgers, cheeseburgers, carne asada, chicken tacos, cheese quesadillas, funnel cakes, baked potatoes, breakfast muffins, corn on the cob, hot dogs, chillitos, BBQ beef sandwiches and popcorn chicken.

The four-day festival will be held Memorial Day Weekend Friday, May 27 through Monday, May 30. This year's theme is "Celebrating Our Local Sports Heroes," and in support of the theme, five Olympic gold medalists will be in the parade along with the top boy and girl athletes from each of the seven Garden Grove high schools. Olympians are Shirley Babashoff, Dr. Sammy Lee, Bruce Furniss, Cliff Meidl and Dr. Lance Larson.

Miss California Bree Morse is the 91st Miss California. Morse is a 23-year-old Garden Grove native. She is a graduate of California State University, Long Beach with a bachelor's degree in Business Marketing. Last September, she competed for the title of Miss America, and although she did not come home with the crown, she was a beautiful representative of the state.

She continues to be an advocate for her platform, "Alopecia Areata Advocacy," Children's Miracle Network Hospitals, and an organization's sponsors. Due to her own experience with alopecia areata, she speaks on behalf of competed against professional those living with silent diseases. and many struggling to accept their physical differences.

Morse is a certified substitute teacher in Southern California. With the scholarship she earned, she plans to obtain a credential in English.

Derrin Horton Is a sportscaster for KTLA-TV. For the past 22 years, Horton has hosted, anchored, reported and called play by play for some of the largest sports networks in America. Since 2004, Horton reported from the sidelines and has hosted shows for many NFL Network productions. He spent the previous five years at KCALTV in Los Angeles anchoring "Sports Central," and was the main feature reporter for Channel 9's coverage of Los Angeles Lakers basketball. While at KCAL, Horton won an Emmy for his coverage of the Special Olympics. He holds a dual degree in broadcast journalism and political philosophy from Syracuse University. During college, he interned and worked at CBS Sports, WFAN Radio, WCBS-TV, WTVH-TV and WSTM-TV. In 1998, Horton joined Fox Sports Net as a sideline reporter on the Conference USA package, then as a college football and basketball announcer for ESPN. He's also called games for ABC Sports, NFL Network and ambassador for a number of the Fox Sports Net's coverage of NFL Europe, and for CBS Sports.

An athlete himself, he has even athletes in the Spike TV reality show "Pros vs. Joes," where he finished second in the competition, losing in overtime.

Dr. Sammy Lee, 96 years old, is the first American of Asian descent to win an Olympic gold medal for the United States. The diver, just 5-feet tall, had to overcome much discrimination. He received his MD at the USC medical school in 1947, becoming an ear, nose and throat specialist. While in

school. Lee squeezed in diving practice, but was only allowed at the Los Angeles Swim Stadium and Brookside pool one day a week, then the pool was emptied and replenished with fresh water the next day. In 1942, at the age of 22. Lee competed in the National Diving Championships and become the first non-Caucasian to win. In 1948 he won his first Olympic gold medal in the IOM platform and a bronze medal in the 3M springboard. In the 1952 Olympic Games, Lee won his second gold medal in the IOM platform. At 32, he was the oldest person to win a gold medal in diving, and the first male diver to win backto-back diving gold medals. He later coached Bob Webster to two gold medals and Greg Louganis to a silver medal. He is the only Asian-American to have won the James E. Sullivan award as the U.S. outstanding amateur athlete.

Shirley Babashoff was the most successful female U.S. Olympian prior to the 1990s, with a total of eight Olympic medals. She is recognized as one of the greatest freestyle swimmers of all time. Babashoff set six world records in individual events and shared in an additional five in relays. She also set 37 U.S. records (17 individual and 20 relay), and at one time held the U.S. freestyle record at every distance from 100-meter to 800-meter. She has garnered twenty-seven AAU titles in addition to taking the 200-meter and 400-

meter individual gold medals at the 1975 World Championships. At the 1976 Olympic Trials she won every freestyle event and the 400-meter individual medley. She set three U.S. records in the heats and three more in the finals, and broke the world record in the 800-meter freestyle. This ranks among the greatest swimming feats of all time. In 2005, Babashoff received the Olympic Order, the highest award of the Olympic Movement.

Cliff Meidl was the 2000 USA Olympian Flagbearer. When this kayaker led his U.S. Olympian teammates onto the field, many of the 2 billion viewers learned of his courageous rehabilitation from a tragic 1986 construction accident. Meidl had jackhammered into a buried power line that sent 30,000 volts of electricity through him. He suffered three cardiac arrest episodes and was "gone" for more than two minutes before being revived. He endured 15 surgeries and spent more than three years on crutches. The accident nearly forced the amputation of his legs; however, they were saved due to an innovative surgical procedure. At first, he turned to canoeing and kavaking for the rapeutic value then pursued an aggressive weightlifting and conditioning regimen. In 1995, Meidl won gold, silver and bronze medals in kayaking events at the U.S. Olympic Festival in Denver. He made two U.S. Olympic teams, a feat that only 15 percent of all Olympians accomplish. Today, an active financial analyst, he enjoys sharing his inspirational story with diverse audiences across the U.S.

Swimmer Bruce Furniss broke 10 World and 19 American records, and won 11 AAU and six NCAA Titles over a 17 year period, in spite of waging a personal battle against the crippling arthritic disease, ankylosing spondylitis, an affliction he had since age 16. As a member of the 1976 U.S. Olympic swimming team, Furniss won two gold medals in the 200meter freestyle, one of only three Americans to ever win this Olympic event, as well as the 4 X 200meter freestyle relay, setting world records in each event. Furniss also garnered two gold and two silver medals in World Championship competitions in 1975 and 1978. In 2004, he was recipient of the NCAA Silver Anniversary Award. Furniss became the 12th of only 14

Americans to break the 200-meter freestyle world record, which he accomplished four different times. He held the 200-meter freestyle world record from 1975 to 1979. His 1976 Olympic gold medal victory would outlast seven Olympic Quadrennials before being equaled in 2008 by Michael Phelps. Furniss was twice named World Swimmer of the Year. He is a founding board member of Swim with Phelps, a non-profit organization which provides college scholarships to physically challenged athletes.

Lance Larson competed at the 1960 Summer Olympics in Rome, Italy, where he received a gold medal for swimming the butterfly leg of the men's 4 X 100-meter medley relay for the winning U.S. team. The U.S. relay team set a new world record of 4:05.4. Individually, Larson also received a silver medal in the men's 100-meter freestyle at the 1960 Olympics. Initially, John Devitt of Australia was listed as the winner of the men's 100-meter freestyle race; however, both Larson and Devitt finished with identical time of 55.2 seconds. Results were decided by finish judges who relied on their eyes and did not use replays. The official results placed Devitt first and Larson second. The United States team appealed, bolstered by videotaped footage of the finish that appeared to show Larson the winner. The controversy would pave the way for electronic touchpads to be included in swimming events to determine finish and accurate timing. Larson went on to break the 100-meter butterfly world record twice in 1960; first, setting the new record of 59 seconds on June 29, 1960; and again, a new record of 58.7 seconds on July 24, 1960.

The four-day charity event, the second largest city festival in the Western United States, drew 300,000 last year. Highlights include the Friday evening official giant strawberry cake-cutting ceremony at 6 p.m. at the Showmobile (Acacia and Main streets) when free strawberry shortcake is served to more than 2,000 people. On Saturday morning, there will be a City of Garden Grove sister-city 5K Run and a festival VIP celebrity breakfast at the Garden Grove Community Center, with proceeds going to Casa Garcia's We Give Thanks.

This is followed by a parade that starts at 10 a.m. with celebrities, floats, bands, equestrians, athletes and characters. All four festival days will feature 35 carnival rides, four contests, more than 200 food and shopping booths, games, music and live entertainment.

Contests, held in the amphitheater, include the Berry, Berry Beautiful Baby Contest, Redhead Roundup, Strawberry Idol Karaoke and Tiny Tots King and Queen.

Huge crowds to converge on festival

Police issue information about street closures during four-day strawberry event

Beginning Friday, May 27 through Monday, May 30, the 58th annual Garden Grove Strawberry Festival will take place in Village Green Park, 12732 Main St., where Euclid and Main Streets intersect

During the four-day festival, heavy traffic is anticipated in the immediate area. Motorists are asked to plan accordingly to avoid delays.

Main Street, north of Acacia Parkway, will be closed from Thursday, May 26 through Tuesday morning, May 31.

The following streets will be closed only on Saturday, May 28, from 6:30 a.m. to 1 p.m., for the annual Strawberry Stomp 5K Walk/Run and the Strawberry Festival Parade: Acacia Parkway, from Grove Street to Civic Center Drive; 9th Street, between Jerry Lane and Orangewood Avenue; Chapman Avenue, between West and Nelson Streets; and Euclid Street, between Orangewood Avenue and Garden Grove Boulevard.

No vehicles will be allowed to drive or park on the closed streets until the 5K and parade have ended. Any vehicles found on the street after 4 a.m. on Saturday, May 28, will be towed and impounded. Affected streets will be posted with "NO PARKING" signs and residents will be notified in advance.

Orange County Transit Authority bus routes will be affected by road closures.

Stanford Avenue and residential streets near Lampson Avenue and Euclid Street will be open to residents only. Identification will be required for vehicles traveling on those streets during festival hours. Garden Grove police officers will be in the immediate

area to provide directions for residents entering or leaving the area.

Suggested alternate routes during the 5K and parade hours are Katella Avenue or Garden Grove Boulevard for east and west traffic, and Brookhurst or West streets for north and south traffic

On Saturday, May 28, the Strawberry Stomp 5K will begin at 8 a.m. on Main Street and travel north on Euclid Street, heading east on Chapman Avenue to 9th Street, before traveling south back onto Euclid Street. The 5K will finish on Main Street at 9:30 a.m.

Following the 5K, at 10 a.m., the parade will begin on Chapman Avenue, from 9th to Euclid streets, then continue south towards Village Green Park where it concludes at Acacia Parkway.



POLICE DEPARTMENT LAUNCHES TASK FORCE FOR HOMELESS

The Garden Grove Police Department introduces a specially-trained team of five patrol officers, responsible for serving the homeless community and those affected with mental health disorders. The Special Resources Team (SRT) will focus on providing resources to help reduce the number of homeless and the police responses involving the homeless and mentally ill.

According to the Garden Grove Police Department, calls involving the homeless increased by more than 40% in 2015 over the year prior. While the Department has made focused outreach efforts to assist the homeless, Garden Grove Police Chief Todd Elgin believes part of the solution relies on police relationships and understanding of the homeless community.

"Establishing a genuine rapport with this community builds mutual trust.

Without that, we can't be effective," says Chief Elgin. He adds, "The creation of this program is in response to a community and public safety need to address this situation, in this instance, by working together to find a solution."

In addition to the patrol officers, the SRT will also include a full-time clinician from the Orange County Mental Health agency. Understanding that many homeless suffer from mental illness, the Police Department has maintained a long-time relationship with the agency.

The program was designed by Officer Brian Hatfield. His idea of an SRT for the Garden Grove Police Department came after he suffered a serious off-duty injury from a traffic collision more than a year ago. While he was recovering from his injuries, he participated in volunteer work through his church, serving the homeless as a civilian in plain clothes. He also has family members who have suffered from mental illness and homelessness.

While the team officially kicks off this month, Officer Hatfield and other SRT members have been conducting homeless outreach over the last six months, including two, large-scaled efforts to relocate occupants living in dangerous flood control channels.

The police department has also partnered with the Garden Grove Community Foundation to accept monetary donations to assist the local homeless and mentally ill. Monies collected will be used to provide motel vouchers, transportation, food certificates, and other items for individuals or families with immediate needs. In terms of the Orange County hotel market, the overall county lodging market has seen a fast recovery from when the economy began to falter in the latter part of 2007. As the hotel market continued to recover, growth in demand, as measured by occupied room nights, outpaced the increase in supply, and average daily rate has enjoyed above the general level of economic growth since 2011. However, our current forecast indicates that occupancy levels likely peaked in 2015, as the market absorbs substantial new supply along with continued demand growth in the coming years. CBRE Hotels, Americas Research compiles an economics-based hotel forecasting model that projects supply, demand, occupancy, average daily room rates (ADR), and revenue per available room (RevPAR) for the U.S. lodging industry. Hotel Horizons® reports are published on a quarterly basis for 60 markets and six national chain-scales. The following provides an excerpt from the soon to be released June August 2016 edition Orange County Hotel Horizons® report.

By year-end 2016, Orange County hotels are forecast to see a RevPAR increase of 5.2 percent. This is the result of an estimated decrease in occupancy of 0.6 percent and a 5.8 percent gain in ADR. The 5.8 percent boost in Orange County RevPAR is better than the national projected preliminary estimate of less than a 4.5 percent increase. Leading the way in 2016 RevPAR growth is the lower-priced segment of Orange County. The properties in this category are forecast to achieve a 6.1 percent gain in ADR and see a 0.3 percent increase in occupancy, resulting in a 6.4 percent RevPAR increase. Upper-priced hotels are projected to experience an ADR growth rate of 4.6 percent, along with a 1.6 percent decrease in occupancy, resulting in a 4.6 percent RevPAR increase. Looking towards 2017, Orange County RevPAR is expected to grow 5.2 percent. This is equal to the rate of growth in 2016. Prospects for RevPAR growth in the lower-priced segment (positive 5.1 percent) are better than in the upper-priced segment (positive 4.5 percent). The following table presents our 2016 and 2017 forecast, as well as actual 2015 performance for comparison purposes.

As part of the OC Bus 360° initiative to improve bus service and better serve community needs, the Orange County Transportation Authority (OCTA) provides travel options such as vanpools that offer viable transit alternatives.

A vanpool is a group of five to 15 people who regularly travel to a workplace, school, or other destination in a shared van. Vanpools offer direct, express-like service that provides many benefits, including saving time and money and helping to reduce traffic and pollution. Participants lease a van through one of our approved vanpool providers and share the costs of the lease, fuel, tolls, and parking. Through federal grant funding, OCTA provides a \$400 contribution per month per van which covers approximately 30 to 50 percent of the monthly lease cost.

Since 2007, OCTA has been helping individuals and companies form vanpools. We now have approximately 500 vans with 1.3 million annual passenger trips. A fact sheet with additional information is enclosed.



- * unpleasant odor of marijuana, including the smell wafting through the building's ventilation system;
- * their staff and clients are very uncomfortable by the presence of the dispensaries' customers; and
- * the watering system of marijuana growers in a business suite have broken and flooded adjoining suites.

In addition, BURGLARIES are now being committed at the dispensaries and more recently, we had a "TAKE OVER" ROBBERY with guns occur at one of them, which is of grave concu

If you suspect an illegal medical marijuana dispensary, or grower, may have moved into your complex, we strongly encourage you to notify us right away, but please note that you can c

The City Council is considering regulating and taxing the dispensaries in our City; however, whatever revenue that may be collected will not reflect their true income and will not be of ar anticipate will continue, and possibly worsen, if the ban is lifted.

There is only a very short window of time to make known your feelings regarding this issue. This will not be decided by a ballot vote by citizens. The decision on whether to repeal the opinions regarding how you feel the dispensaries may, or may not, impact your businesses and our community-at-large. Please note that you do not have to be an actual resident of this your businesses. Children and adults are welcome and you don't have to necessarily speak - you can express your solidarity and concern regarding these serious public safety issues!

Drone Fight Heats Up

The drone industry is still out to pre-empt local ordinances via pending state legislation. The industry continues to uniformly oppose <u>SB 868</u> (Jackson), a League-supported measure and the only bill regulating drones that expressly protects local ordinances. SB 868 brings California into conformity with the existing few meaningful federal regulations governing recreational drones. California's roads are in dire condition and voters expect their lawmakers to adequately fund this vital infrastructure. In fact, California roads consistently rank as the worst in the nation and cost drivers more than \$760 in repair costs annually. According to a March 2016 Public Policy Institute of California survey, 68 percent of likely voters think spending more money on the maintenance of California's roads, highways and bridges is important for future equality of life and economic vitality for California.

"The Legislature and Governor Brown have no doubt heard the same complaints as I have. It's time to get something done this year," said Mayor Michael.

Reaching an agreement has proven to be very difficult, with all parties raising valid concerns and policies. The Republicans are right that reforms are needed. The Democrats are right that new revenues are needed. Democrats and Republicans must come together and compromise.

In addition to Mayor Michael, other speakers included:

Thursday's rally was held almost a year after the Governor called the Legislature into a special session on transportation. Despite good faith efforts from the Governor and several lawmakers, legislative progress has stalled and California is no closer to a solution. The people of California and everyone that relies on the roads pay the price for legislative inaction. Cities should continue to express their support for quick action on a transportation proposal to their legislators.

The bill contains other provisions enhancing public safety, including:

- Prohibits flights within 500 feet of any critical infrastructure so identified by the Governor's Office of Emergency Services (OES) without the permission of the owner/operator of the infrastructure;
- Prohibits flights within 1,000 feet of a heliport without appropriate permission;
- Prohibits flights within any other area in which OES determines that unrestricted use of remotely piloted aircraft presents an imminent danger to public health and safety;
- Restricts flights over state parks, and any lands managed by the Department of Fish and Wildlife, and within 500 feet of the State Capitol; and
- Prohibits drone operations constituting recklessness, nuisance, or trespass.

While the League and the California Police Chiefs Association successfully defeated an attempt to force state pre-emption on cities in <u>AB 2320</u> (Calderon and Low), drone industry representatives continue to walk the halls of the Capitol, pushing for pre-emption of local ordinances.

This same scenario is playing out in Washington D.C. where the industry is aggressively lobbying for complete federal pre-emption of state laws regulating unmanned aerial systems in the FAA reauthorization bill that will set new regulations for recreational drones. This is noteworthy and troubling because in previous years the industry has successfully fought to block meaningful federal regulations on drones, such as a requirement for mandatory unique identifiers on their products as they leave the factory, or an easily enforceable registration requirement.

<u>A March 16 joint letter</u> issued by the National League of Cities and the U.S. Conference of Mayors to the Senate Committee on Commerce, Science and Transportation rejects the concept of pre-emption in any federal law or regulation pertaining to recreational drones.

Cities that have enacted or are thinking of enacting regulations regarding drones should be alert to the threat this situation poses to their local regulatory authority. A well-financed and well-represented industry is working hard in Washington, D.C. and Sacramento to pre-empt your ordinances and render them meaningless. The irony is that currently, the strongest regulations of recreational drones are not at the state or federal level — they are regulations that have been enacted by cities.

Cities concerned about pre-emption should actively support SB 868, since local ordinances could well be struck down by state legislation this year. Cities that have enacted drone ordinances have the most to lose: Los Angeles, San Francisco, Berkeley, and Poway, to name a few.

Next Steps

Cities are urged to send in SB 868 support letters to the Senate Appropriations Committee, calling out the fact that the bill contains express protection for local ordinances. A sample letter is available at www.cacities.org/billsearch by plugging SB 868 into the search function.

Home to 2,900 residents in the Napa Valley, Yountville decided to expand its recycled water program in response to the challenge of using water in an environmentally sustainable way while supporting the needs of the local agriculture and economy.

An 18-hole golf course located 5 miles southeast of town became Yountville's first recycled water customer. Later converted to vineyards and continues, the land continues to use the recycled water to irrigate. As the popular wine region expanded, two additional wineries started using recycled water. A nine-hole golf course was built on the property adjacent to the Yountville Wastewater Treatment Facility. With this new development, approximately 45-50 percent of the entire amount of wastewater treated at the facility was being utilized between three vineyards and the new golf course for irrigation purposes.

The complex regulatory environment also posed a challenge to Yountville's water efforts. In 2005 the town negotiated with the San Francisco Bay Regional Water Quality Control Board to renew the National Pollutant Discharge Elimination System Permit for the Wastewater Treatment Facility. This would require the town to install expensive equipment in the Napa River that would be difficult and invasive to native species to construct and maintain. Instead, it was later agreed that in lieu of this proposal, the town would expand its already successful Recycled Water Program. This solution would set the stage for a new way of thinking about water and how to use it in a way that made sound fiscal and environmental sense. This process made it possible to save water in the underground aquafers for domestic future use.

An unusually dry winter in early 2009 precluded Yountville from discharging its treated wastewater to the Napa River because there was not adequate dilution due to the lack of flow in the river. This became an opportunity to increase public-private partnerships and allowed Yountville to negotiate a short term agreement with a vineyard in close proximity to the existing recycled distribution pipeline. The relationship more than doubled the existing volume of storage previously available. Yountville was now able to recycle 87 percent of wastewater due to the fact that the ponds on the new property were completely empty and it was an extremely dry winter.

The solution to providing a sustainable use of recycled water involved partnerships that promoted community engagement, applications of new technology and improved services. Yountville sought advice in how best to remedy and avoid the constraints within the Wastewater Treatment Facility and to allow for the production of Title 22 Unrestricted Level Recycled Water, which has specific standards for recycled water. The scope of the project included the demolition of existing equipment/facilities that were no longer in service, construction of a new larger Chlorine Contact Chamber, Effluent Holding Pond Bypass Structure (allowing treated recycled water to be pumped directly to customers without having to first pass through the storage pond), and the installation of new coagulant storage and pumping facilities to increase solids capture and filter upgrades.

The first phase of the Title 22 construction project enabled customers to utilize the upgraded level of treated recycled water for expanded purposes such as indoor plumbing of toilets and other

non-potable uses and increased fire protection (fire sprinklers). Additionally, this higher level of treated recycled water could now be used for what is known as heat protection during unusually hot periods. Recycled water could now be distributed through overhead sprinklers and could come in contact with the edible portion of the fruit. The Title 22 Upgrade Project was completed in 2010 and now meets several of the requirements set forth by the Regional Water Quality Control Board.

The first phase's success led to phase two, the Recycled Water Expansion Project. Funded through the State Revolving Fund, Yountville worked with consultants to design the elements of the expansion. This included the installation of approximately 4,500 linear feet of 8 inch purple PVC pipe to connect a fifth vineyard customer to the recycled water distribution system, Supervisory Control And Data Acquisition functionality to allow remote operation and monitoring of the entire recycled water distribution system and several portions of the Wastewater Reclamation Facility, new larger recycled water pumps, and new filter media installation and other minor treatment plant modifications.

In 2011, the amount of wastewater used for irrigation purposes was approximately 55 percent. This number has increased by nearly 10 percent each year to allow the town of Yountville to beneficially reuse 83 percent of its wastewater in 2014. With the addition of a fifth vineyard customer, Yountville will be able to recycle 100 percent of the wastewater generated by the town during periods of extreme drought. From an environmental perspective, the numbers speak for themselves — using recycled water for irrigation reduces the need for potable water.

Yountville continues strong public outreach both at the local and regional level to help other agencies learn from the success of the recycled water program.

Tech Grants for Cities - Deadline July 15

Cities can apply for funds to support tech projects or equipment purchase through the <u>CRT</u> <u>Settlement Fund</u>. As a result of a computer industry lawsuit settled by the California Attorney General, about \$2.27 million in one-time funds will be awarded to both public and nonprofit agencies, with grants ranging from around \$30,000 to \$86,000, and one to two years in duration. Grant process will be administered by Harry M. Snyder, consumer attorney, Cy Pres Funds, with final grant approvals by the California Department of Justice.

Projects that increase access to computer or visual technology will be considered. In brief, the <u>proposal</u> allows developers to get their projects approved by city staff in an expedited timeframe based on whatever general plan and "objective" zoning criteria are in effect, and even authorizes staff to approve zoning changes, zoning variances and conditional use permits without public review.

The League voiced significant concerns over these proposals at separate hearings held last Wednesday by both the Assembly and <u>Senate Budget Subcommittees #4</u>, and conveyed that removing opportunities for public input undermined transparency and public trust in the actions of local government, and could inspire residents to pursue local ballot measures in response. Labor and environmental groups testified in opposition to the removal of environmental review, and housing advocates questioned the minimal levels of affordability proposed for these developments.

Purported Savings May Be Pennywise

According to the Administration's information, the potential savings for shutting out public review appears minimal. Despite a lengthy description of the alleged problems created by community input, the May Revise (page 49) calculates a savings of only 5 percent in project costs. Such a low number actually supports a counter argument that the concern may be overblown.

Moreover, excluding the public from decisions that affect them undermines the principles of the Brown Act, which states in its preamble: "The people of this State do not yield their sovereignty to the agencies which serve them. The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created. (Sec. 54950 Gov. Code)

Changes caused by design review were assigned 7 percent of project costs, yet having good design (as opposed to taking short cuts on quality) has long been maintained by affordable housing developers as the key to community acceptance of higher density and affordable housing projects. Myths and Facts About Affordable & High Density Housing, co-authored by the state Department of Housing and Community Development states: "Architectural standards and adequate maintenance also strongly influence property values, particularly as they apply to affordable rental properties. Properly maintained affordable housing developments, designed and built with sensitivity to the architectural and aesthetic standards desired by the community, may even increase property values."

League's Preliminary Analysis Available

On Friday afternoon, the League sent city officials an analysis of the proposals on Friday, May 20.

Next Steps

Several legislators raised concerns about the policy implications of this proposal while it was being reviewed in the Budget subcommittees last week. While it was unveiled as part of the budget, it has major policy implications deserving of careful Legislative consideration. City officials should contact their legislators and urge that this proposal not be fast-tracked with the budget, but given the careful analysis and consideration it deserves.

About Stonehaven Apartments

Stonehaven Apartments is limited to occupancy by qualifying students at the University of California, Riverside. The project consists of eight two-story buildings, includes 200 units (up to 600 beds), and was originally developed in 1999. Stonehaven Student Housing, Inc., a 501(c)(3) nonprofit corporation (Stonehaven), is an affiliate of EAH Inc., a nonprofit housing development corporation located in San Rafael, California. Established in 1968, EAH Inc., EAH develops low-income housing, manages over 100 properties in California and Hawaii.

CSCDA partnered with Deutsche Bank which purchased the \$19,570,000 in tax-exempt bonds for Stonehaven. The bonds will be used to refinance CSCDA's previously issued 2002 Bonds, allowing Stonehaven to reduce its bond debt service and interest cost.

Background

Despite vast gains for women in recent decades, significant gender inequality persists across the country. By focusing on gender equality, local governments can ensure that women and girls are fairly treated, represented in their cities, and that their communities thrive. For example, the wage gap extends across professions and hurts the entire economy. From construction workers to doctors, women make only 78 percent of their male counterparts' salary. For African-American and Latina women, the pay gap is even greater: the average African American woman earns only 64 cents and the average Latina only 55 cents compared to white men. It is estimated that improving gender parity will add millions to local economies and add \$12 trillion to the global economy.

ITN also announced the launch of its national Network City Program as another support for local jurisdictions, with San Francisco as its first chapter. The Network City Program will support the implementation of recommendations in the *Mayor's Guide* and the needs of particular cities through a constellation of network cities that employ cross-sector collaboration.

The guide emerged from a roundtable event sponsored by ITN, in partnership with the San Francisco Department on the Status of Women, on the eve of last year's annual U.S. Conference of Mayors meeting. The roundtable engaged mayors, women leaders, and experts across a variety of sectors to highlight successful models and innovations in 11 issue areas affecting women and girls. These included economic security and wage gap equity, ending violence against women, STEM education, and many others.

ITN seeks to fuel this innovation where it matters most in women's lives — at the local level — to drive equality forward with easy, practical access to these pockets of success.
