

This is the fourth year that the Garden Grove Community Foundation staged the "Voice of Garden Grove." It is a five-week competition, beginning with four weeks of preliminary rounds. See leak at school? Give Water Wise Hotline a call

Garden Grove Unified launches a service to help the district reach mandated cuts.

The Garden Grove Unified School District wants your help to stop its leaks.

The district launched a Water Wise Telephone Hotline that people should call or text if they see leaks, broken sprinkler heads, ruptured water lines and excessive runoff at any of its 72 schools. Calls of texts to 657-263-5353 will go to the district's maintenance crews, who will make the repairs.

The hotline is part of an overall conservation program to reach a state-mandated 25 percent cut in water use across its nearly 1,000 acres of property by 2016. Other strategies are creating stormwater-capture programs at local high schools, creating droughttolerant landscaping and installing technologically advanced sprinklers to help reduce the watering of athletic and recreational fields by 33 percent.

"Having a dedicated

number to call or text will allow our maintenance crews to respond more quickly and make necessary repairs," Jeff Rosell, the district's director of maintenance, operations and transportation, said in a statement. "There is a huge opportunity to save water."

The district recently received a \$1.99 million grant from the Drought Response Outreach Program for Schools, known as DROPS.


Brookhurst St. to get a completely new look

A multimillion-dollar construction project set to start soon could cause big traffic delays until Thanksgiving.

Drivers may want to look for alternate routes to avoid Brookhurst Street for the next few months as the major thoroughfare in Garden Grove is set to undergo a \$2.6 million renovation.

The construction will occur in two phases, first from Trask Avenue to Garden Grove Boulevard and then from Hazard to Westminster avenues. The first




This part of Brookhurst Street locking south from Westminster Avenue will undergo a massive reconstruction project.

phase will begin by the end of the month, Public Works Director Bill Murray said.

"Brookhurst gets much traffic," Murray said. "It's horrible. We have to repair everything,"

The Brookhurst construction is a "full-depth reclamation," according to a city staff report.

It will, essentially, be a new street, Murray said.

"This proposed street reconstruction project," the staff report says, "will significantly improve ride, safety and appearance of this arterial street and reduce maintenance."

After tearing up the street, workers will lay a foundation of recycled materials and concrete, topped by an overlay of asphalt.

The project also calls for repaved sidewalks, curbs, gutters and wheelchair-accessible ramps, along with the installation of a video detection system and new signs.

Construction is expected to wrap up by Thanksgiving, Murray said.

Though it may slow traffic and hurt some businesses along Brookhurst, the work is needed, he said.

HAWK pedestrian signal

The Brookhurst construction project also calls for the installation of a new pedestrian signal on Harbor Boulevard and Twintree Lane, which is blocks from several public schools and is where a lot of children cross the street.

The signal is called a high-intensity-activated crosswalk, or HAWK.

The signal faces both sides of the street and has three lights arranged as a reverse pyramid – with two red lights on top of one yellow.

The signal will remain blank until a pedestrian hits the walk button. The yellow light will flash and then become solid for several seconds to warn drivers to stop.

The dual red lights will go on and the pedestrians will see the traditional walk symbol allowing them to cross. Then the two lights will alternate and the walkers will get a stop sign with a countdown display. Drivers must treat the alternating lights as a stop sign, meaning they can continue once it is safe.

The HAWK system leads to a "statistically significant reduction in pedestrian crashes," according to a 2009 study by the Federal Highway Administration.

A step into Casa de Soto takes you back decades there's the brown Naugahvde booths, checkered tablecloths and murals painted on the walls. There's also the staff - some have worked there 35 years who have watched patrons win the playoffs, graduate high school and get married.

"It's been humbling." manager **Luis de Soto** said. "Hearing all the stories ... they appreciate we kept going." Luis is the son of Carol and founder Tony de Soto. Tony died in 1998.

Chloe Black, 15, has been going to the restaurant as long as she can remember.

"They have like the best Mexican food ever - except mv grandmother's cooking," she said, noting she'll miss the mild salsa and the albondigas soup.

- C is for classes, so kids learn to swim properly.



AFFORDABLE HOUSING UNITS GETTING REMODEL

Two affordable-housing apartment complexes near Newhope Street in Garden Grove will soon undergo a \$7 million remodel thanks to bond money from the California Municipal Finance Authority.

The complexes, with 41 total units at 11681, 11682,

11701, 11702 and 11762 Stuart Drive, will include a computer lab, a community space with a kitchen and media area, a barbecue pit and a laundry room. Interior upgrades will include central air, a dishwasher and vinyl flooring for each unit.

Families whose annual

income falls at or below 60 percent of the median income of the surrounding area will be eligible to rent there. Garden Grove's median income is \$59,648, according to the U.S. Census Bureau's 2013 American Community Survey.

Police given grant for DUI enforcement

The Garden Grove Police Department is getting \$259,000 from California this fiscal year to beef-up driving under the influence enforcement.

The grant comes from the state's Office of Traffic Safety and will allow Garden Grove to afford the costs of checkpoints to stop people from driving under the influence of drugs or alcohol.

Certain police officers will also receive

training in how to check people for sobriety.

In 2014, there were 48 crashes in Garden Grove where alcohol was involved, leading to 68 injuries and one death, police say.

Without the money from the Office of Traffic Safety, Traffic officer Royce Wimmer said enforcement would be "greatly affected."

Mayor spoke of House run

In recording, Garden Grove's Nguyen also blasted fellow councilmen.

GARDEN GROVE • During an early morning conversation at his home in June, Mayor Bao Nguyen asked the president of the Garden Grove Police Association about his chances in a congressional

race, used a pejorative term toward a fellow councilman and discussed several other issues.

The discussion was recorded with a microphone on Sgt. Mike Viscomi's lapel, which department policy requires of on-duty officers. Nguyen said he thought the chat was private.

Garden Grove released the 25-minute recording on Wednesday after the City Council agreed a day earlier that the public should hear it. That decision came after members of the public requested a copy. It's unclear how anyone found out about the recording.

In a statement released before Tuesday's council meeting, Nguyen said, "The people elected me to be open and honest, and I have always kept that promise."

Nguyen called the Police Department's non-emergency hotline about 9:30 p.m. June 18 to report a public disturbance on Garden Grove Boulevard near his home, Chief Todd Elgin said.

Viscomi called the mayor, saying he didn't find anyone. Later on, Nguyen called the sergeant and invited him to the house.

"The officer did not know what he was responding to," Elgin said of the mayor's later call.

At 1:26 a.m. June 19, Viscomi started the recorder as he pulled up to the mayor's house, the police chief said, because he thought the invitation was related to Nguyen's earlier disturbance call.

"He was completely following procedure," Elgin said.

Viscomi could not be reached for comment.

Early in the discussion, Nguyen asked Viscomi if he wanted to shut down the patrol car and come inside. Viscomi said it was against department policy.

The police and city are bargaining a new labor contract. When asked if he called the union president to discuss those negotiations, Nguyen said, "absolutely not."

The chat turned to several other topics, some political and some familial.

"I want to talk to you about replacing Loretta Sanchez," Nguyen said in the recording, referring to the Democratic congresswoman who is running for U.S. Senate.

The police union president responded, "I know you could get the votes, if you're ready."

After a brief exchange, Nguyen said, "I'm going national, man."

The police union did not support Nguyen when he ran against incumbent Bruce Broadwater in the 2014 mayoral race. Nguyen said on Wednesday that he didn't bring up a potential congressional campaign to Viscomi as a way to gauge the union's interest in endorsing him.

"I ask everybody," the mayor said. "I don't even know if the union endorses for congressional races. I just want people to be genuine with me."

The conversation between Nguyen and Viscomi also underscored the apparent tension between the mayor and Councilman

Phat Bui. The council infighting began in February, when Nguyen refused to

sign a letter

asking the city of Riverside to rescind a sister-city relationship with Can Tho, Vietnam.

Nguyen, who was a child when his family fled to America, said it was inappropriate to tell another city what to do. Supporters of Bui, an older and hard-line first-generation Vietnamese American who endorsed the letter to Riverside, led an unsuccessful re-

call effort against the newly elected mayor.

Since then, the two have openly fought and cut each other off during heated council debates.

"Phat Bui is a (expletive), man," Nguyen said. "And you know what? I'll tell you straight: Steve Jones is echoing that bull ... too," he added, referring to another fellow councilman.

Bui and Jones didn't return calls for comment. Nguyen said he's not worried how the recording will affect the council's ability to collaborate.

"If everyone is focused on the real issues," Nguyen said, "we'll be able to get things done."

Nguyen said that just by their department being out at the National Night Out shows that they care

"We are here for more than just responding to emergency calls,

Children and adults alike had the opportunity to pet the police horse, "Spirit," and were told that the horses are trained to tolerate stimulus such as balloons, pop-up tents, gunfire, fireworks, and other things they wouldn't normally experience.

Spirit is privately owned by Sgt. Jim Holder.

"A horse is a flight animal; it's OK if they startle, but we don't want them running away, which is their normal response," he said. "We work the Strawberry Festival and other events, such as the recent U.S. Open of Surfing at Huntington Beach, but we don't do regular patrol, just special events such as the Dodgers' games and festivals in resort areas where there is high traffic.

Holder explained to children that horses can live to be 25 years old and that Spirit is 12 years old. I got him when he was a year old

and that's when I began training him to be a police horse," Holder

Darrell Blackman, whose wife is the president of the Garden Grove Neighborhood Association, was on hand cooking free hot dogs for those in attendance; the hot dogs were all donated by the 7-11 on Nelson Street in Garden Grove.

"I think this is good," said Tran. "It's our first time, we just stopped by when we were leaving s lesson; we didn't know about it before then.



"My mother was born in Garden Grove in 1924; I was born here in 1954 and my grandson was born here," said Marla Beihl. We are a generational family living close to each other and







repairs," said Jeff Rosell, district director of maintenance, operations and transportation. "There is a huge opportunity to save water at our 72 sites covering nearly 1,000 acres. With the community's help we can conserve water and save money."

The telephone hotline is part of an ambitious conservation strategy to reduce districtwide water consumption by 25 percent by 2016, which includes decreasing the watering of landscaping and fields by 33 percent. To support this initiative, the district is replacing select decorative lawns with drought-tolerant landscaping, applying for grants to install "smart" sprinklers to control watering of athletic and play fields, and implementing new measures to protect sprinkler heads and irrigation lines from damage. Also, all district high school pools will be immediately covered after use to limit evaporation and curb heating costs.

bond are helping reduce water use through the replacement of old water mains, backflows, drinking fountains, and sinks, and by installing ultra-low flush toilets throughout district schools.

The district's water conservation program will be enhanced by stormwater capture projects at Bolsa Grande, Los Amigos, and Santiago high schools combined with education and outreach opportunities for students, teachers, and community members.



Governor signs local rep's voting bill

State Sen. Janet Nguyen is proud to announce that her bill. SB 366, was signed into law last week by Gov. Jerry Brown. The law will expand the pool of qualified and certified translators who can translate ballot and voting materials. SB 366 is Sen. Nguyen's first law as a state senator.

"As we celebrate the 50th anniversary of the Voting Rights Act. I am proud that SB366 has been signed into law as it will make it easier for residents to practice their most fundamental rights at the voting booth," said Nguyen, who represents Westminster, Garden Grove and other cities.

Currently, elections officials were only allowed to use translators from a local Superior Court

or translators who were certified by a single association of colleges and universities. Through the passing of SB 366, translators certified by other accrediting agencies will be added to the list of qualified translators. This in turn, will provide election officials with quality, cost-effective translator services that will also save taxpaver dollars.

"Given the language diversity of our voting population, it is important to have the flexibility and options necessary to provide translated elections documents to our residents. I am pleased that the State Legislature and Governor Brown have supported this much-needed legislation," said Nguven.

SB 366 was supported by the California Association of Clerks and Election Officials and will go into effect January 2016.

Police: man dies at hands of his brother





Recording of mayor will be released

GARDEN GROVE • An audio recording of a late-night conversation between Mayor Bao Nguyen and an on-duty police officer in front of the mayor's home in mid-June will be released today.

City council members Phat Bui, Steve Jones and Chris Phan unanimously agreed to release the recording during a closeddoor meeting Tuesday evening. Nguyen recused himself, and Councilman Kris Beard was absent because he is on a family vacation.

"We want to be transparent," Bui said. "I have no idea what's on the tape beside the summary briefing."

Residents filed a public records request for the recording by the officer's wireless microphone, which he is required to wear when on duty.

It is not yet clear what is on the tape. It appears that Nguyen did not know the conversation was being recorded because, according to the mayor, he used curse words.

"On this recording of a private conversation I used some salty language that I shouldn't have," Nguyen said. "But we have important matters to address in our city, and I will not be distracted from the job I was elected to do."

City Clerk Kathy Bailor said the tape will be released today.

Audio of mayor talking to officer may be released

Resident: Leader should show the transparency he affirmed in campaign.

GARDEN GROVE • An audio recording of a late-night conversation between Mayor Bao Nguyen and a Garden Grove police officer outside the mayor's house could get released if two City Council members decide to do so during a closed-door meeting tonight.

The discussion comes after several Garden Grove residents submitted public-records requests for the recording.

It is unknown what Nguyen and the on-duty officer discussed when they met in mid-June, but the two may have talked "about a number of things," ac-

cording to Councilman Phat Bui, who has been briefed on the recording. The city and its

police association are undergoing contract negotiations.

Nguyen declined to comment Monday evening.

Officers must wear wireless microphones at all times and record "all citizen contacts, whether dispatched, self-initiated, or citizen initiated," according to department policy.

The mayor, who was elected in November 2014 after making transparency his primary campaign issue, will recuse himself from the vote, and Councilman Kris Beard said he will not be at the meeting because he is on a family vacation.

That means that only two

of the three councilmen likely to be present - Bui, Steve Jones and Chris Phan - have to vote to release it, said City Attorney Omar Sandoval.

"We want to be transparent," Bui said. "If the public wants it, we should make it available."

Tony Flores, a longtime Garden Grove activist and one of those who submitted a request for the video, said that even if there is no real issue with the conversation between Nguyen and the officer, it is a problem that the recording hasn't been released, considering the mayor's campaign promises.

"We are talking about a mayor who ran on a platform of transparency," Flores said. "This is what he's supposed to be about."

City leader lauded for efforts on Fire Authority board

Councilman David Shawver has served for 20 years consecutively

Since the founding of the Orange County Fire Authority in 1995, Stanton City Councilman David Shawver has served continuously for 20 years; he is the only board member to do so.

In presenting Shawyer with a 20-year plaque, OCFA Board Chair Al Murray likened Shawver to baseball player Cal Ripken Jr., who played 21 seasons for the Baltimore Orioles, setting a record for the most consecutive games played.

"And your consecutive years of service-streak are still going strong," said Murray, as he praised Shawver for his "Keen insight and depth of institutional knowledge, which are critical assets to how we function. Your ability to come up with great, often out-of-the box ideas, and your quick wit and wonderful sense of humor have set a standard to which we all aspire.

Shawver said he started in the late 1980s as a representative of the Orange County Fire Department, which in 1994 formed the Joint Powers Authority (JPA) with other cities and became the OCFA.

"I had an interest and so transitioned from the JPA to the OCFA," said Shawver. "I have always had an interest in making sure the City of Stanton and its residents had the best protective service available. and as of today, the OCFA is recognized throughout the country as one of the top fire services in the nation."

Shawver said he remembers his first OCFA meeting back in 1994, that was held in the old fire station (still standing) in the City of Orange on Water Street.

We met at card tables with folding chairs — and what I've noticed



in my 20 years, is the problems we had in 1990 are the same as we currently have to solve, such as ambulance service, response times, firemen training and governance of OCFA. Nothing has really changed over the years — it's cyclical — history repeats itself," he said.

Shawver said the accomplishments he is most proud of include that he is the only member left of the original board and that he has continually served as the representative for Stanton.

"I'm pleased to have helped with the selection of the new Fire Chief Jeff Bowman and pleased to have helped form the first-ever human resource committee working with the rank and file of the OCFA.

What has he accomplished. working with OCFA? He said he's most proud of helping create a Regional Fire Authority to serve the entire unincorporated area of Orange County, plus the 25 cities, and bringing it into national prominence.

Shawver continues to serve as chairman of the Human Resources Committee and on the OCFA executive board.

"I appreciate that our City Council has always allowed me to stav and serve on the board, representing the citizens of Stanton, and boy, those 20 years have gone by quickly," he said.

GG, WM rep promotes healthy and active lifestyles





Workshop Scheduled Aug. 26, Comments due Aug. 28

The California Department of Water Resources (DWR) has opened its public comment period for the recently released draft version of its Proposition 1 Economically Distressed Area (EDA) Instructions and Mapping Tool. For more, see Page 2.

While California has been focused on putting together a transportation funding package that will address the backlog of projects, Congress has continued to negotiate the federal transportation authorization.

At the end of June, the Senate Environment and Public Works Committee unanimously voted to send a six-year bill to the Senate Floor dubbed the Developing a Reliable and Innovative Vision for the Economy (DRIVE) Act. However, the Senate finance committees were able to identify only enough funding for three years. After several weeks of negotiations, the Senate adopted HR 22, a six-year authorization with about three years' worth of offsets to address the dwindling balance in the Highway Trust Fund.

Unfortunately, the Senate failed to pass its version in time for the House to consider it before their summer break. Instead, both houses agreed to the short-term, three-month extension of the current authorization bill, MAP-21. The authorization is now set to expire on October 29.

Congress will face another daunting task in October. Treasury Secretary Jacob Lew sent a letter to Congress this week indicating that the extraordinary measures the U.S. Government is taking to avoid a default on federal debt will suffice only through October or mid-November.

The House returns from its summer recess on Sept. 8. Once the House passes its version of a long-term authorization, the bills will go to conference committee so that differences can be hammered out.

Other GIS layers relevant to the Integrated Regional Water Management (IRWM) Grant Program are also shown on the map. All GIS layers can be toggled on and off while varying each layer's transparency. Ontario to Regain Control of its Airport Agreement Ends Years of Dispute between Los Angeles and Ontario

It could take upwards of a year to complete the process, but the <u>announcement</u> on Thursday that Los Angeles has agreed to relinquish control of the Ontario International Airport made headlines throughout California. Ontario Mayor Pro Tem Alan D. Wapner, who also serves as the President of the Ontario International Airport Authority, and Los Angeles Mayor Eric Garcetti made the announcement together during a news conference at the Ontario Airport. The Ontario International Airport Authority will take control once the Federal Aviation Administration, the two cities' respective city councils, and cities' airport agencies formally approve the transfer. *For more, see Page 2.*

Thursday's announcement was celebrated as a victory for local regional control. Los Angeles officially became the airport's owner in 1985 after managing it since 1967. The city of Ontario sued Los Angeles in a trial that was set to begin Aug. 17 over allegations that Los Angeles had not effectively managed the airport. Local governments in the region supported Ontario's efforts to regain control of the airport. According to *The Los Angeles Times*, this transfer is supported by 130 cities, counties, regional planning groups, locally elected officials, aviation-groups as well as the counties of Los Angeles, Riverside and San Bernardino.

Voters approved Prop. 57 in 2004 to refinance accumulated budgetary debt. Bond payments on this debt total \$14.2 billion principal, \$4.8 billion in interest and administrative costs of \$153 million. The 2014 Budget Act provided \$1.6 billion from the Budget Stabilization Account so that the recovery bonds could be paid off in the summer of 2015, one year ahead of the previously scheduled payoff date. Because the debt is being retired earlier, finance officials estimate that the state will save approximately \$60 million in debt service costs associated with a longer payoff period.

It is important to note that this relates to the salestax for property tax swap that is the mechanism to fund the state's operating debt scheme under Proposition 57. This is not the Vehicle License Fee (VLF)-Property Tax swap and has no effect on that policy. Property Tax in lieu of VLF payments are not affected and, in fact, are constitutionally protected.

Coalition Supporting Transportation Investments Convenes Press Briefing to Outline Proposal

Seeking \$6 Billion Annually to Support State and Local Streets, Roads and Highways

Members of the Capitol Press Corps gathered this morning at the League of California Cities[®] for a briefing from Fix Our Roads, a broad coalition representing local government, transportation, business and labor that supports increased funding for transportation. The coalition formed in July with Gov. Jerry Brown's calling of the special session on transportation in conjunction with the budget deal he reached in late June with legislators. The coalition seeks \$6 billion annually, split equally between the state and local governments, over the next decade.

California's network of roads and highways are deteriorating rapidly. In fact, California has the second highest share of roads in "poor condition" nationally and 58 percent of state roads need rehabilitation or pavement maintenance. Our state is also home to four of the five cities ranked with the worst road conditions in the nation. California local streets and roads face a \$78 billion shortfall in deferred maintenance, \$7.8 billion annually. CalTrans faces a \$59 billion backlog in deferred maintenance and \$5.7 billion annual shortfall in the State Highway Operation and Protection Program.

<u>The Fix Our Roads Coalition</u> believes that a legislative solution should be reached during the special session that results in a robust and meaningful dent in California's transportation funding shortfall. This critical issue must be addressed immediately with the state's road system continuing to deteriorate as inadequate funding to deal with deficiencies creates safety hazards, costs motorists time and money, and leaves California stuck in gridlock. In the coming weeks, the coalition will engage in meetings in the Capitol and district offices, legislative hearings, and roundtable events throughout California.

During Monday's briefing, reporters had an opportunity to hear details on the coalition proposal and talk with coalition members including, League Executive Director Chris McKenzie, California State Association of Counties Executive Director Matt Cate and California Alliance for Jobs Executive Consultant Jim Earp.

McKenzie stressed that California's roadway system, freeways, major urban thoroughfares, residential streets and rural roads are all connected. "This matter is urgent and we're glad the Governor called a special session. This is an issue that impacts every Californian in some way. Drivers in California want something done about our road."

Cate spoke about the work that has been done. "There are already ideas on the table from both sides of the aisle and the Governor has his own ideas. To our coalition what makes sense are small increases in several taxes and fees that represent a user-pay system that is fair and accountable."

Earp remarked, "Our plan is prudent. We're talking about fixing the existing system and just playing catch up before building anything new."
