OBJECTIVE

To provide information regarding new Division of Drinking Water (DDW) requirement to notify local governing body and consumers of PFOA and PFOS constituents detected in Garden Grove's production wells.

DISCUSSION

PFOA and PFOS are fluorinated organic chemicals that are part of a larger group of chemicals referred to as per- and poly-fluoroalkyl substances (PFASs). PFOS and PFOA have been extensively produced and studied in the United States. These manmade substances have been synthesized for water and lipid resistance. They have been used extensively in consumer products such as carpets, clothing, fabrics for furniture, paper packaging for food, and other materials (e.g., cookware) designed to be waterproof, stain-resistant or non-stick.

Since these chemicals have been used in an array of consumer products, scientists have found PFOA and PFOS in the blood of nearly all people tested. According to the Center for Disease Control (CDC), blood levels of both PFOS and PFOA have steadily decreased in U.S. residents since 1999-2000.

Epidemiological studies conducted by the EPA indicate exposure to these compounds over certain levels may result in adverse health effects. As a result, DDW has set a notification level (NL) at 13 part per trillion for PFOS and 14 parts per trillion for PFOA. In addition, DDW strongly suggests taking wells out of service for wells that cannot meet a response level (RL) of 70 parts per trillion total for PFOS + PFOA. These are precautionary health-based advisory levels established by DDW while further research and analysis are conducted by state to determine the necessity of setting an enforceable drinking water maximum contaminant level(MCL).

Based on prior sample results, 12 Orange County Groundwater Producers/Public Water System, including Garden Grove, were issued orders to sample on a quarterly basis.

Garden Grove Water Services is one of the nine(9) ground water producers with the wells above the NL for PFOS, PFOA or both. There are no wells that exceed the RL. A second set of samples will be taken on June, 5 2019 for purposes of confirmation. Once the results for this set has been received, the Water Division is required by DDW to notify our local governing body (City Council) within 30 days. Customer notice is also recommended, which can be done through the City's annual Consumer Confidence Report.

Confirmation results are expected by the end of June, 2019.

OBJECTIVE

To provide City Council with updated information regarding community events that have been approved for sponsorship during fiscal year 2018-2019.

BACKGROUND/DISCUSSION

At the June 25, 2019 City Council Meeting, City Council requested a list of annual non-profit organizations that request their community events to be sponsored and/or fees to be waived. City sponsorship for these events is restricted to in-kind services, such as City staff support, use of City owned equipment, showmobile stage, permit fees and use of the City's rental facilities.

In accordance with City Council direction at a meeting held on Tuesday, May 8, 2018, staff has collaborated with these non-profit organizations and encouraged them to share in 5% of the costs of city support for their community events in order to offset a portion of the City's costs. Also included in the list below, is the dollar amount of 5% each groups has contributed.

Annual Sponsored Community Events

1. OC Autism Christmas event at Atlantis Play Center (2018)

The total amount waived was \$920. This cost was for the use of the park facility for an 8-hour period. **There was a motion by City Council to not have them pay the 5% and waive the entire fee. The fee would have been \$46.**

2. West Garden Grove Youth Baseball Parade (2019)

The total amount waived was \$2,660. This cost was to provide Police staff (approx. \$2,300), waiving the fee of \$250 for rental of the showmobile stage, and cost for staff to set up the showmobile stage (approx. \$250). **The organization paid \$140, as part of their 5%.**

3. Strawberry Stomp 5K (2019)

The total amount waived was \$11,642. This cost is to provide Police, Fire and Public Works staff required to support this event. **The association paid \$1,000 towards city cost, which is more than 5% requested.**

4. Garden Grove Community Foundation one-day use of the Willowick Golf Course (2019)

There is no cost for sponsoring the use of the golf course as it is part of the agreement with the Lessee that allows one free use of the facility per calendar year.

5. Cub Scout Pushcart Derby (2019)

The total amount waived was \$4,845. This cost is to provide Police staff support for the one day event. **The organization paid \$255, as part of their 5%.**

6. Mid-Autumn Children's Festival at Atlantis Play Center (2019)

The total amount waived was \$498.75. This cost was for the exclusive use of the park facility for an 8-hour period. **The organization paid \$26.25, as part of their 5%**

Annual Fee Waiver Request

1. Garden Grove Farmers Market on Main Street (2019)

No request has been brought forward.

One-Time Request for Sponsorship

1. Western University of Health Sciences, OC Council (2018)

Total amount waived was \$337 for the use of the Senior Center facility for an 8-hour period to provide an event for seniors.

The total amount sponsored for this fiscal year 2018-2019 is \$20,902.75.

AIR NATIONAL GUARD FIGHTER JET FLYOVER ADDS HIGH-POWERED SALUTE AS JFTB CELEBRATES AMERICA'S 243RD BIRTHDAY

LOS ALAMITOS, Calif. -- A flight of California Air National Guard F-15C fighter aircraft from the 144th Fighter Wing based in Fresno, Calif. will perform a flyover of Los Alamitos Army Airfield on Thursday evening, July 4, in conjunction with Joint Forces Training Base's annual "Fireworks Spectacular" public event celebrating Independence Day.

The flyover is expected to take place at approximately 6:15 p.m. following their flyover of Dodger Stadium during pre-game ceremonies for the Los Angeles Dodgers – San Diego Padres game.

"On behalf of Maj. Gen. David Baldwin, the Adjutant General of the California National Guard, our City of Los Alamitos and Seal Beach community partners, and the Citizen Soldiers who work and train here at Joint Forces Training Base, we look forward to welcoming our friends and neighbors to join us in celebrating America's birthday," said JFTB Installation Commander Col. Nick Ducich. "We are privileged to enjoy outstanding support from the communities we serve, and this special day provides us with a great opportunity to say thank you for their patriotism and tremendous military outreach."

The event will also include a concert by the 40th Infantry Division Band and static displays of equipment utilized by the Citizen Soldiers of the California Army National Guard including a UH-60 Black Hawk helicopter, military vehicles and an exhibit of historical artifacts presented by the California State Guard's Museum Command.

JFTB's main gate on Lexington Drive will open to the public at 4 p.m., with fireworks scheduled for 9 p.m. Admission and parking is free, but everyone over the age of 16 must present photo identification at the gate and all children must be accompanied by parents/guardian. Only service dogs will be permitted.

Biking onto the installation is allowed but helmets are required. Alcohol, fireworks, BBQs and motor homes are prohibited.

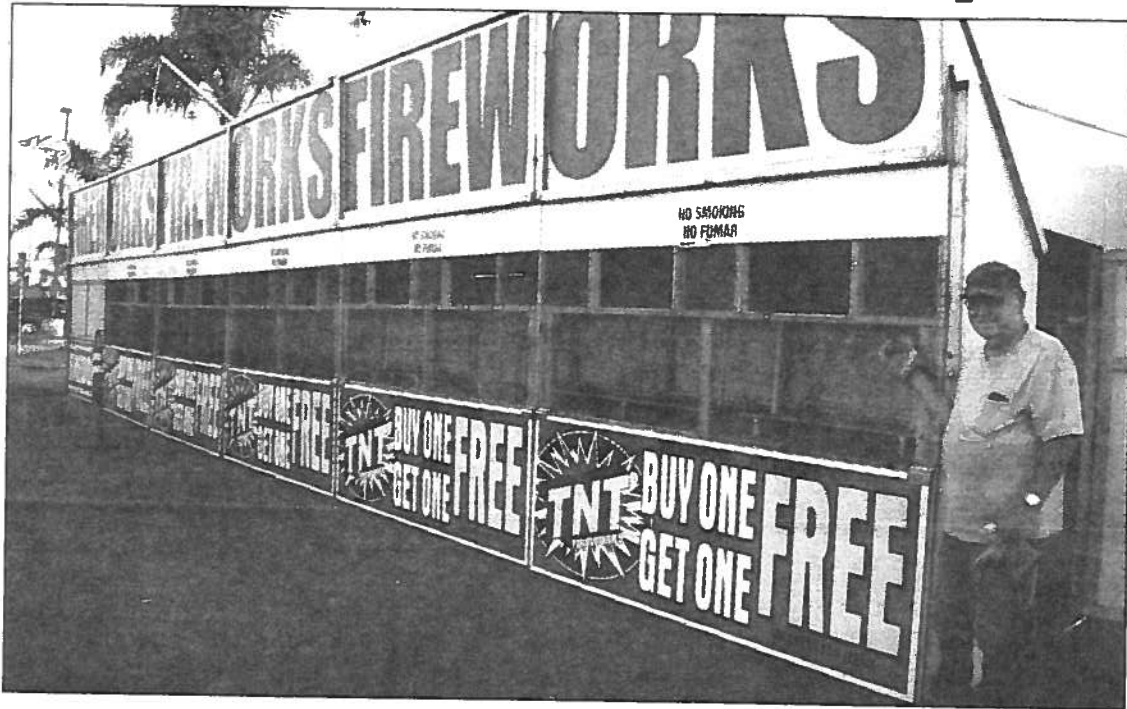

City Attorney's Summary

City Council Resolution No. 4547-74 submitted to the voters for approval an ad valorem tax for paramedic services in an amount not to exceed 10¢ per \$100 of assessed valuation. The measure was approved by the voters in June 1974. State law requires that the City Council set the annual levy of the tax by ordinance or resolution. This Ordinance sets the levy of the tax at 8¢ per \$100 of assessed valuation for FY 2019-2020.

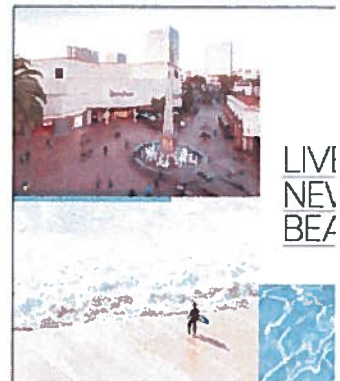

The time together was an exciting opportunity to learn from each other and to share ideas about what's working in our cities. I hope the experience was valuable and productive for those of you who were able to attend.

I'm writing to you today with an important update on a League strategic priority involving resources and tools to address housing affordability and homelessness.

Last Thursday, Gov. Newsom signed the FY 2019-2020 state budget that included the most significant housing and homelessness-related investments in modern history with more than \$2 billion in one-time funds to help with planning grants, housing-related infrastructure, homelessness services, mixed-income loan programs and an expansion of the state's Low Income Housing Tax Credit Program. Also, on Thursday, the housing-related budget trailer bill was introduced. The Legislature will begin voting on it as early as this afternoon.

The League appreciates the work of the Governor and Legislative leadership to allocate the largest amount of planning, affordable housing and homeless funding in memory. We also appreciate the many city officials from every corner of the state who joined the League in advocating for these additional resources for our communities.

Recognizing the important role cities play in planning and setting the table for housing production, the planning grants will be very helpful. Still, we all know that planning alone does not build affordable housing units. That's why the \$2 billion in additional resources to build units, address infrastructure challenges and assist the homeless are so critical.

We also appreciate the incentive-based approach in the trailer bill that rewards cities when they take steps to encourage additional housing development, particularly high-density housing and housing near transit.

While potential court-imposed sanctions in the bill for local agencies with non-compliant housing element plans are substantial, we appreciate the aspects of the language in the bill that incorporate appropriate due process safeguards and opportunities to resolve legitimate disagreements between local and state agencies on matters of interpretation. We also appreciate the recognition that some communities may be facing financial and other hardships that may hinder compliance. Over 90 percent of cities already have state-approved housing elements plans, and the number has been increasing.

As with any 143-page bill, there is certainly more to be understood about its many provisions in the coming days, and it will take time to fully realize the benefits of these new resources to our communities and those we serve. The League looks forward to working with the Legislature and Administration to help inform cities on the details and deadlines associated with accessing the many new funding opportunities to help plan for and build housing in our communities.

Governor Signs the Budget, Legislature Continues Work on Trailer Bills

Cannabis Trailer Bill Approved; Housing and Homeless Trailer Bills in Print

July 1, 2019

Gov. Gavin Newsom formally adopted the budget, [AB 74](#), on June 27.

Following its adoption, a series of trailer bills have been making their way to the floors of both the Senate and the Assembly. Among the trailer bill items approved last week was the cannabis trailer bill, [AB 97](#), with key provisions related to provisional licensing, local equity grants, and penalties against unlicensed cannabis activity. The League released a detailed analysis of the [first round of trailer bills](#) two weeks ago.

Upon adjournment last Thursday, the Legislature released its housing and homelessness trailer bill, [AB 101/SB 102](#). Language regarding the Governor's utility wildfire liability bill, [AB 1054](#), was also released late last Thursday and will require a two-thirds vote. Although budget trailer bills are not confined to a specific timeline for approval, both of these bills are expected to be voted on before the end of next week. The League is currently analyzing the contents of those measures and will be releasing a follow-up story this week.

Below is a list of trailer bills and their respective analyses that have been approved by the Legislature and are pending a signature by the Governor. Detailed descriptions of the key provisions of interest to cities, where applicable, are outlined below.

[SB 75 \(Enrolled\)](#) – Education Finance: Education Omnibus Budget Trailer Bill

This is the K-12 and Early Education Omnibus trailer bill which contains various statutory changes necessary to implement the 2019–20 budget. This bill appropriates funding for education programs totaling approximately \$1.2 billion. Specifically, the bill:

- Provides \$300 million in one-time General Fund for the Full-Day Kindergarten Facilities Grant program.
- Changes the eligibility requirements for the state preschool program to provide priority access to full-day state preschool program slots to income eligible families with a need for full-day care with remaining full-day slots available for other income eligible families.

- Requires the Secretary of the Health and Human Services, in concurrence with the executive director of the State Board of Education to contract for research to create a Master Plan to ensure comprehensive and affordable child care and universal preschool.
- Establishes the Early Learning and Care Infrastructure Grant Program to provide grants to child care and early education providers to build new facilities, or retrofit, renovate, or expand existing facilities. This bill would appropriate \$142.7 million to be expended over five years in equal amounts per year in addition to \$102.3 in federal funds appropriated through the budget act for this program.
- Establishes the Early Learning and Care Workforce Development Grant Program to expand the number of qualified early learning and care professionals and increase education credentials for existing professionals. Appropriates \$195 million for this program to be expended over five years in equal amounts per year.

SB 78 (Enrolled) – Health

This trailer bill is an omnibus health trailer bill which makes statutory revisions affecting health programs. In brief, the bill:

- Creates the Minimum Essential Coverage Individual Mandate to require an individual who is a California resident to ensure that the individual, and any spouse or dependent of the individual, is enrolled in and maintains minimum essential health care coverage for each month beginning on and after Jan. 1, 2020.
 - Requires the California Health Benefit Exchange (Covered California) to grant exemptions from the mandate for reason of hardship or religious conscience, and would require Covered California to establish a process for determining eligibility for an exemption.
 - Imposes the Individual Shared Responsibility Penalty for the failure to maintain minimum essential coverage, as determined and collected by the Franchise Tax Board, in collaboration with Covered California.
- Establishes a program within the Health Benefit Exchange (Covered California) to provide state subsidies to assist individuals with incomes under 600 percent of the federal poverty level (FPL) afford health insurance.
- Implements several grant programs to local health jurisdictions, with no less than 50 percent of the funding being provided to community-based organizations. These grants will be related to the prevention of sexually transmitted diseases, human immunodeficiency virus (HIV), and hepatitis C.

- Creates a Value-Based Payments program to provide supplemental incentive payments to Medi-Cal providers to meet metrics related to behavioral health integration, chronic disease management, prenatal and postpartum care, and early childhood preventive services.
- Extends the availability of \$50 million in funding for the Health Home Program (HHP) until July 1, 2024.
 - The HHP is designed to serve eligible Medi-Cal beneficiaries with complex medical needs and chronic conditions who may benefit from a full range of physical health, behavioral health, and community-based long-term services and supports needed by eligible beneficiaries.

SB 79 (Enrolled) – Mental Health

This trailer bill makes necessary changes to implement the 2019–20 budget related to mental health programs administered by the Mental Health Services Oversight and Accountability Commission. It allows a county to encumber Mental Health Services Act funds for innovative programs that provide local assistance for designated mental health programs so long as they are encumbered under the terms of the program plans or until three years after the date of approval. The bill also eliminates the prohibition on the use of state funds for early psychosis and mood disorder detection and intervention programs.

AB 97 (Enrolled) – Cannabis

This trailer bill contains statutory provisions related to cannabis which:

- Extends the California Environmental Quality Act (CEQA) exemption through July 1, 2021:
 - Currently, CEQA does not apply to the adoption of an ordinance, rule, or regulation by a local jurisdiction that requires review and approval of permits, licenses, or other authorizations to engage in commercial cannabis activity.
- Addresses provisional licenses:
 - Extends the repeal date for provisional licensing to Jan. 1, 2022.
 - Modifies the applicant requirements to provide evidence of compliance with local ordinances. These modifications include:
 - Requiring a provisional license to be valid for no more than 12 months from the date it was issued.

- Requiring a licensing authority to include the outstanding items needed to qualify for an annual license if renewing a provisional license.
- Authorizing a licensing authority to renew provisional licenses annually until the licensing authority issues or denies the provisional licensee's annual license.
- Authorizing a licensing authority to revoke or suspend a provisional license if the licensing authority determines the licensee failed to actively and diligently pursue requirements for an annual license.
- Requiring a licensing authority to cancel a provisional license upon issuance of an annual license, denial of an annual license, abandonment of an application for licensure, or withdrawal of an application for licensure.
- Addresses the Cannabis Appeals Panel statute:
 - The Medicinal and Adult Use Cannabis Regulation and Safety Act establishes the Cannabis Control Appeals Panel that reviews decisions of licensing authorities appealed by any person aggrieved by those decisions.
 - Clarifies that the Cannabis Control Appeals Panel is established in the Business, Consumer Services, and Housing Agency.
- Enhances equity grants:
 - Authorizes the Governor's Office of Business and Economic Development to administer on behalf of the Bureau of Cannabis Control (BCC) provisions related to the review and granting of funding for cannabis equity programs.
 - Eligible local jurisdictions may submit an application to BCC for a grant to assist with the development of an equity program or to assist local equity applicants and local equity licensees through that local jurisdiction's equity program.
 - Local Equity Programs are programs adopted or operated by a local jurisdiction that focus on the inclusion and support of individuals and communities in California's cannabis industry who are linked to populations or neighborhoods that were negatively or disproportionately impacted by cannabis criminalization.
- Authorizes penalties against unlicensed activity:
 - Authorizes a licensing authority to issue a citation to a licensee or unlicensed person for any violations of existing law or regulations related to the Control, Regulate and Tax Adult Use of Marijuana Act of 2016.
 - Authorizes licensing authorities to assess administrative fines not to exceed \$5,000 per violation for licensees and \$30,000 per violation for an unlicensed person, each day.

- Requires proceeds from citations to be used for the recovery of investigation and enforcement costs and to be deposited into the Cannabis Control Fund.
- Requires the State Department of Public Health to establish a certification program for manufactured cannabis products no later than July 1, 2021. Previously, the Department of Food and Agriculture was the sole determiner of designation and certification for cannabis.

SB 104 (Enrolled) – Health

This trailer bill makes statutory changes affecting health programs. In brief, it expands full-scope Medi-Cal eligibility for adults age 19 to 25 regardless of immigration status beginning July 1, 2019. The bill will also establish the Healthy California for All Commission effective July 1, 2019 which will serve as an independent body to develop a plan for advancing the progress towards achieving a health care delivery system including, but not limited to, a single payer financing system for all Californians.

SB 106 (Enrolled) – Budget Act of 2019

This is the Budget Bill Jr. which makes minor technical changes to the 2019 budget. This bill will increase appropriations in the 2019–20 fiscal year by \$285 million. Provisions of most interest to cities include:

- Appropriation of \$428.6 million (an increase of \$133.4 million) General Fund to Covered California to provide premium assistance subsidies to individuals with household income at or below 600 percent of the federal poverty level (FPL).
- Appropriation of \$5 million General Fund to California Health and Human Services for the Healthy California for All Commission.
- Allocation of \$5 million in one-time General Fund to California Health and Human Services to conduct research to inform the development of a Master Plan for Early Learning and Care to support comprehensive and affordable child care and universal preschool in California.

Next Steps

The bill language regarding housing and homelessness was released Thursday afternoon. A more comprehensive summary of that language will be available soon.

Moving Forward After SCOTUS Ruling in Census Case

July 1, 2019

On June 27, in a 5-4 ruling, the Supreme Court rejected President Trump's Administration's decision to include a citizenship question in the 2020 Census, citing a pretextual violation of the Administrative Procedures Act.

The court's decision in *Commerce v. New York*, to remand the decision to add an untested citizenship question to the 2020 Census questioned back to the agency, held that Commerce Secretary Wilbur Ross came into office determined to add a citizenship question, later justifying the decision as enforcing the Voter Rights Act (VRA). This decision sends this case back to a federal court in New York for further consideration, presumably giving the Trump Administration time to offer different justification for the need to add the citizenship question.

The ruling reaffirms that block-level citizenship data is unnecessary to enforce the VRA. There are fears that such a question would reduce the likelihood of minority and low-income populations participating in the 2020 Census. The Public Policy Institute of California released a report in March stating that California faced a great risk of an undercount, given the state's diverse hard-to-count population. Adding a question about the status of citizenship may make immigrants and others more reluctant to share information with the government, likely causing the state to lose a congressional seat and miss out on significant future federal funding. California received an estimated \$115 billion in federal funding tied to the state's population count in fiscal year 2016 alone.

Shortly after the ruling, California Gov. Gavin Newsom released a statement emphasizing the "unprecedented investment of \$187 million in outreach efforts to ensure an accurate and fair count" in the state.

The National League of Cities also released the following statement: "Today's ruling reaffirmed that block level citizenship data is unnecessary for Voting Rights Act enforcement and threw the fate of this question in doubt. The full truth is that citizenship question is untested, untimely and unnecessary across the board. While we celebrate today's tentative victory, local leaders know there is still more work to be done to ensure our communities are

fully counted next year,” said Irma Esparza Diggs, director of Federal Advocacy.

What’s Next?

As the Trump Administration considers alternative justification for a citizenship question and further arguments being heard in federal court, the fate of the citizenship question remains uncertain, and distribution and printing of the Census forms may be delayed.

Department of Finance Releases FY 2019-20 Suspended State Mandates

July 1, 2019

Most city officials do not relish complying with state mandates, but what they may not know is that the Legislature and Governor agree to "suspend" numerous mandates in the annual budget process.

This means locals do not have to comply with them.

This is done so that the state does not have to reimburse local agencies for the costs. The Department of Finance (DOF) has released its annual letter notifying the League that 56 mandates have been suspended for FY 2018-19.

The letter from DOF notes that during this period, local agencies are not required to implement any of these previously mandated programs nor will local agencies be reimbursed for associated costs. The requirement stems from Proposition 1A of 2004 (sponsored by the League), which included this "pay or suspend" requirement. Prior to Prop. 1A, the state simply would defer payment and was years in arrears.

This list that includes topics such as airport land use commission plans, Brown Act, Local Coastal Plans and other items may provide a city with opportunities to revise past practices and perhaps incur cost savings. Additional information on any of these specific mandates can be found on the State Mandates Commission website.
