



Nguyen's expanding 15 minutes' of fame

Even Democrats praise her after ouster from Senate floor

The leader of the state Senate called it Janet Nguyen's "15 minutes of fame." But getting forcibly removed from the Senate called the state of the s

ate floor on Feb. 23 has made the Fountain Valley Republican something of a folk hero in the Vietnamese American community.

That means the aftereffects of the incident could well extend to 2018

and help Nguyen's reelection in a Senate district that includes much of Little Saigon. Democrats have a 9 percentage point advantage in the district and have been eying it as vulnerable for takeover.

You may recall that Nguyen was delivering a speech criticizing the late Democratic lawmaker Tom Hayden for his opposition to the Vietnam War,

two days after Hayden was memorialized in the Senate. State Sen. Ricardo Lara, D-Bell Gardens, was in charge of the proceedings and, believing she was out of order, asked Nguyen to take a seat.

When she continued, Lara had the sergeants at arms escort her out of the chambers.

Republicans were predictably outraged – but plenty of Democrats also winced at the optics of free speech apparently being shut down. Some Democrats offered Nguyen their wholehearted support in the conflict.

"I commend Senator Janet Nguyen for standing up with great courage to express her deeply-held views born out of her personal experiences as a refugee fleeing communist Vietnam," Rep. Alan Lowenthal, D-Long Beach, said in an emailed statement. "She spoke to the painful history and hardship that many of our shared constituents in the Vietnamese American community feel. Senator Nguyen's removal from the Senate floor was uncalled for and it was wrong."

Perhaps not coincidentally, Lowenthal's district also includes much of Little Saigon.

Senate President Pro Tem Kevin de Leon promised to review the incident.

Meanwhile, Nguyen held a free-speech rally in Little Saigon on March 4. She held another in Sacramento on March 6 that attracted hundreds from Orange

County, the Bay Area and Sacramento, according to news reports.

De Leon, a Democrat, showed up at the Sacramento event and said that Nguyen had violated procedural rules but vowed such an incident "will never happen again."

"I think she enjoyed her 15 minutes of fame," he said a couple minutes later. "And she doesn't want it to disappear, obviously."

Nguyen is a moderate Republican who has spoken out in support of social services and their importance in helping her refugee family get on their feet in the U.S. She has also steered clear of Donald Trump, casting a write-in vote instead for an undisclosed candidate last year.

Before being elected to the Senate, she served on the Garden Grove City Council and the county Board of Supervisors. Her popularity in Little Saigon helped carry her to a 58 percent to 42 percent victory in getting elected to the Senate over Democratic former Assemblyman Jose Solorio in 2014.

She is the nation's first Vietnamese woman to serve in a state legislature

But Hillary Clinton won Nguyen's district by a whopping 56 percent to 34 percent over Donald Trump. I recently asked county Democratic Party Chairwoman Fran Sdao to list Republicans she was targeting for next year.

"I would say Janet Nguyen but – thank you Democrats," she said, alluding to the attention Nguyen is getting from Lara kicking her out of the chambers.

Anti-Trumpsters

Rep. Darrell Issa, R-Vista, held two town hall meetings Saturday, but anti-Trump activists continue to press their cases for similar events with Orange County's other three Republican Congress members.

The push began shortly after Trump's inauguration with weekly pilgrimages to the members' district offices.

In the case of Rep. Mimi Walters, R-Laguna Beach, activists are now taking their plea to city councils in the district, asking them to join in the call for town halls so they can express their views and asking the cities to offer to host the events.

No such luck at the Mission Viejo council meeting on Feb. 28 and the Rancho Santa Margarita meeting on March 8, according to Register reporter Nathan Percy, who was on hand.

Rancho Santa Margarita Councilman Jerry Holloway told the activists that he was concerned that they wanted "to just take shots at her."

"I would not be in favor of inviting her here for the purpose of answering questions they can't seem to get answered on their own," he said. "I would think it would be almost a setup. ... I don't think that would be appropriate or professional."

But when several activists from Lake Forest made the request of their council, the GOP-majority panel agreed to extend the invitation to Walters and for good measure, to state Sen. John Moorlach and Assemblyman Steven Choi as well.

Among speakers making the request in Lake Forest was Kayla Francis, a member of the California 45th and the Indivisible activist groups.

"I thought this meeting was a huge success," Francis said in an email. "It was my first City Council meeting but it certainly will not be my last. The willingness of the City Council to listen to us and offer real solutions was such a positive experience that I am eager to continue to stay involved in my local community."

Man suffers severe burns from butane lab

He's in stable condition after explosion occurs in backyard gazebo

lucky.

But a local man will walk away from what could have been a fatal disaster.

Garden Grove police officers were dispatched to a scene last week after a 911 hang up call.

Upon arrival, Garden Grove Fire Department personnel were on scene and were rendering medical aid to a 32-year-old man who had severe burns on his face, arms and legs as a result of an explosion.

The victim had been living in a makeshift shed made out of an outdoor gazebo in the rear yard of the home. He was allegedly oper-

He probably doesn't feel ating an illegal honey oil butane lab, which involves a process of extracting concentrated cannabis from marijuana leaves.

This extraction method is highly explosive due to butane being used. During the extraction, the butane ignited, causing a small explosion. The man was admitted into UCI for his burns and is in stable condition.

No structural damage was reported to the home.

No arrests had been made at press time.

Police investigators responded. to the scene and worked with the Fire Department to collect evidence from the explosion.

Is this more than just 15 minutes of fame?

Some say State Sen. Janet Nguyen is a rising star in GOP

State Sen. Janet Nguyen, who represents Garden Grove and Westminster, has transformed into a national figure.

Her name and face appear in newspapers and on websites and TV as community-based as this one and as countrywide as CNN.

There have been chants among state GOP leaders: "Janet Nguyen for governor!"

The Republican and former Garden Grove city councilwoman was silenced on the Senate floor – actually, she was physically removed - while criticizing late California lawmaker Tom Hayden for his opposition to the Vietnam War.

"Tom Hayden chose to work directly with the Communist North Vietnamese Government to oppose the efforts of United States forces in South Vietnam,"

Nguyen said in her speech.

State Sen. Ricardo Lara, a Democrat, had her removed because, he said, she was violating procedural rules and impugning the character of

Hayden, who the legislature had posthumously memorialized two days prior.

Democrats say Nguyen was grandstanding, pandering to her base, thousands of whom are Vietnamese-Americans who were rousted - or had family members rousted - from their homeland by an encroaching, Communist government.

Nguyen, who immigrated from Vietnam after the war, said she was merely offering up "historical perspective" with regard to the Vietnam War and Hayden, a Democrat and activist.

Many of her constituents support her.

Hundreds protested in Westminster on a recent Saturday; hundreds more protested in Sacramento on the following Monday.

California is demanding an apology from Senate President Pro Tem Kevin de Leon. Nguyen's supporters also want her to be given the chance to finish her speech in the state capitol.

"Her free speech was violated," said Garden Grove City Councilman Phat Bui.

Meanwhile, de Leon, a Democrat, has appointed a three-person panel – Senate staffers – to investigate the incident.

He also stated of the flap: "It will never happen again."

Pressed on it, he took a dig at Nguyen: "I think she's enjoyed her 15 minutes of fame."

Read State Sen. Nguyen's controversial speech

Editor's note: Following is the full speech that State Sen. Ianet Nguyen attempted to deliver on the Senate floor. After being physically removed from the chamber for allegedly violating parliamentary rules, she posted the speech on her website. It has not been edited.

Dear Senators and the People: I and the children of the former South Vietnam soldiers will never forget the support of former Senator Tom Hayden for the Communist government of Vietnam and the oppression by the Communist Government of Vietnam for the people of Vietnam.

After 40 years, the efforts by people like him have hurt the people of Vietnam and have worked to stop the Vietnamese refugees from coming to the United States, a free country. We will always continue to fight for freedom and human rights for the people of Vietnam.

Members, I recognize today in memory of the million of Vietnamese and the hundreds of thousands of Vietnamese refugees who died seeking freedom and democracy. I recognize that on Tuesday you had an opportunity to honor Senator Tom Hayden. With all due respect, I would like to offer another historical perspective.

On Tuesday, instead of participating, I chose to step out of the chamber out of respect to his family, his friends and to you. In contrast to your comments on Tuesday, I want to share what Senator Hayden meant to me and to the over 500,000 Vietnamese Americans who call California their home, as well as to the over 1 million Vietnamese Americans across the United States.

As you may be aware, Tom Hayden chose to work directly with the Communist North Vietnamese Government to oppose the efforts of United States forces in South Vietnam.

Mr. Hayden sided with a communist government that enslaved and/or killed millions of Vietnamese, including members of my own family. Mr. Hayden's actions are viewed by many as harmful to democratic values and hateful towards those who sought the very freedoms on which this nation is founded.

Were it not for the efforts of the thousands of men and women who served bravely in the United States military and the South Vietnamese military, as well as the efforts of millions of Vietnamese citizens who resisted the comrepresenting the residents of the the world do not enjoy.

In addition to the sacrifices made during war, the efforts of President Ronald Reagan in the 1980s allowed many Vietnamese like me to seek refuge in the United States.

In contrast to the great many people who fought to defend freedom and democracy, Mr. Hayden supported a Communist agenda and traveled to North Vietnam during the war.

He believed that those who protested the human-rights violations of the Communists were tools of the CIA. It is known that he believed that the war was a conflict between Imperialism, led by the United States and the "free" people of North Vietnam: Former Senator Hayden was profoundly wrong in his support of the Communist.

Members, to this day, the government of Vietnam continues to violate the basic human rights of its citizens. They systematically continue to oppress freedoms of expression, religion and assembly and incarcerate those who speak out for freedom and democracy.

Thank you for allowing me to make my comments. I proudly stand before you as a Vietnamesemunists, I would not be standing American who appreciates the here on this Senate floor humbly freedoms that so many around

So, what constitutes a random thing? For Vu, it's things like buying out a cookie booth or, maybe, raising a duck.

"I started raising ducks. My rooster died, so now I have a duck named Waffles," Vu continued. "I already looked it up. Ducks can't eat the cookies; there's too much sugar."

So, what do you do with 45 boxes of cookies? Vu is an insurance services coordinator at AAA. He plans to bring them to the office to share with his coworkers.

"I also pass them out to random people. I give them to homeless people and anyone I meet." Vu waved goodbye and thanked the Scouts for their work,

"I'm going to look for more Scouts selling outside a grocery store and buy all of their cookies next."

The girls reminded him that another group of scouts were due to arrive later that day to set up the table outside Target and sell their troop's cookies.

Sisters Samantha, 10, and Megan Swett, 8, were still excited after Vu was gone.

"We couldn't believe it," said

Samantha. "He bought half, then came back."

Samantha is an expert cookieseller, having participated in the program for five years. She showed the patches on her vest that she earned last year for selling many cookies.

"This one is for earning the Smart Cookie badge," said Samantha, a Junior Girl Scout. "It's for participating in cookie sales and learning the skills needed to sell cookies."

She also had patches for selling more than 200 boxes, selling online, attending the cookie rally to get pumped up for selling, selling 50 boxes as a goal-getter, a cookie booth badge, Cookie Share for donating cookies to others, and the Inchworm Badge for service in the community. The entire back of her vest was filled with patches.

"The biggest sale we had before today was 12 boxes," said Megan, a Brownie, participating for her second year. "A relative bought them."

Asked about their favorite cookies, Megan was quick, "I like

Orange County News March 15, 2017 2 of 3 Thanks-A-Lots. They are short-bread with chocolate on the bottom." Samantha's favorite is "Caramel deLites. They have caramel, coconut and chocolate."

Their parents, Lisa and Daniel, are active with the troop. Mom helped at the booth, while dad, who works for a forensic software company, is the cookie coordinator for the troop. Both are proud of their daughters and their cookie sales.

So, what happens with the money Troop 629 raises? "We are debating in our troop," said Samantha. "We might go to Camp Sherman, a Girl Scout camp, or maybe, Mammoth for a weekend."

This troop is active, having helped the homeless by preparing toiletry kits. They work to earn patches, sell cookies, and spend time having fun with their Girl Scout friends.

"We have 20,000 girls and 14,000 adults in Girl Scouts of Orange County," said Emma Donahue, marketing manager. "Our coordinator here today is Marti O'Neill. She oversees 66 troops with 850 girls, along with overseeing the Cookie Cupboard in Cypress."

"The first three days, we moved out 1,4000 cases of cookies each day, and restocked those cases each day," said O'Neill. "All work is done by volunteers."

"I like doing this work. It gives me a more community-wide understanding. I get to meet and talk to the troops when they pick up their cookies," said O'Neill.

"We are always looking for volunteers who want to build girls of courage, confidence and character, who make the world a better place," said Donahue.

"If someone has an interest, we can find a place for them," said O'Neill. "We also need people who can help with STEM topics and the creative arts programs. We can always use cookie warehouse volunteers, people to speak at events, people who can give girls career tours of their business, help with the Lego robotics program and the Raspberry Pi coding program."

Rental apartments under construction; more planned

The development at Brookhurst Triangle, designated "Brookhurst Place," is well underway.

The project is at the junction and Brookhurst Street. of Garden Grove Boulevard, Brookhurst Street, and Brookhurst Way.

"It's great to see the first phase of 180 rental apartment units coming to market by this summer," said Garden Grove Mayor Steve Iones. "Phase two will be for sale condominiums and then phase three will add 200,000 square feet of brand-new restaurants and retail opportunities at the intersection where Little Saigon, the Korean Business District, and downtown all come together."

The 180 luxury apartments are on three-acres of the property. When the entire project is completed there will be 670 mixed-use condo/apartments. The last building will contain a retail center, making a total of six buildings on the site, with 272,000 square feet of open space and 65,000 square feet of commercial

The project is the city's largest mixed-use development. encompassing 14 acres of 670-plus market apartments along with commercial and open space.

The area at Brookhurst Street, Garden Grove Boulevard and Brookhurst Way has been sitting as a patch of dirt for more than 20 years. Part of that area was formerly a car dealership that was

home to the first Isuzu vehicles that came into America in 1981 and another car dealership at the corner of Garden Grove Boulevard

The final OK to move ahead on the project came in March of 2015. Before that, the city was waiting for the state to release redevelopment property and money it had taken from cities statewide.

Now, there will be a winding path of more than 1-mile for walking around inside the development area and it has been touted as a place where people can go to live and work.

It's a significant project for the Garden Grove community.

Mayor Jones said the project goes back a long time, back to when he was still serving on the Planning Commission.

"I've seen the project go through many hands, so this is an exciting time. I thank city staff for their support in helping with the development."

The City of Garden Grove will sell the rest of the property for \$18 million once phase two begins.

However, not all of that money goes to Garden Grove. With the dissolution of redevelopment agencies statewide, Orange County gets a sizable amount of that money to distribute to other agencies.

Still, the project will help the city financially.



Vitamin maker Nature's Bounty to lay off 223, close Garden Grove, Santa Fe Springs facilities

Some 223 people will lose their jobs at The Nature's Bounty Co. facilities in Garden Grove and Santa Fe Springs as the company shifts operations elsewhere in the country, including New York, where it will get \$35 million in state tax incentives.

The vitamin and supplement maker said it is moving its centers to other company-owned plants across the country.

According to Newsday, the company plans to create 157 jobs in Suffolk County as it closes factories in California and China and moves the work to New York.

Nature's Bounty will modernize and expand its New York facilities in exchange for up to \$35 million in state aid over the next 10 years, the article stated.

A spokesperson with Nature's Bounty said the facilities were chosen for closure based on "financial analysis, network effectiveness, and geographic location in relation to other parts of the supply chain."

The company also has facilities in Arizona and Nevada.

Nature's Bounty filed notices with California, indicating it will terminate 213 jobs in Garden Grove and 10 at its Santa Fe site, effective May 1.

Employees will be provided with severance pay, benefits and assistance in finding new jobs, the company said.

In Garden Grove the company has a factory and offices at 7366 Orangewood Ave. In Santa Fe it has a warehouse for the Garden Grove operations at 12945 Leffingwell Ave. Both facilities are leased by the company.

Nature's Bounty owner the Carlyle Group is reportedly exploring the sale of the company.

BC Partners and CVC Capital Partners would consider offers for the entire company, Bloomberg reported.

Bain Capital and Xio Group are also weighing bids, and some firms may make offers just for Nature's Bounty's U.K. unit, Holland & Barrett, the February Bloomberg article stated.

The company is expected to sell for as much as \$6 billion.

In February, <u>Irvine-based AutoAlert indicated it would shift its headquarters to Kansas City</u>, also lured by tax incentives – \$9 million in exchange to grow the software company.

The move, the company said, would create more than 200 jobs. Chief Executive Mike Duella, in a statement, has described the Kansas City positions as "high-paying tech jobs."

"After a comprehensive evaluation of major markets, AutoAlert selected Kansas City due to its revitalized and growing downtown area, access to tech talent, and convenient transportation options," the company stated.

AutoAlert in February declined to comment on the move or how many local employees might be impacted. In its statement, the firm said it would keep an office in Irvine, but did not specify how many employees would remain.



Chính vì lá cờ đỏ sao vàng xuất hiện trong cơ sở thương mại của tên Trần Trường hơn 10 năm trước đây tại phố Bolsa đã gây căm phẫn cho người Việt ở khắp nơi, nên suốt 53 ngày đêm chúng tôi đã biểu tình, và cuối cùng đã dẹp được là cờ máu đó. Thành phố Garden Grove là thành phố có đông cư dân gốc Việt, chúng tôi không muốn thấy lá cờ đỏ sao vàng xuất hiện nên chúng tôi để nghị HĐTP ra Nghị quyết cấm treo cờ đỏ sao vàng trong thành phố. Một số nghị viên đã nêu nhiều câu hỏi và được Nghị viên Thu Hà và ông Phát Bùi giải thích. Nghị viên Kris Beard, cho biết, Đơn vị ông hầu hết là người Mỹ trắng, họ không muốn treo bất cứ lá cờ nào ngoại trừ cờ Hoa Kỳ nên ông bỏ phiếu "No". HĐTP Garden Grove đã thông qua Nghị Quyết với 6/7 phiếu, như vậy từ nay Việt cộng không thể treo cờ đỏ sao vàng tại thánh phố này.

Trong buổi họp, nơi hàng ghế tham dự có hai phụ nữ, một trung niên và một thiểu niên lạ mặt, chưa từng thấy hiện diện trong các sinh hoạt cộng đồng. Ông Phát Bùi cho biết, Tổng Lãnh Sự Việt Cộng tại San Franciso đã biết tin HĐTP sẽ ra nghị quyết cấm treo cở của họ nên đã gửi thư phản đối; vì thế một số người cho rằng nhóm người lạ mặt đến tham dự buổi họp có thể là người của phía bên kia. Rất tiếc, Cộng Đồng tham dự quá ít, chỉ có hai ông Nam Hà (QĐ IV) và ông Võ Tấn Kha (Thành viên Hội Đồng Giám Sát Cộng Đồng NVQG Nam Cali,) phóng viên Phan Đại Nam, Thanh Phong...







MATTERS FROM STAFF:

TO APPOINT A COMMISSIONER TO THE OC COLLABORATIVE EMERGENCY SOLUTIONS GRANT FUNDING REVIEW COMMITTEE.

Staff stated that as a part of the annual Action Plan process, Garden Grove staff had worked collaboratively with the cities of Anaheim and Santa Ana, the only three cities in the county that receive Emergency Solutions Funds, and a joint request for proposals had been sent to not-for-profit service providers, who service the homeless community. Staff asked the Commission to appoint one Commissioner to sit on an application review committee to review the funding applications, and along with staff, make recommendations for the use of the Emergency Solutions Funds to

grant to the subrecipients. Staff explained that the selected Commissioner would receive the applications, and a draft of the review form to review, with the actual collaborative date to be February 21st, from 9:00 a.m.-5:00 p.m. at Anaheim City Hall. Last year, Commissioner Pham had been selected and commented that the process was interesting and important, and with assistance by staff, went smoothly. Staff noted that if the appointed Commissioner was not on the new forthcoming Commission, he or she would be designated as a Community Representative.

Commissioner Ramirez asked staff to explain the goal of the process. Staff responded that the grant funding was the Emergency Solutions Grant (ESG) funds directly received from the Department of Housing and Urban Development (HUD); that the funds were designed to address homelessness; that last year, Garden Grove received approximately \$177,000; and, that the collaboration maximizes the funding to avoid duplication while serving the community.

Chair Brietigam asked for volunteers. Vice Chair McIntosh and Commissioner Pham indicated they would like to volunteer.

Vice Chair McIntosh stated that he had a soft spot for the homeless; that he worked with an on-line group called Orange County's Homeless to alleviate the problem and get people in beds and shelters and to provide rehabilitation; and, that he had the passion and time to volunteer.

Commissioner Pham stated that he had the experience from last year and had a passion for working with the homeless; he previously worked with an Orange County health agency as a mental health specialist for outpatient engagement; and, had been in the homes of the homeless.

Chair Brietigam opened the floor to Commissioners.

Commissioner Ramirez asked for the number of applications to be reviewed. Staff replied 'seven', and that the collaborative had asked for one representative from each city along with one staff member and one community or commission member.

It was moved by Chair Brieitigam and seconded by Commissioner Ramirez to appoint Commissioner Pham, due to his experience. The motion carried by a 3-0 vote, with Commissioners Blackmun and Constantino absent, and Commissioner Pham abstaining, as follows:

SB 1 Passes out of Senate Government and Finance Committee

The League continues to support the additional \$2.2 billion that the bill dedicates annually for local streets and roads and the provisions expanding the streamline review for projects in existing right-of-way for all cities. State and local roads have a maintenance backlog of \$130 billion and California motorists are spending more than \$700 annually on car repairs due to pothole-filled roads. This backlog is divided between \$59 billion for state highways and \$73 billion for local streets, roads, and bridges. Without additional funding, this shortfall is projected to grow by \$20 billion in the next decade.

SB 1 now goes to the Senate Appropriations Committee where it will be heard sometime next week. The measure is another step closer to the Legislature meeting Gov. Jerry Brown's <u>April 6</u> deadline to pass comprehensive transportation package.

While several new tools including, Enhanced Infrastructure and Finance Districts (EIFD) and Community Revitalization Investment Authorities (CRIA) have been established, they lack the concentrated financial lift in urban areas offered by the former redevelopment tool. Left unaddressed, this financing gap presents real challenges for the future development of infill urban areas and avoiding continued sprawl onto open lands where it is easier to develop.

Sen. Jerry Hill's (D-San Mateo) SB 711 helps address this need by establishing a creative financing mechanism focused on filling the local funding gaps to maximize opportunities for large-scale transit-oriented development (TOD), affordable housing, and facilities within a disadvantaged community.

The measure creates a six-year pilot project to enable the Strategic Growth Council (SGC) to review and approve projects that the SGC agrees maximize state and local policy objectives, by authorizing the applying city or county to reduce its individual property tax contributions to Educational Revenue Augmentation Funds (ERAF), so the applying agency can invest these funds in the project.

Currently, cities, counties and special districts contribute \$7.5 billion annually to ERAF funds, a mechanism established by the state in the early 1990s to allow the state to reduce its funding to schools. Full discretion in whether to approve projects is provided to the SGC (as an entity representing the state's policy interests) and is capped at \$10 million annually, over six years. SB 711 also requires substantial reporting and oversight.

From a local government perspective, the funding available via this measure is much more than it may appear. Each local government that is awarded an ERAF reduction will be able to receive that reduction on an annual basis for the life of the project. For instance, if a city is approved a \$1 million per year annual reduction, they would receive that reduction for the life of the project financing (for instance, 35 years). In short, a city that is trying to do the right thing gets to keep more of its own property taxes to help fund the project.

SB 711 creates a "win-win" for maximizing state-local development opportunities and climate goals by ensuring that some of financial lift of the former redevelopment tool is restored for projects that advance state priorities.

Led by Pismo Beach City Manager Jim Lewis, who is also president-elect of the League City Managers' Department, coastal cities are working to identify goals for working with the Coastal Commission in the coming years.

New Market Tax Credit - Fostering Investment in Low-Income Neighborhoods

The California Statewide Communities Development Authority (CSCDA) is currently soliciting potential pipeline projects in connection with its 2017 application for New Markets Tax Credits. Through the California Statewide Communities Development Corporation, CSCDA's subsidiary Community Development Entity, CSCDA has successfully received three awards totaling \$143 million in New Markets Tax Credit (NMTC) allocation and has successfully deployed this valuable subsidy into communities in need throughout the state. CSCDA looks forward to continuing to provide a critically important funding gap to quality eligible projects throughout California next year.

The NMTC program, passed by Congress in 2000, encourages investments in low-income communities by providing a tax incentive for community development lenders and the capital markets to invest in communities that historically have had poor access to capital. Eligible project types include community facilities, charter schools, healthcare facilities, manufacturing facilities, operating businesses, and commercial real estate developments located within eligible low-income neighborhoods throughout California. NMTCs will generate up to 20 percent of the capital required for these projects and businesses. Often that is the difference that will make a desirable project feasible.

League-Sponsored Bond Agency Issues \$161.6 Million in Tax-Exempt Bonds for Affordable Housing in Newport Beach

Some of the most significant benefits of League membership for cities since 1988 have flowed from the League's co-sponsorship of the <u>California Statewide Communities Development</u> Authority (CSCDA).

This program provides a variety of public agencies and developers access to low-cost, tax-exempt financing and economic development tools. CSCDA recently issued a total of \$161,620,000 in tax-exempt multi-family affordable housing bonds for Uptown Newport Apartments in Newport Beach.

About Uptown Newport Apartments

Uptown Newport Apartments is the new construction of 455 mixed income housing units by The Picerne Group (TPG). Twenty percent of the rental housing units will be rent restricted for low-income tenants. The income-restricted apartments are comprised of studio, one-bedroom and two-bedroom units.

CSCDA and TPG partnered with Stern Brothers & Co. and Orrick Herrington & Sutcliffe, LLP to provide the \$161,620,000 in tax-exempt and taxable multi-family affordable housing bonds for the project. The financing for the project requires the affordability of units for low-income tenants to be maintained for 55 years.

California City Solutions: Fort Bragg Converts Old Mill Site into Beautiful Coastal Park and Trail

This story is part of an ongoing series featuring Helen Putnam Award entries. The 2016 entries are available on the League's website as a resource for cities in a searchable database called <u>California City Solutions</u>. The Fort Bragg Coastal Restoration & Trail Project was submitted in 2016 for the Planning and Environmental Quality award category.

The Northern California city of Fort Bragg has a population of 7,200 and is located on the beautiful Mendocino coast. It is the largest city on the coast between San Francisco and Eureka, and is more than a three-hour drive from each of those cities. During the 20th century the city's economy was largely based on the timber and fishing industries. At the turn of the century, Fort Bragg was looking for new ways to boost its economy. However, Fort Bragg's Coastal Restoration & Trail Project transformed the coastline of a blighted lumber mill into a recreational park with native plants and a multiuse trail that provides public access along a four-mile stretch of coast that had been fenced off for more than a century.

By the turn of the millennium, Fort Bragg's Noyo Harbor based fishing fleet had declined to just a handful of boats. Local fisheries fell victim to overfishing, overregulation, or overharvesting along spawning streams. Soon after the decline of the fisheries, the Georgia-Pacific lumber mill permanently shuttered its operations in late 2002. Two decades of unsustainable timber harvesting had left the north coast's redwood forests with insufficient timber to support the lumber mill.

Fort Bragg's mill provided good jobs for generations of residents and at its peak employed 1,500 people. Closure of the mill devastated the local economy and marked the end of an era. Not only had the community lost its primary employer, but Fort Bragg's deeply rooted identity as a logging and fishing town was also lost. Fort Bragg was at a crossroads and the city's leaders realized that the mill closure presented an unique opportunity for the community to plan for its future.

The blighted mill site covered 425 acres in the city's center of the city and spanned its entire coastline. For more than a century, Fort Bragg was a coastal town without a waterfront because the mill had blocked public access to the coast.

In 2003, the Coastal Conservancy awarded Fort Bragg an urban waterfront grant to plan for reuse of the Georgia-Pacific mill site. Hundreds of local residents participated in an extensive community visioning process from which two key priorities emerged: provide public access along the coast; and help transition Fort Bragg's local economy from mining based industries to a rebuilding based economy. The community agreed that Fort Bragg's spectacular and remote coastal setting is the key to its future. The planning process generated an Open Space Framework that mapped a conceptual layout for a coastal trail and park system spanning the entire coastline of the mill site.

There were a number of challenges to transforming an old mill into the coastal park. The mill site was purchased and the property was contaminated from a century of industrial use with large areas that were covered with asphalt and compacted gravel. Huge volumes of stormwater ran across the site creating unstable and retreating coastal bluffs and the coastline included significant sensitive resources such as rare plants, bird nesting areas, wetlands, and marine mammal haul outs and Native American cultural sites that would need to be protected and preserved. Millions of dollars were needed to restore the property and construct the coastal trail.

The Fort Bragg Coastal Restoration & Trail project was conceived as a key recreational service that would serve the community and its visitors. The city spent several years negotiating for acquisition of approximately 100 acres stretching along the four-mile coastline on the former mill site. It was clear to the city that development was far off in the future. The mill site faced a complicated environmental remediation process; the market for new development in Fort Bragg is constrained by its remote location; and the entitlement process in California's coastal zone is complex and time consuming.

In 2006, the National Park Service's Rivers, Trails and Conservation Assistance (RTCA) program offered Fort Bragg technical support for a community based design process for the parkland.

RTCA planners led an intensive, invitational; three-day design workshop attended by nearly 70 civic leaders and community stakeholders. The conceptual plan became the basis for the project's environmental review, permitting, and design. Public meetings were held to refine the design. City staff also led hikes on the property to give community members a sneak preview of the coastline that few had ever seen.

The city spent nearly two years consulting with the Sherwood Valley Band of Pomo Indians, a local tribe with deep connections to Fort Bragg's coastline, to honor the tribe's concerns and redesign the project to avoid disturbance of cultural sites. A preserve was established within the park that is accessible only for scientific research and tribal use.

The city imported 25,000 cubic yards of dredge sands from the Noyo Harbor District (which simultaneously solved the district's quandary over disposal of the material). The dredge sands were composted with spent grains from Fort Bragg's North Coast Brewing Company. This formed the basis for restoration of the site. Native seeds were collected locally by Jughandle Farm to ensure diversity of native vegetation on the 23 acres of newly created habitat (formerly asphalt). The project has resulted in a significant expansion of several federal and state listed plant populations.

After years of negotiation, Fort Bragg succeeded in acquiring its coastline for public access. The State Coastal Conservancy awarded the city \$4.2 million for purchase of 37 acres along the coast and Georgia-Pacific agreed to dedicate another 45 acres as part of the deal. The California Department of Toxic Substances Control, which oversees the mill site environmental remediation process, helped expedite the cleanup of the future parkland with the city taking the title to the 82-acre coastal site in 2011.

Construction of the coastal trail and restoration of the bluffs took several years to complete and was funded by over \$7 million in grants from Proposition 84, the State Coastal Conservancy and Caltrans. The northern segment of the Fort Bragg Coastal Restoration & Trail Project was opened to the public in February 2015 and the southern segment was opened in December 2015. The trail is tremendously popular with local residents and visitors. In peak summer months, thousands of people visit Fort Bragg's coastal trail each day. The park has transformed Fort Bragg into a waterfront community.

The year 2015 was the strongest year for tourism in Fort Bragg. People are flocking to the new coastal trail and the influx is helping local businesses. In FY 2015–16, the city experienced higher Transient Occupancy Tax (TOT) receipts than ever before. Year to year, after the trail opened, Fort Bragg's TOT revenues jumped 7 percent. The city, with the support of local lodging establishments, is now planning a ballot measure to increase the TOT rate to generate more revenue for marketing and promotions of Fort Bragg and to support coastal trail maintenance and security.

Fort Bragg has now set its sights on development of the Noyo Center for Marine Science on an 11-acre site adjacent to the new park and the North Coast Brewing Company is planning to triple its production capacity and build a destination brewery on a nearby parcel on the former mill site.

Senator Roth's SB 540 Creates Blueprint for More Housing Construction League-Sponsored Bill Scheduled for First Committee Hearing on March 21

Local elected leaders are acutely aware of the severity of California's housing affordability crisis and their role in fashioning solutions. While numerous factors are contributing to the problem, there is an agreement that more needs to be done to create a path for and streamline new housing construction. Local governments do not build homes. Cities are responsible for planning and land use decisions that allow housing to be built. The League of California Cities[®] is sponsoring Sen. Richard Roth's (D-Riverside) <u>SB 540</u> to create a robust system for planning and streamlining housing approvals and construction that ensures public engagement on the upfront planning process. *For more, see Page 2*.

SB 540 Creates a Blueprint for More Housing Construction

SB 540 provides an enhanced up-front planning process for local governments that reduces delays and uncertainty when proposed projects are consistent with those plans. Ensuring local planning requirements and environmental mitigation measures are identified early would streamline the approval process to facilitate more housing construction.

In brief under SB 540:

- Cities and counties could identify priority housing areas within a community where enhanced planning, necessary environmental reviews and public engagement would occur at the front end.
- By focusing on workforce and affordable housing in areas close to jobs and transit, the additional streamlined process would encourage developers to propose projects that address affordable housing needs and climate protection goals.
- In order to be eligible:
 - o 30 percent of units must be sold or rented to moderate income households;
 - 15 percent must be sold or rented to lower income households;
 - 5 percent must be sold or rented to very low income households; and
 - Funding to support the up-front planning would come from a revolving state loan fund available to local governments. Loans would be repaid when development occurs.

SB 540 Streamlines Housing Approvals while Protecting Public Engagement

Public engagement in the planning process is important and SB 540 helps streamline housing project approvals without compromising local control or the rights of citizens to participate in local land-use decisions. The proposal retains vital opportunities for public engagement and transparency, through the up-front plan development and environmental review.

Housing developments within these planned areas can proceed in an expedited manner. Because the local government has fully conducted the necessary environmental reviews, no project-specific additional environmental reviews would be needed. The environmental review and project streamlining stands for five years to provide the development community with needed certainty.

Under this proposal, a local government has the authority to approve or disapprove the housing development within 90 days of a completed application. Local governments cannot deny a development that satisfies the criteria of the plan. This approach could drastically streamline housing approvals and create a blueprint for more housing construction.

Next Steps

SB 540 has been triple referred to the Senate Committee on Transportation and Housing, Senate Committee on Governance and Finance, and the Senate Environmental Quality Committee. It will have its first hearing on Tuesday, March 21 in the Senate Committee on Transportation and Housing.

The League issued an action alert on March 13 and has posted a sample letter to the League's online <u>Action Center</u> that cities can use to tailor with how SB 540 will affect their community.
