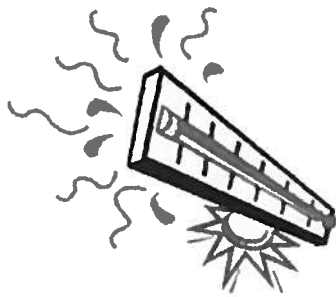

SUBJECT: Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Tier 2 volume for MWDOC, and selected water supply information.

- Fig. 1 OC Water Usage, Monthly by Supply OCWD Groundwater water was the main supply in May.
- Fig. 2 OC Water Usage, Monthly, Comparison to Previous Years Water usage in May 2017 was slightly below average compared to the last 5 years but was higher than in May of 2015 and 2016. We are seeing a slight increase in overall water usage compared to the historical lows of the 2015-16 Fiscal Year. In June 2016, all water conservation became voluntary for MWDOC agencies.
- Fig. 3 Historical OC Water Consumption OC water consumption is projected to be 523,000 AF in FY 2016-17 (*this includes ~15 TAF of agricultural usage and non-retail water agency usage*). This is about 31,000 AF more than FY 2015-16 and is about 48,000 AF less than FY 2014-15. Water usage per person is projected to be slightly higher than in FY 2016-17 for Orange County at 147 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts.

MWDOC "Firm" Water Purchases, 2016 "Firm" water above the Tier 1 limit will be charged at the higher Tier 2 rate. Tier 2 purchases are zero in 2017.

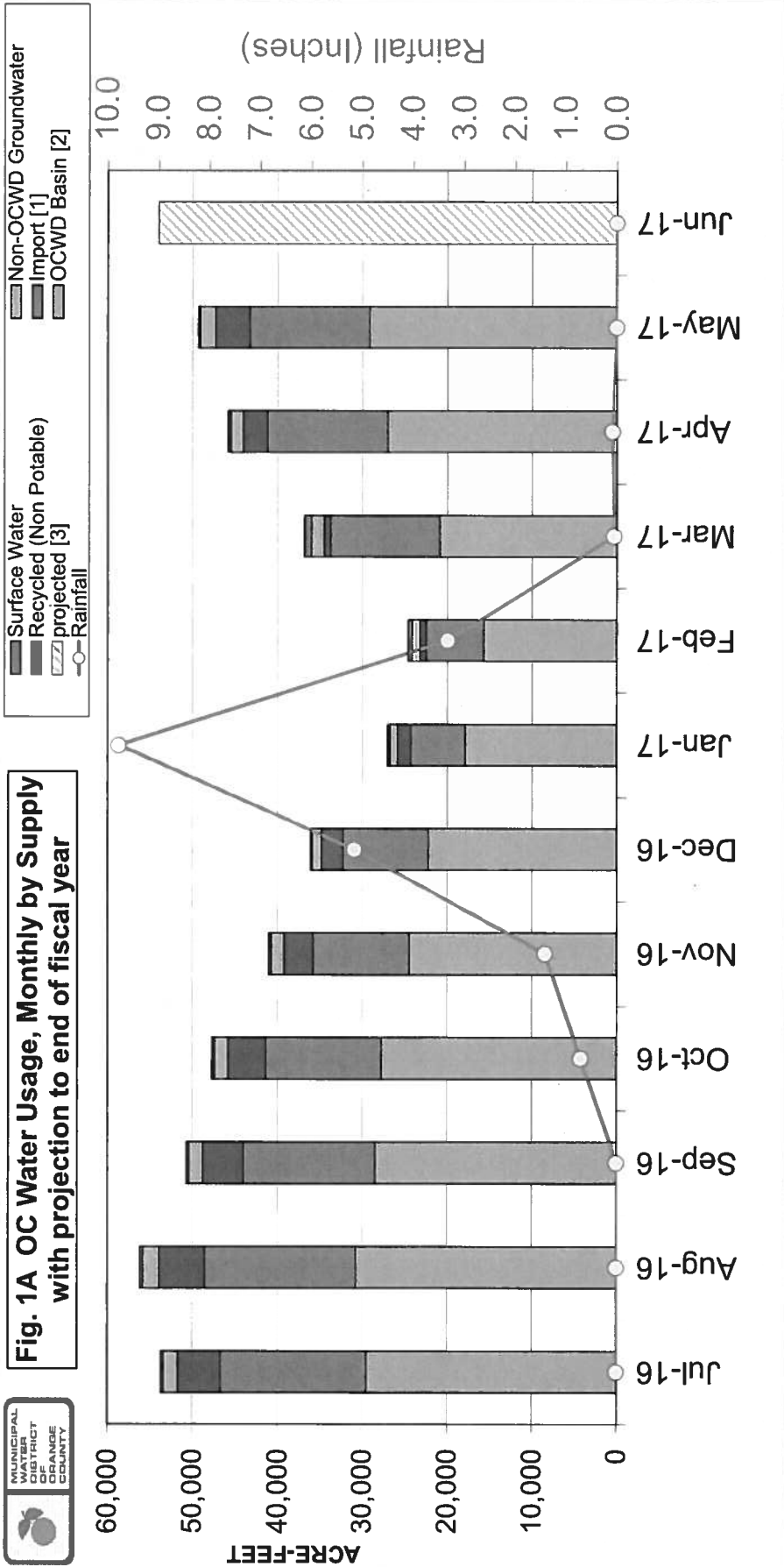
Water Supply Information Includes data on: Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the

magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated rainfall through June was well above average for this period. Orange County has had below average rainfall for the past 5 hydrologic years.
- Northern California accumulated precipitation through June was around 195% of normal for this period. June 2017 rainfall was average for that month and the region is seeing the wettest water year on record. The Northern California snowpack is 195% of normal as of May 26th. The State of California was in a declared Drought Emergency that started January 2014 and just recently ended in April of 2017. As of late April drought conditions have improved significantly and only 8% of California is still suffering from moderate or severe drought. The State Water Project Contractors Table A Allocation has increased to 85% as of the end of April.
- Colorado River Basin accumulated precipitation through June was 111% average for this period. The Upper Colorado Basin snowpack was 152% of normal as of May 22nd. This follows five below-average hydrologic years; the Colorado River Basin is in the recovery of a long-term drought. Lake Mead and Lake Powell combined have about 67% of their average storage volume for this time of year. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries for the Lower Basin states. As of late June Lake Mead levels were 7' above the "trigger" limit. The USBR predicts that the end of 2017 or the end of 2018 will not hit the "trigger" level.

Fig. 1B O.C. Historical Water Usage

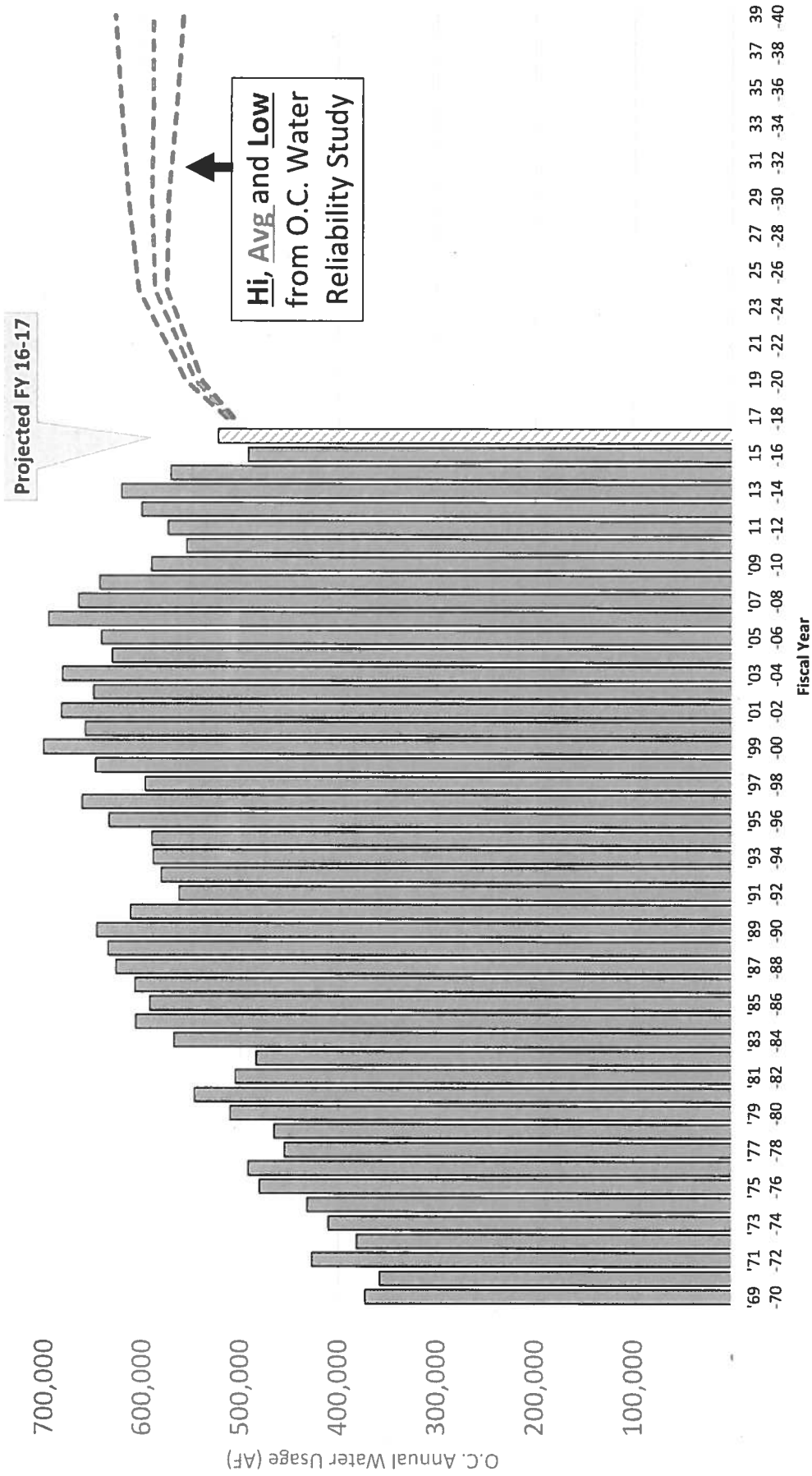
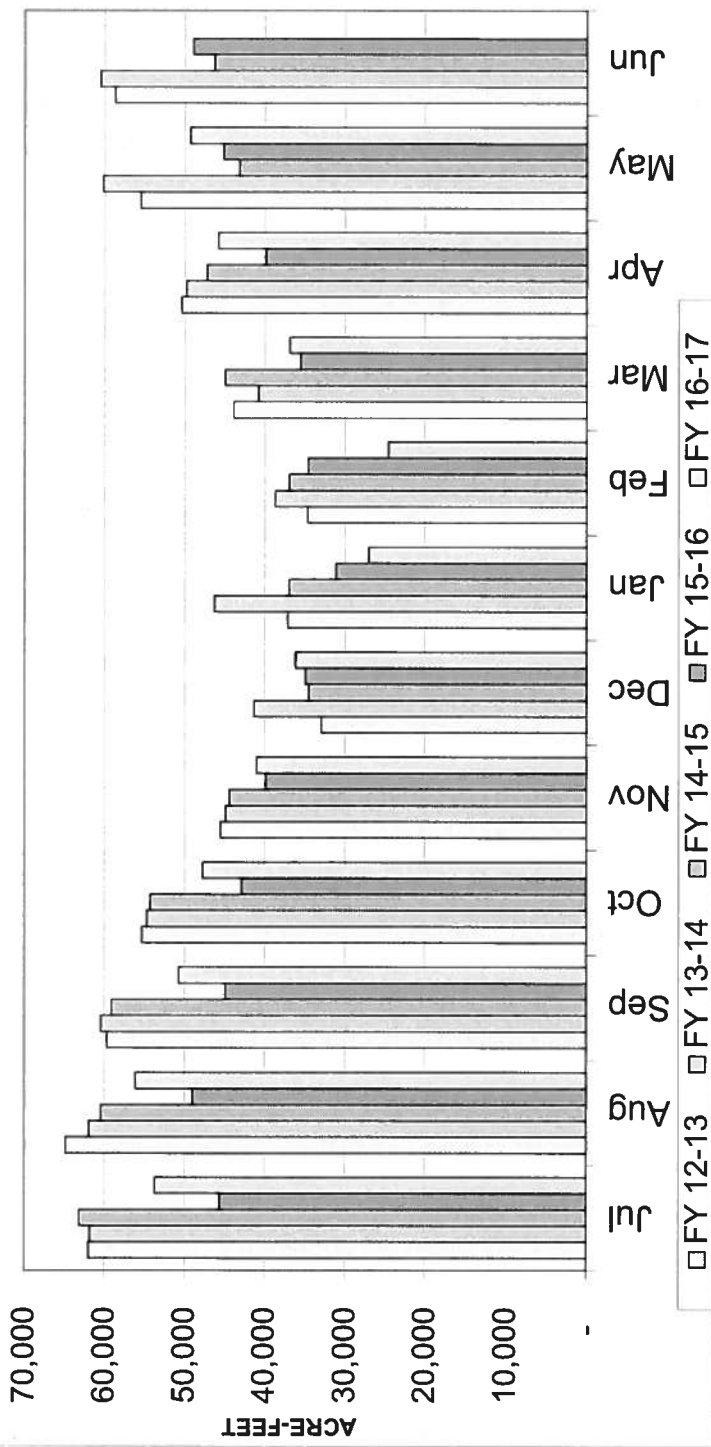
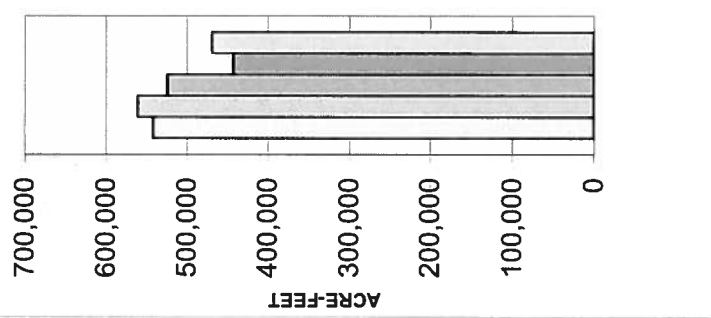




Fig. 2A OC Monthly Water Usage [1]: Comparison to Last 4 Fiscal Years



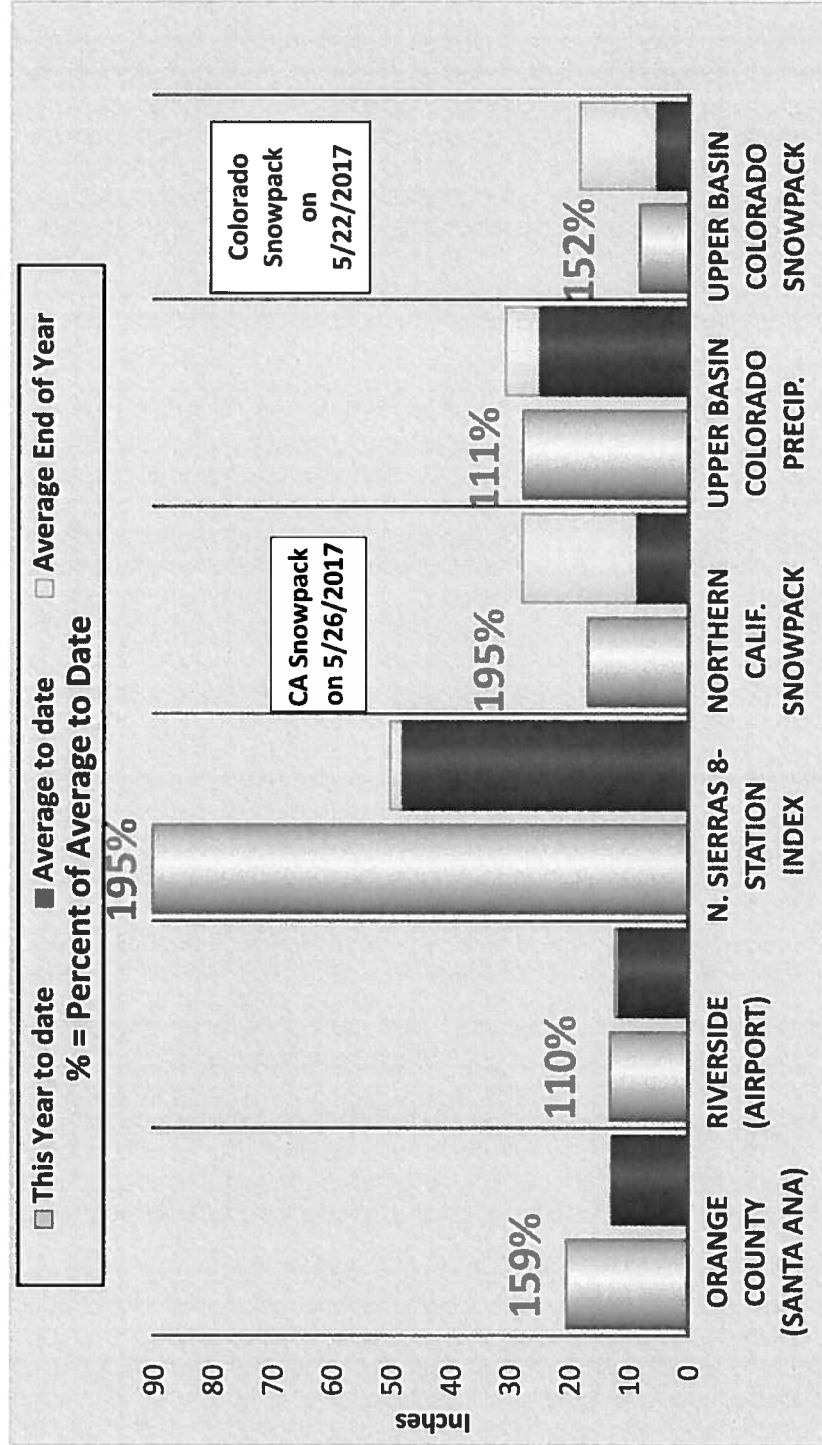

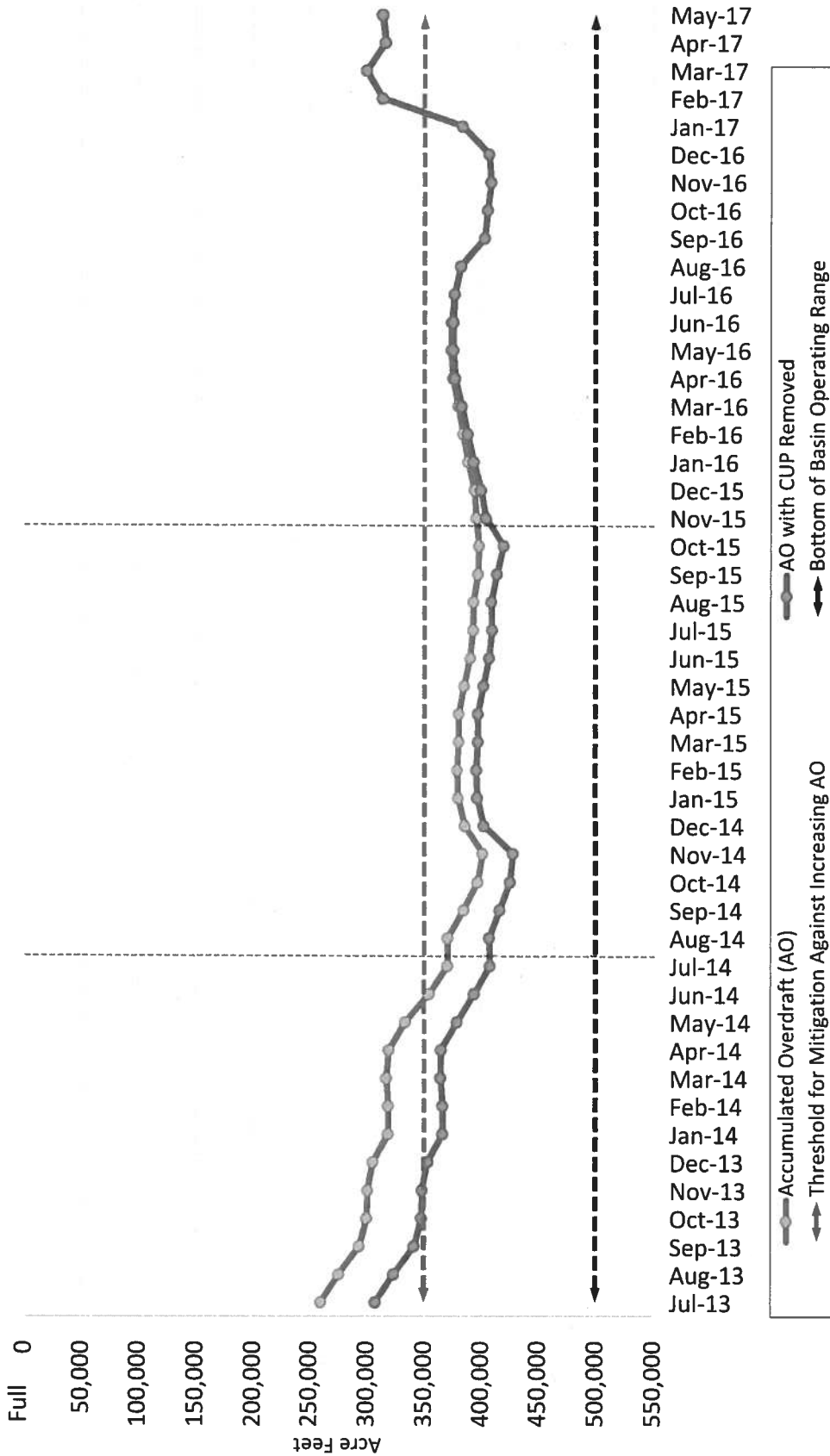
Accumulated Precipitation

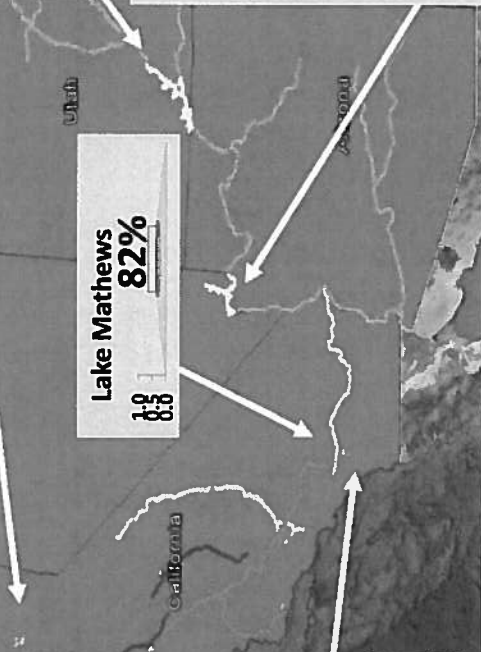
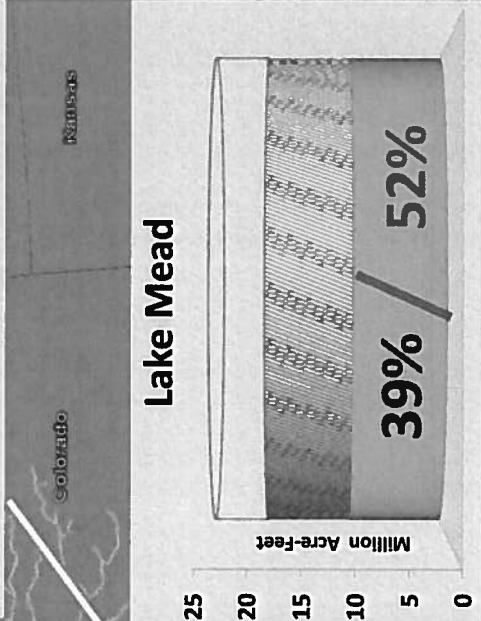
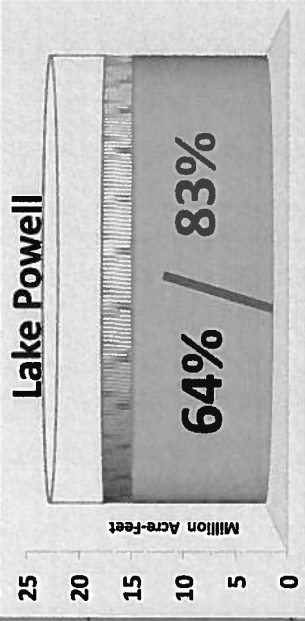
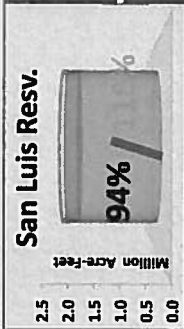
Accumulated Overdraft of the OCWD Groundwater Basin as of May 2017

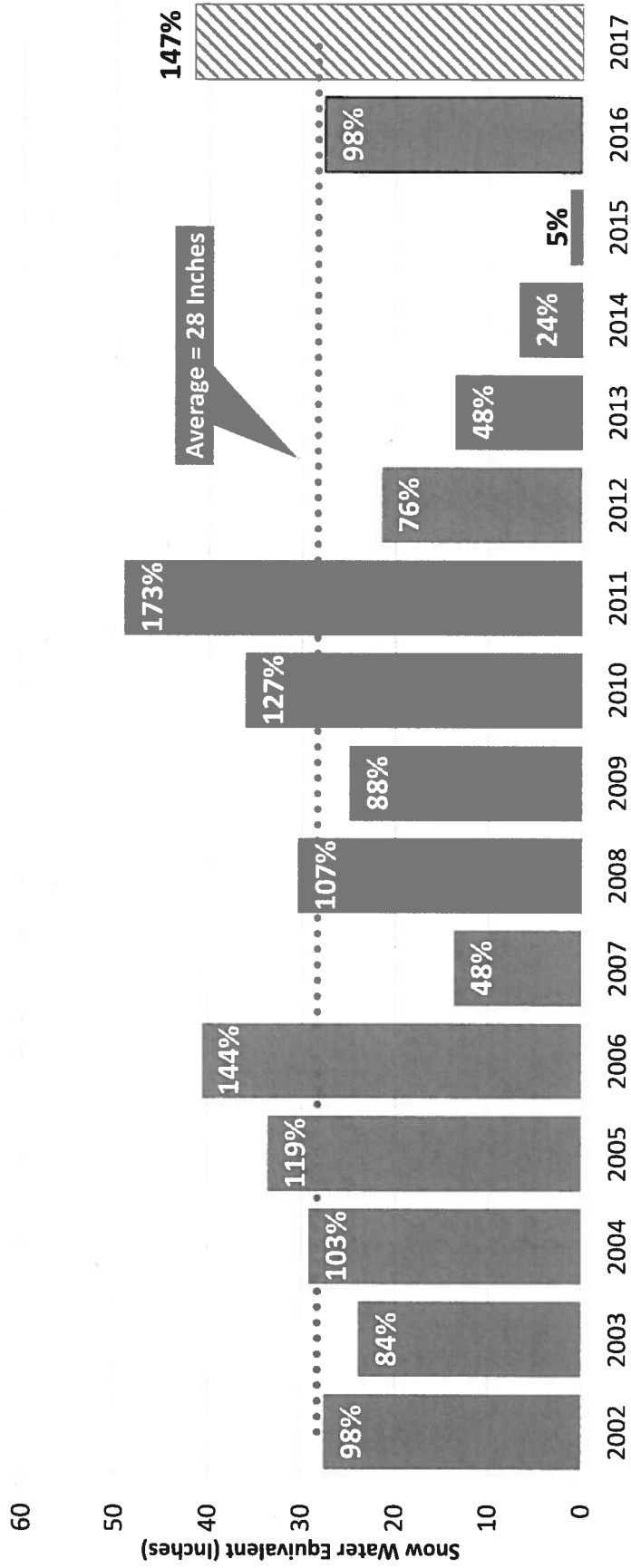


State Water Project, Colorado River, and MWD Reservoir Storage
as of May, 28th 2017

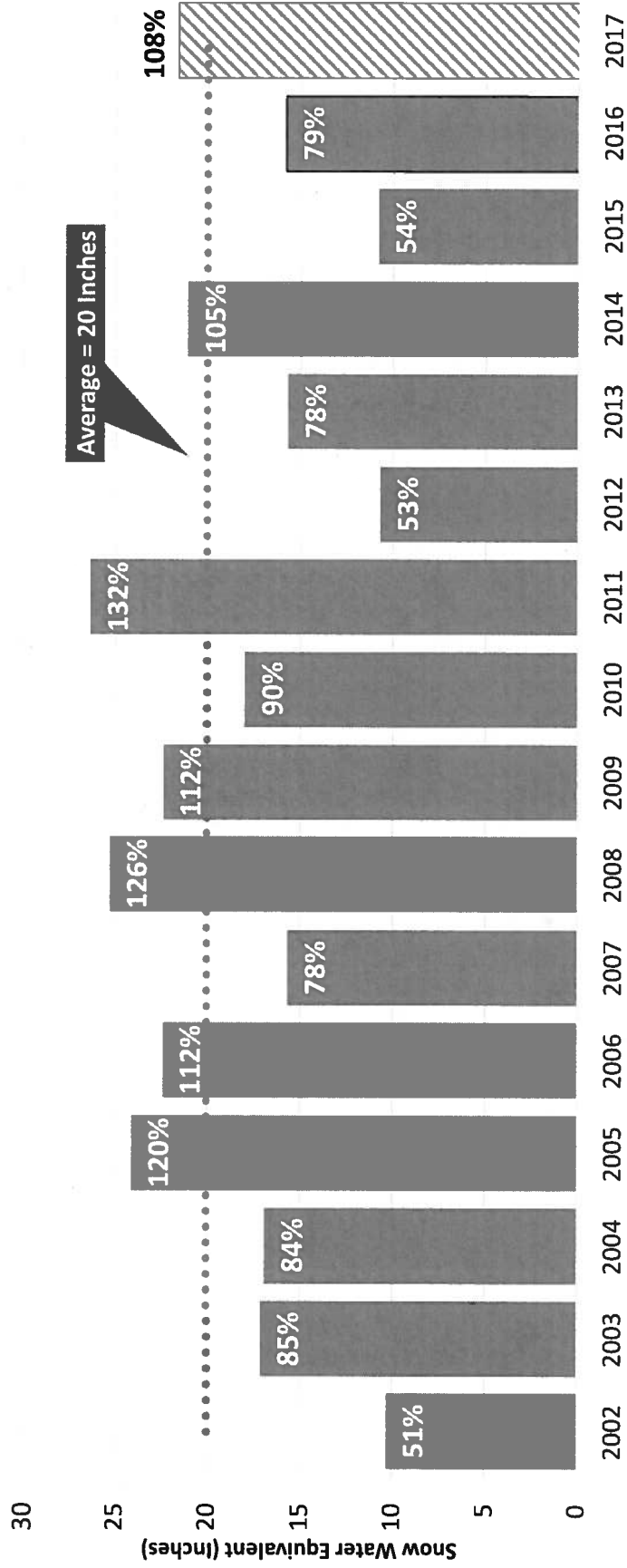

Historical Northern California April 1st Peak Snow Water Equivalent



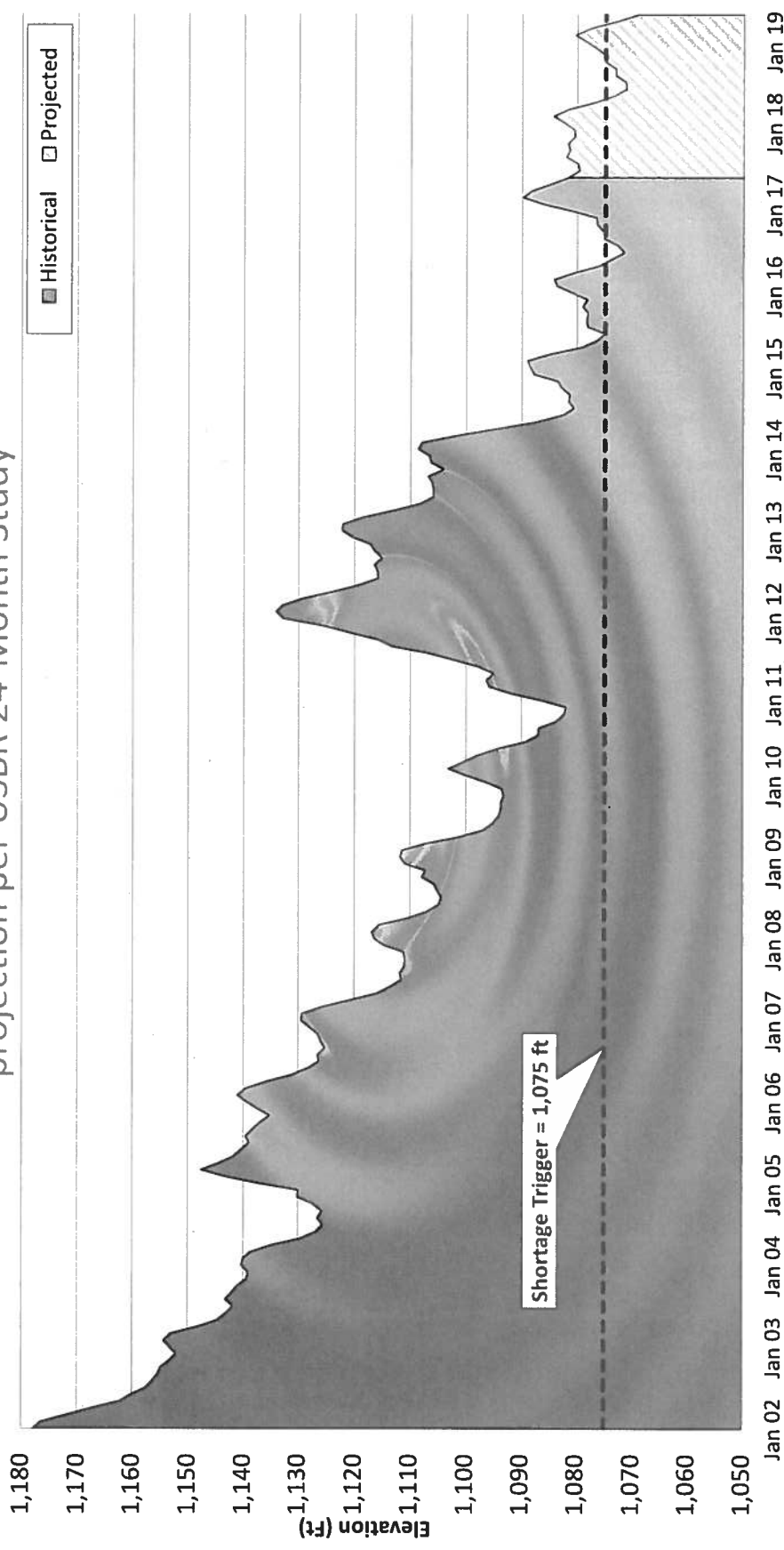
Historical Colorado Basin April 15th Peak Snow Water Equivalent





Lake Mead Levels: Historical and Projected projection per USBR 24-Month Study

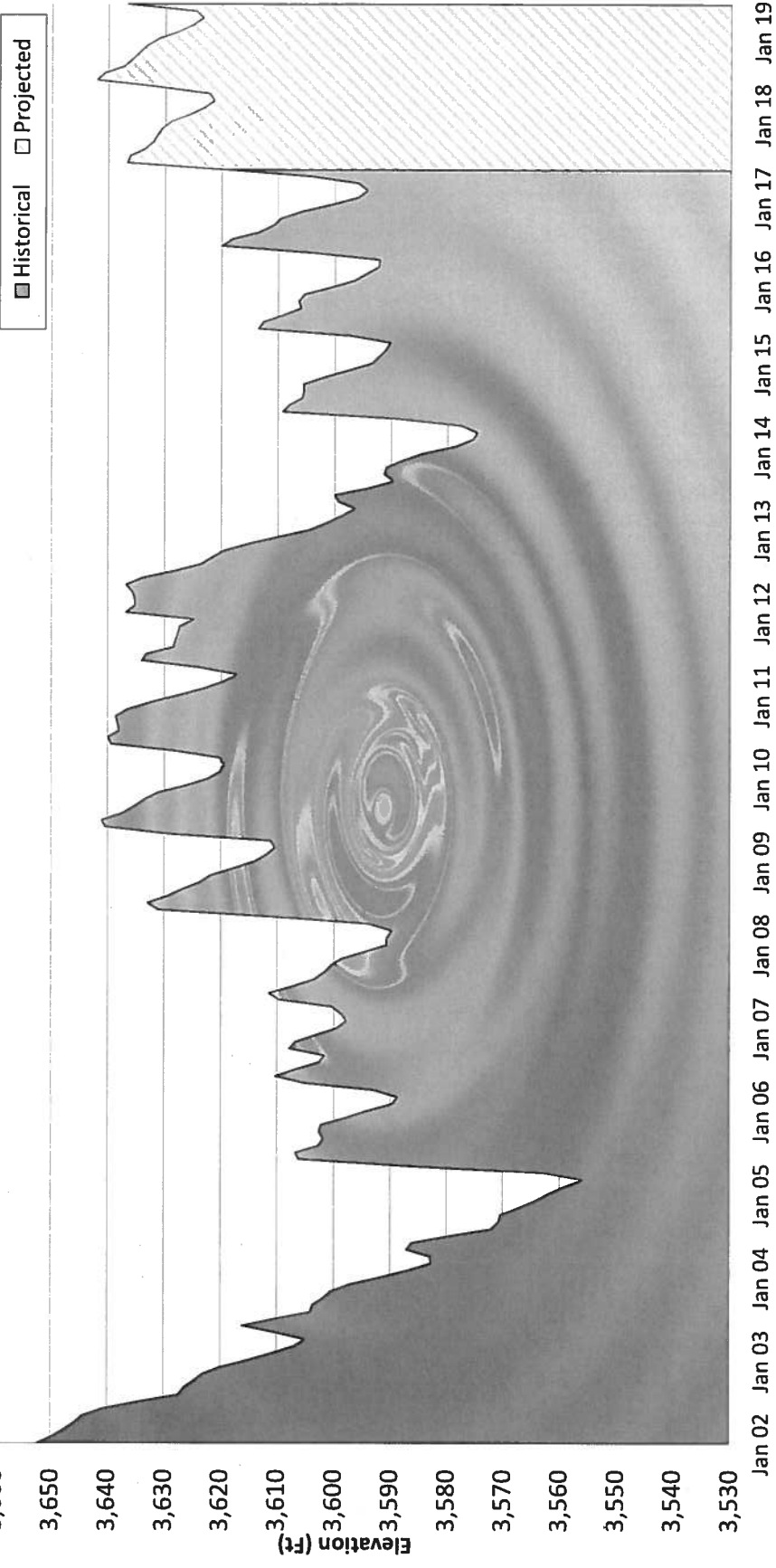

City of Garden Grove

An open-source pioneer says it was actually late to the game

When Garden Grove, California, installed its first personal computers in 1994, the fifth largest city in Orange County was behind the times. Most municipalities had made that transition in the late '80s.

But IT Director Charles Kalil says there were advantages to being a late adopter. For starters, it gave Garden Grove the opportunity to research all the latest software and networking programs. So when the city finally made its move, it had the most advanced technology on the market.



In other words, “if we were going to be late to the party, we wanted to have the newest car in town,” says Kalil.

In 1995, Garden Grove became one of the first cities to use a transmission control protocol/internet protocol (TCP/IP), UNIX, to build the city’s private network. At that time, the internet was already established in homes, but most city governments were hesitant to switch to the new protocol, especially considering they made the jump to PCs only a couple of years earlier.

But Kalil, who was then working as a senior information systems analyst, says the previous IT manager was convinced that TCP/IP was the future of networking, and he was proved right.

Less than a year later, after Garden Grove had moved into a new city hall, people started asking the IT department when the city was going to get this “internet thing” they had heard about on TV.

“They expected us to be behind, and instead we got to tell them you’ve had that for about six months,” says Kalil, almost laughing. “That’s really when perceptions about [Garden Grove] began to change because instead of being the backwards city, we were the ones ahead of the curve.”

However, Garden Grove's decision to use the UNIX networking system wasn't just rooted in the city's role as a latecomer. It was also a way to save the city money—and it could do the same for other municipalities.

Garden Grove may be the fifth largest city in Orange County, but it has the 8th largest budget.



Beside the advantages of running on a TCP/IP, UNIX also supports multiple open-source programs systems such as Samba, a networking protocol that Garden Grove used to network all its PCs together, and Linux, a fully-featured computer operating system.

Open-source software is free to download, and, in the case of Linux, often has more capabilities than its more expensive counterparts, Kalil says.

"With Linux, we could just download it and immediately start exploring," he says. "It was powerful, accessible—and remember, we were in a time crunch trying to get things up and running."

software the changes can be shared with the rest of the software's users.

However, only three cities in the United States, including Garden Grove, were using open-source software, which meant Garden Grove couldn't depend on outside technical support if there was a problem with the system.

"So any time we were looking for a solution, the answer was always, we'll just do it ourselves," Kalil says.



As a result, Garden Grove's team of developers has written the majority of the city's web applications, and today continues to rely heavily on its in-house team of analysts and developers.

In preparation for the November 2016 election, for instance, the IT department made it easier for citizens to look up which district they lived in by developing an open-source GIS in as little as four weeks.

When the city bought a mobile app, Kalil says his team ended up writing most of the applications so that Garden Grove didn't have to depend on a third party for updates or changes to the system. The IT department also built the mobile systems to be exactly the same as the city's website.

"The application you use on your computer at home is the same application you're using on your smartphone, we've just made it responsive so it changes its look and feel based on the size of the device using it," Kalil says. "When we fix something on one site, it changes all the platforms."

Collaboration nationwide

For the last 10 years, Garden Grove has been encouraging other cities to join them on open-source platforms. Kalil says the problem is that a lot of cities don't see the point in investing in developers when they could just buy the newest software.

satisfy the needs of Senate Bill 272. This new law is designed to improve governmental transparency by requiring governments to publicly display a catalogue of enterprise systems. Today, nearly 100 California agencies use the system that Garden Grove wrote and hosted.



"It's something I would love to see more of in the future because we used [open-source software] because we have a limited budget, but the reality is all governments have a limited budget. We all have the same issues and we aren't in competition with one another, so why aren't we collaborating more?"

Every piece of software Garden Grove has developed is free for other cities to use. Kalil hopes that other municipalities will take advantage of the tools his team has developed, and, with any luck, improve it for the next user.

"I think government could be a lot more efficient if they instead utilized developers and we all collaborated together to create solutions," he says.

GARDEN GROVE, California (NV) – Trong phiên họp tối Thứ Ba, 27 Tháng Sáu, Hội Đồng Thành Phố Garden Grove chuẩn thuận việc hoàn toàn tài trợ chi phí làm bảng tên đường "Bolsa Trần Hưng Đạo" tại hai góc đường Bushard và đường Ward để hài hòa với bên Westminster.

Với tỷ số 6-1, thành phố Garden Grove đồng ý bỏ ra khoảng \$1,500 để làm hai bảng tên đường này.

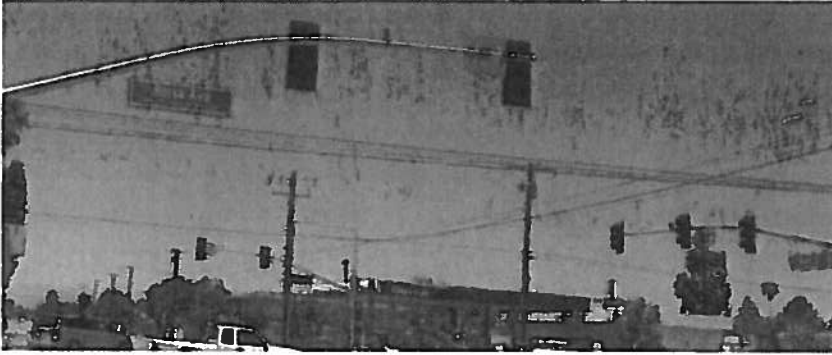
Việc treo hai bảng tên đường mang tên "Đại Lộ Trần Hưng Đạo" mang đến cho đường Bolsa, một trong những trục lộ chính, chạy dọc trung tâm Little Saigon, thêm sắc thái đặc thù của một thủ đô tị nạn và cũng nói lên sự liên kết chặt chẽ giữa Garden Grove và Westminster, theo Nghị Viên Thu-Hà Nguyễn.

Đề mục này được Nghị Viên Thu-Hà Nguyễn và Phó Thị Trưởng Phát Bùi đề nghị, với sự đồng tình của Thị Trưởng Steven R. Jones đưa vào nghị trình.

Cô Thu-Hà nói với nhật báo Người Việt: "Góc đường Bolsa và đường Bushard thuộc Địa Hạt 3, là địa hạt của tôi. Còn góc đường Bolsa và đường Ward thuộc Địa Hạt 4, là địa hạt của anh Phát Bùi. Đó là lý do cả ba chúng tôi cùng làm việc với nhau để thuyết phục Hội Đồng Thành Phố thông qua."

Phần hướng Nam, bên tay phải, từ góc đường Magnolia đến góc đường Ward, bảng tên "Bolsa Trần Hưng Đạo" đã được thành phố Westminster treo từ Tết rồi.

Hai bảng tên mới này cũng tương tự như của Westminster, bên trên có chữ "Bolsa Ave," bên dưới là "Đại Lộ Trần Hưng Đạo."

Điểm khác nhau là, bên Westminster có chữ trắng trên nền xanh lá cây, y như màu bảng tên đường trên xa lộ, trong lúc bên Garden Grove có chữ trắng trên nền xanh dương, theo qui định thành phố.

Cuộc bàn thảo về việc này của Hội Đồng Thành Phố Garden Grove không nhanh chóng như của Westminster vì Westminster được Trần Hưng Đạo Foundation trang trải mọi chi phí, trong lúc các vị dân cử Garden Grove muốn thành phố xuất tiền từ công quỹ.

Ngay sau khi đề cập đến đề mục này, Nghị Viên Thu-Hà Nguyễn bị Nghị Viên Kris Beard đặt nhiều câu hỏi như "Tại sao phải làm giống Westminster? "Tại sao không chỉ ghi chữ 'Little Saigon' thay vì tên tuổi dài dòng?" "Muốn khác với Westminster, tại sao không ghi chữ 'City of Garden Grove?'"

Phó Thị Trưởng Phát Bùi ôn tồn giải thích cặn kẽ từng thắc mắc cho ông Beard.

Nghị Viên Stephanie Klopfenstein nêu lên quan tâm của mình là nếu số tiền thành phố phải bỏ ra cao hơn dự trù thì ai sẽ chịu. Về điều này, Nghị Viên Thu-Hà Nguyễn mạnh dạn trả lời: "Tôi và cộng đồng sẽ chịu mọi trách nhiệm trang trải cho số tiền sai biệt. Nếu cần, chúng tôi sẽ tự gây quỹ."

Phó Thị Trưởng Phát Bùi chia sẻ với nhật báo Người Việt: "Tôi rất mừng là đã thông qua được việc này. Được việc của mình là quá vui rồi, nhưng tôi cũng rất lo. Khoảng một tháng rưỡi nữa, bảng tên đường mới hoàn tất. Thành phố Westminster sẽ đảm nhận việc treo tên đường.

"Lúc ấy có thể sẽ có một lễ nho nhỏ khi treo bảng tên đường," cô Thu-Hà nói.

Little Saigon: Garden Grove will have the name 'Bolsa Tran Hung Dao Avenue'

On Tuesday evening, June 27, during the City Council meeting, the Garden Grove City Council approved full funding for the street name signs 'Bolsa Tran Hung Dao' at the intersections of Bushard Street and Ward Street to match signs in the City of Westminster

With a vote of 6-1, the Garden Grove City Council agreed to spend about \$1,500 to make these two street signs.

According to Councilwoman Thu-Ha Nguyen, the installation of two street signs called 'Tran Hung Dao Avenue' will bring significance to Bolsa Avenue, in the Little Saigon area, a unique look for a capital city of Vietnamese-American refugees, and help bond the relationship between Garden Grove and Westminster.

This item was proposed by Councilwoman Thu-Ha Nguyen and Mayor Pro Tem Phat Bui, with the agreement of Mayor Steven R. Jones to put it on the agenda.

Councilwoman Thu-Ha Nguyen shared with the Nguoi-Viet Daily Newspaper, "The intersection at Bolsa Avenue and Bushard Street is within my District 3, and the intersection at Bolsa Avenue and Ward Street is within District 4. This is the district of Mayor Pro Tem Phat Bui. That is the reason why all three of us work together to bring it to the City Council for approval."

Two street signs will be installed north of Bolsa Avenue. This means if someone were driving along Bolsa Avenue from Beach Boulevard toward Ward Avenue, the new sign will be on the left side. From the south, on the right side, at the corner of Magnolia Avenue to the corner of Ward Street, the sign 'Bolsa Tran Hung Dao' was already installed by the City of Westminster.

The two new street name signs are similar to those from the City of Westminster, with Bolsa Avenue on top, and below will be named 'Tran Hung Dao Avenue.'

The difference is that Westminster has white letters on a green background, just like the street signs on the freeway. The City of Garden Grove has white letters on a blue background, according to city regulations.

The discussion on this topic by the Garden Grove City Council was not as quick compared to the City of Westminster because the street signs in Westminster were paid for by the Tran Hung Dao Foundation, and Garden Grove constituents wanted the City to raise money from public funds.

After the discussion referring to this topic, Councilwoman Thu-Ha Nguyen was asked by Councilman Kris Beard, "Why do we have to do things like Westminster?"

Why can't we just write 'Little Saigon' instead of a long name? If the City would want to be different from Westminster, why not put 'City of Garden Grove?'"

Mayor Pro Tem Phat Bui insisted on carefully explaining each question from Councilman Kris Beard.

Councilmember Stephanie Klopfenstein raised her concern that if the City had to spend more than expected, who would carry the extra cost. Councilwoman Thu-Ha Nguyen firmly replied: "The community and I will take the responsibilities to cover the difference amount. If necessary, we will raise funds ourselves. "

Mayor Pro Tem Phat Bui shared with Nguoi-Viet Daily newspaper: "I am very happy this discussion was approved, but I'm also very worried. Garden Grove is a multi-ethnic populated city. What if the Korean community wants their names? And what about the Muslim community? But maybe I'm over-worried."

Then he laughed, "Well, we did our job as elected officials in Garden Grove on Tran Hung Dao Avenue. We should be happy as it goes."

The intersection of Bolsa Avenue and Ward Street is at the far end of Garden Grove. From Euclid Street forward, Bolsa Avenue becomes First Street and is in the City of Santa Ana.

In about a month and a half, the new street name signs will be completed. The City of Westminster will be responsible for installation.

Councilwoman Thu-Ha Nguyen said, "At that time, there might be a small unveiling ceremony of the new street signs."

Dear Mayor Jones:

On behalf of the Orange County Transportation Authority (OCTA) Board of Directors, I wanted to advise city elected officials of recent developments regarding the Orange County Taxi Administration Program (OCTAP).

Many may not realize that OCTA administers OCTAP at the request of and on behalf of Orange County cities and the County of Orange (County). OCTAP was created in 1998 to consolidate the licensing, application, and administrative functions to assist Orange County cities in meeting their requirements set forth in Government Code Section 53075.5 and Vehicle Code Section 21100, *et seq.* At that time, OCTA was selected by the cities to provide staff and administrative services necessary to permit taxi operations and enforce OCTAP regulations adopted by the cities and the County.

Since its inception, OCTAP has been funded entirely through permit and license fees. However, with the arrival of Transportation Network Companies (TNCs) such as Uber, Lyft and others, the marketplace has greatly reduced the number of taxi permits in the County, which, in turn, has created a financially unsustainable condition for the continuation of OCTAP as currently funded.

To address this issue, OCTA has been working through the Orange County City Managers Association (OCCMA) as well as the OCTAP Steering Committee (which includes taxi providers as well as member agency representatives) since spring of 2016 to come up with both short- and long-term solutions.

It has been determined that the cost to administer OCTAP for fiscal year 2017-18 will exceed expected revenues, and OCTAP will only have enough funding to operate through December 2017. OCCMA has agreed that it is in the best interest for member agencies (cities and the County of Orange) to fund the shortfall to allow for OCTA to administer OCTAP at least through June 2018 while a long-term solution is identified. It is expected that the amount needed to fully fund OCTAP operations beyond December 31, 2017, through June 30, 2018 is

approximately \$166,800. The estimated cost for each agency, based on population, is attached for your reference.

It is widely believed that OCTAP is an effective model that delivers efficiencies benefitting all member agencies. However, due to the changing marketplace with taxis and TNCs, and the fact that OCTA has no legal requirement to regulate taxis, further administration of OCTAP by OCTA beyond June 30, 2018, may not be an option.

The future of OCTAP will be the focus of OCTA and OCCMA over the next six months. Recommendations will be brought before the OCTA Board of Directors in the coming months for discussion and potential action.

Dear City Manager Stiles,

In recent years, California has swung from one of our driest rain seasons to one of our wettest. That kind of variability speaks to the need to maintain a water system that can capture rainfall when nature makes it available so our communities have adequate water in storage for the next drought. That requires the right investments in the right projects to prepare for the future. Such a project will be ready for consideration soon by The Metropolitan Water District of Southern California Board of Directors. I want to reach out and provide you some information on the project, known as California WaterFix, so that you understand the importance of this water project.

Overall, about 30 percent of Southern California's water comes from Northern California via the Sacramento-San Joaquin Delta and the State Water Project. This is our largest imported source of supply, and one of our most cost-effective sources. It helps us refill our reservoirs and groundwater basins. And its very high quality promotes local solutions like recycling and groundwater replenishment.

The State Water Project system has served Southern California well for nearly half a century. But the time to modernize this project and make it more compatible with the Delta environment has come. We have worked with state and federal agencies for more than 10 years to develop a solution. Now we have received key federal permits, and the agency I represent will soon be ready to decide whether to invest in this project.

I believe the cost of inaction will have significant negative consequences for Southern California. The Delta's declining ecosystem and miles of aging levees are increasingly vulnerable. Investing in a Delta solution will help maintain the reliability of our statewide water system. But we all need to understand this project and important financial details before making a firm investment decision. This will be one of the most important water decisions for The Metropolitan Water District of Southern California in a generation.

The enclosed brochure contains more information about the project – the need, the proposal and the benefits. I invite you to learn more about California WaterFix. Please don't hesitate to call if I or my agency can provide any additional information.

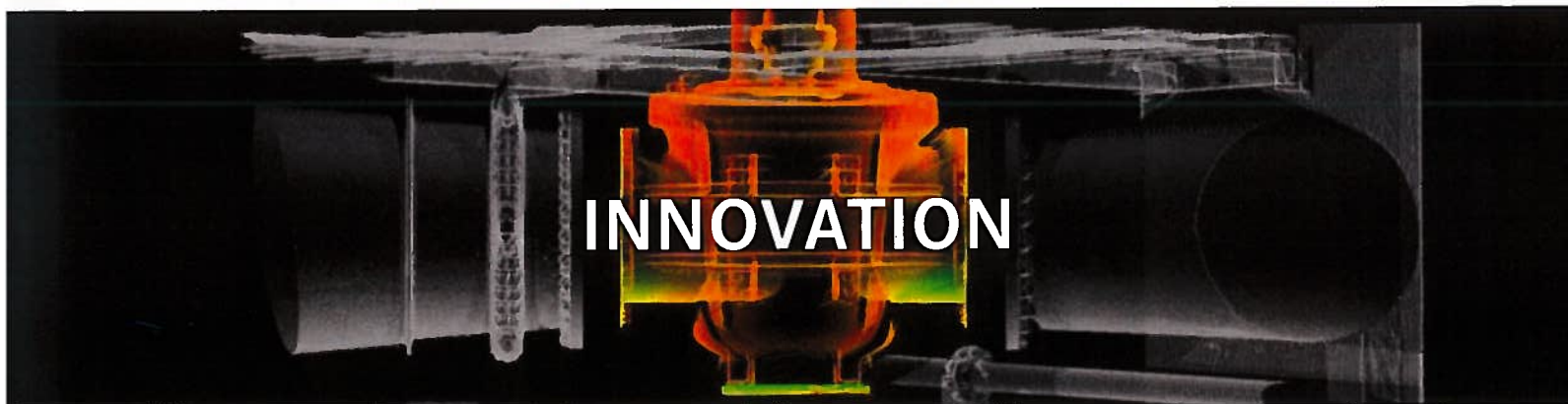

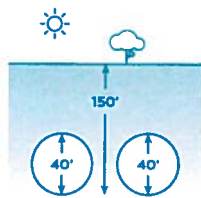

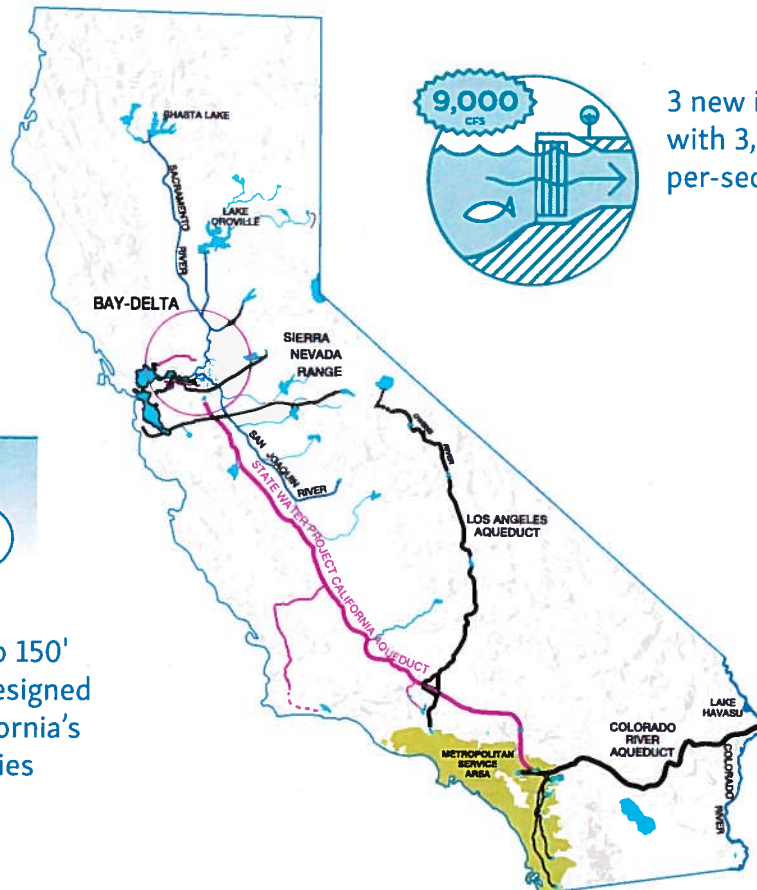

California WaterFix: A Plan to Protect Water Supplies and the Delta

Why We Need a Delta Solution

Modernizing and improving the State Water Project system is essential for our region. About 30 percent of the water that flows out of taps in Southern California homes and businesses comes from Northern California watersheds and flows through the Sacramento-San Joaquin Delta. But the Delta's declining ecosystem and 1,100 miles of levees are increasingly vulnerable to earthquakes, flooding, saltwater intrusion and climate change.

California WaterFix is the comprehensive plan that has been developed over the past 10 years to ensure our state has a reliable water supply for many years to come. This water supply remains one of our most cost-effective sources, even with this major new investment. Southern California will be able to meet new demands on our water supply through increased development of local supplies and conservation, provided we maintain our State Water Project imported supplies. These resources are all important ingredients for future supply reliability.

All of the Above Strategy

Metropolitan and its 26 member agencies are committed to meeting the water needs of Southern California's homes and businesses by maintaining and stabilizing existing resources, along with developing more conservation and new local supplies. Modernizing the state's water system in the Delta is a key part of this "All of the Above" strategy.

It all comes down to reliability and meeting demand. Metropolitan needs to maintain imported supplies from Northern California and the Colorado River, and when there is surplus available, store it in reservoirs and groundwater basins for future use. Conservation continues to be essential, in part because lowering water demand increases the amount of water that is available for storage.

Developing local supplies helps offset imported supply limitations, avoid system costs and meet the demands of our growing population. Finally, Metropolitan invests in innovation in areas like recycled water, desalination, groundwater cleanup and stormwater capture so we have one foot in the future while maintaining reliability today.

Next Steps

In the coming months, Metropolitan and its member agencies will carefully review the benefits of the proposed project before making an historic investment decision. In a series of meetings that are open to the public and will be webcast from our downtown Los Angeles Union Station headquarters, we will examine the proposed financing and operations of this system. Here is the current proposed schedule for board presentations and discussions:

July 25 – Operations

August 14 – Finance/Cost Allocation

August 22* – Metropolitan Board Workshop

September 12* – Vote by Metropolitan Board on California WaterFix

Refilling Storage

Thanks to a record wet year, Metropolitan will put more water back into our local reservoirs and other storage than in any single previous year, including filling our Diamond Valley Lake in southwest Riverside County. This will help prepare us for future droughts and dry cycles. Investments since 1990 have increased our storage capacity across the region by 13 times.

Local Supplies

Southern California continues to work together to diversify the region's water portfolio and meet the future demands of the area's growing economy and ensure supply reliability in the face of climate change impacts. Metropolitan also is working with the Los Angeles County Sanitation Districts on a proposed water recycling project that could be one of the largest in the world.

Conservation

To make conservation a way of life, Metropolitan and its member agencies funded the nation's largest turf removal and water conservation program. While the turf removal program has ended, many other rebates for water-efficient appliances and irrigation systems are available at bewaterwise.com. The site also offers helpful information about online conservation classes, water-saving tips and resources.

Colorado River

For more than 75 years, Metropolitan has delivered reliable and essential water supplies from the Colorado River. Metropolitan invests in innovative conservation and water transfer programs with farmers in the Imperial and Palo Verde valleys. Currently, Metropolitan and other agencies in the United States and Mexico are working to create unique agreements to better manage the river and balance future competing needs.

The timing of enactment of HUD's full fiscal year appropriation has significantly shortened the window available to grantees to submit an Annual Action Plan given the effective submission deadline of **Wednesday, August 16, 2017**. The Department cannot provide relief from this deadline as it has been established pursuant to statute and HUD encourages grantees to expedite efforts to finalize and submit their Annual Action Plans. To assist in this effort, CPD has issued a waiver to reduce the public comment period associated with these plans from 30 to 14 days.¹⁰³² Failure to submit an Annual Action Plan by August 16, 2017, will cause a grantee to forfeit its FY 2017 CDBG formula funding allocation. If you have questions or require assistance in preparing and submitting your Annual Action Plan, please contact your responsible CPD office.

This letter highlights several important points related to these programs. We remind grantees that CPD seeks to develop viable communities by promoting integrated approaches that provide decent housing, a suitable living environment, expand economic opportunities for low and moderate income and special needs populations including people living with HIV/AIDS. The primary means towards this end is the development of partnerships among all levels of government and the private sector, including both for-profit and non-profit organizations.

The Department continues to emphasize the importance of effective performance measurements in all its formula grant programs. Proper reporting in the Integrated Disbursement and Information System (IDIS) is critical to ensuring grantees are complying with program requirements and policies; providing demographic and income information about the persons that benefited from a community's activities; and allowing HUD to monitor grantees. Your ongoing attention to ensuring complete and accurate reporting of performance measurement data continues to be an invaluable resource with regard to the impact of these formula grant programs.

The Office of Community Planning and Development is looking forward to working with you to promote simple steps that will enhance the performance of these critical programs and successfully meet the challenges that our communities face. Dear Acting Regional Administrator Strauss:

Governor Brown's Office asked me to respond to your letter of May 17, 2017, requesting the State of California's position on the proposed listing of the North Orange County Groundwater Basin (North Basin) on the Superfund National Priorities List (NPL).

Protecting public health, the environment and the reliability of safe drinking water are State priorities and we agree with the United State Environmental Protection Agency (U.S. EPA) that threats posed by the contaminated plume in the North Basin must be remediated. The State also supports the principle that polluters should pay to clean up contamination. Listing this site will provide the parties responsible for the contamination in the North Basin with added incentive to develop and fund a cleanup plan for this site. For these reasons, the State concurs with U.S. EPA's proposal to list the site on the NPL.

As you are aware, state and local agencies, including the California Department of Toxic Substances Control, the Santa Ana Regional Water Control Board and the Orange County Water District, have been working independently and in cooperation with U.S. EPA on remediation of the North Basin contamination. These efforts include the Department's remediation of three of the contaminated sites, the Santa Ana Water Board's oversight of remediation at six other contaminated sites, and the Water District's administrative settlement agreement with U.S. EPA to conduct a remedial investigation and feasibility study to address the contamination. The State looks forward to working cooperatively with U.S. EPA to continue these efforts, in conjunction with efforts to compel the responsible parties to conduct and fund a comprehensive remediation of contaminated groundwater in the North Basin site.

start at 6:30 p.m. with the headlining acts booked from 6:30 p.m. to 8:30 p.m.

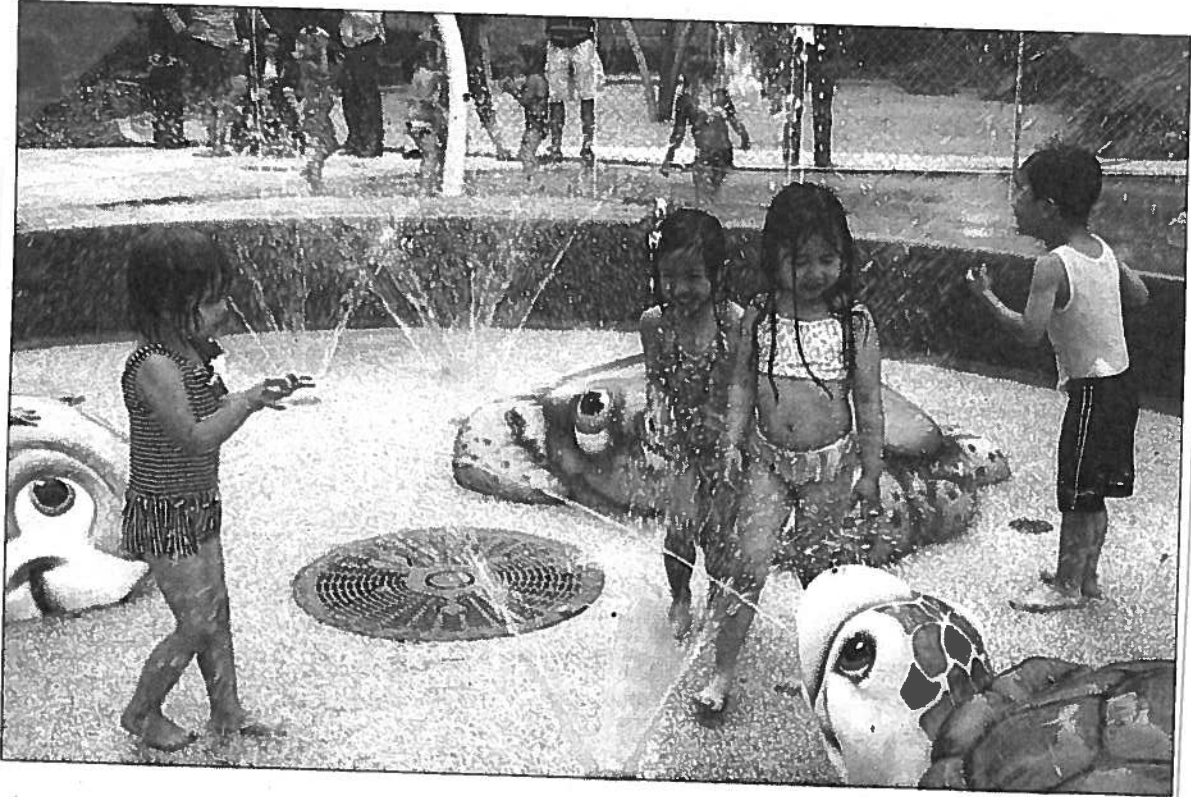
Westminster concert series kicks off

Torrens portrays Robbie Hart, the New Jersey rocker "wannabe" and lead singer of his band who, along with his fellow musicians, George (Peter Crisafulli) and Sammy (Tim Miller), has made a name for himself as a popular wedding singer.

Ironically, Robbie gets jilted by his trashy fiancée, Linda (Brianna Garmon), and Robbie finds himself down in the dumps (literally!) until the sweet, but newly-engaged waitress, Julia (Hannah Clair) comes along.

Torrens and Clair are very strong leads, and the individual cast members all give stunning performances, but it is Holly (Nicole Cassesso, producer) who adds the funny in funny bone.

As a gorgeous material girl

look-a-like, Cassesso's bubble gum popping Holly steals the limelight from the talented ensemble, and Holly's lead into "Saturday Night in the City" and "Right in Front of Your Eyes" duet with Sammy (Miller) tops the charts.

Bad boy and Wall Street mogul Glen Guglia (Lawrence Havelka) struts his stuff in a polyester suit kind-of-way that smells of dirty rat no matter how he wears it, and Havelka digs into his character with sheer abandon.

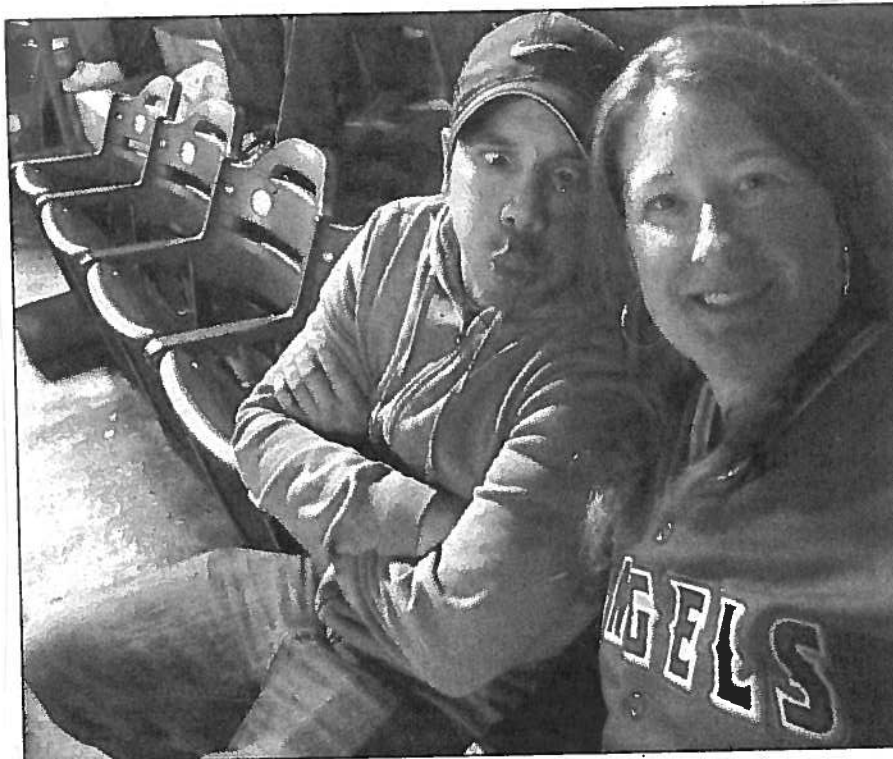

A high-voltage 'Wedding Singer'

Ensemble excellence — critical in any musical theater show — becomes particularly evident in "The Wedding Singer," the latest offering from One More Productions at Garden Grove's Gem Theatre.

Behind its simple romantic plot, also quite nicely interpreted by director-musical director Damien Lorton, is a panoply of dance movements so complex they required four choreographers to create.

These fleet-footed background performers lend enormous support to the romantic comedy involving a wedding singer and a waitress, each engaged to others at their initial encounter, who somehow discover each other.

They also discover the musical decade of the 1980s, the era which first produced the movie on which the stage version is based. The '80s references abound in the Gem production, even sparking a "best '80s outfit" contest for audience members on opening night.

The title role of Robbie Hart is taken at the Gem by Edgar Andrew Torrens, a multi-talented performer who revs up this vintage storyline with his energy and enthusiasm. His dramatic skills surface in his

plaintive solo "Somebody Kill Me."

The waitress, Julia, who's uncertain about her impending marriage and gravitates toward Robbie, is beautifully enacted by Hannah Clair, who pours out her hopes and dreams in her number "Someday." Clair and Torrens combine their musical and comedic talents in the duet "Come

Out of the Dumpster."

Nicole Cassesso, the show's producer and the company's executive director, takes a wild turn on stage as the hot-to-trot Holly, who vainly pursues Robbie and headlines a terrific first-act closing number, "Saturday Night in the City."

Julia's erstwhile fiancee, impishly christened Glen Guglia, gets a cool, mercenary interpretation from Lawrence Havelka. The waitress invokes shudders when she imagines herself as "Julia Guglia."

Robbie's backup musicians are enthusiastically rendered by Tim Miller and Peter Crisafulli, the latter leaving no doubt that he prefers his vice versa.

Brianna Garmon has some fine comic moments as Robbie's former fiancée, while Shannon Page and Claire Perry have some fun with older characteriza-

tions.

Wally Huntoon's wide-open setting allows plenty of room for the complicated choreography fashioned by Shauna Bradford, Heather Smith, Alan Collins and stage manager Katie Marshall. These four enrich the overall effect with their swift and smoothly executed movements.

Jon Hyrkas' flashy lighting design electrifies the show, but too frequently illuminates the audience as well, thus producing the opposite of the intended reaction. Larry Watts' costumes hold true to the period of three decades past.

"The Wedding Singer" is an upbeat example of a bygone era of musical theater, rich in interpretation and energy in this robust revival at the Gem Theater.

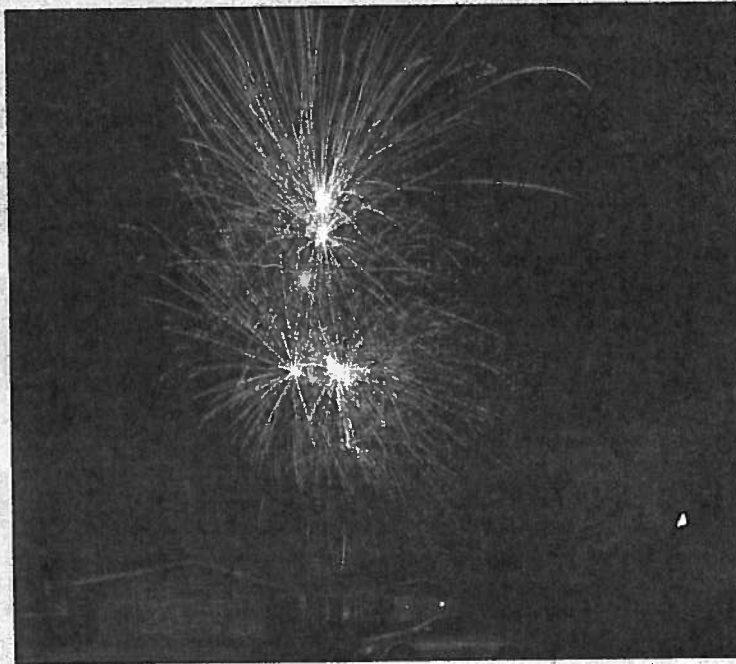

Summertime is swim time at Garden Grove pools

Hundreds of children have fun
while learning water safety

It's summertime, and the temperature is rising outside. What better way to cool off than in a nice big swimming pool?

Garden Grove offers three swimming facilities: the Gary Hall Pool in Eastgate Park, Magnolia Park Pool and the Woodbury Park Pool.

There's recreational swim time and lesson time.

Enjoying some recreational swimming this week were brothers Phyodore, 4, and Phoelyx, 6, who were accompanied by their father, Patrick Lu of Garden Grove.

"This is my first time this year to be at the pool, but the boys have been here before with their mom," said Lu. "The pool is really safe because the lifeguards watch out for the kids and tell them, 'No

running,' and give them proper discipline."

Also enjoying recreational swimming was Xander, 8, whose Westminster grandmother, Sandra Aarvig said she sees that he gets pool time every day so he keeps busy during the summer.

"They always have three or four lifeguards who watch the kids closely and see that the kids follow the rules," said Aarvig. "My grandson loves it here and there are really nice kids here at the pool for him to associate with."

Aarvig said Xander started out by bringing safe pool toys to share with others to make friends.

Two Garden Grove sisters, Faith, 10, and Hope, 8, are taking swimming lessons at the Gary Hall Pool. Asked what they like about the pool, their response was, "This pool has warm water and it's bigger than others we've been to. This is our fourth day of swimming lessons."

The sisters noted that last year they were "Guppies" (level 2 for 6-13 year olds) at the Magnolia Park Pool.

Their mom, Juliet Campbell, said her daughters want people to know that they love going to the Gary Hall Pool because it's so big and that the teachers are friendly, "And let you go to the bathroom

whenever you need to, and they like how the lifeguards say, 'No running,' because it keeps people safe."

Warm water seems to be a big hit at the Gary Hall Pool.

"They also like Eastgate Park because it has a fun playground and basketball court with a lot of room for trees to grow and for kids to run and play," said Campbell. "I would like to say that this is the second year I've enrolled the girls in the Garden Grove Aquatics Summer program because it's the most affordable that I've found at \$50 a class and it's conveniently located."

The girl's teacher, Water Safety

Instructor Melissa Bell, said that private lessons last 40 minutes, where students are taught safe swimming practices and they focus on the basics of swimming skills. Students learn what to do if they fall into a pool and also what steps they should take if someone else needs help in the pool, with the objective of swim lessons to teach safety to children in a fun and positive atmosphere.

Lifeguards take instructional courses to become certified; they need to know First Aid and CPR/AED, among other skills.

Children 6 months and older, plus adults, can take private, semi-private and group lessons.

The lower the age of a child, the lower number of students in the swim classes and swimming is something children will remember for a life time.

The pool is named for Gary Hall, 66, who gained Olympic fame, and also grew up in Garden Grove; he's a former competition swimmer who made it a point to swim every day after his medical classes. He and his son, Gary Jr., formed "The Race Club," swimming club.

Summertime is swim time at Garden Grove pools

Hundreds of children have fun while learning water safety

It's summertime, and the temperature is rising outside. What better way to cool off than in a nice big swimming pool?

Garden Grove offers three swimming facilities: the Gary Hall Pool in Eastgate Park, Magnolia Park Pool and the Woodbury Park Pool.

There's recreational swim time and lesson time.

Enjoying some recreational swimming this week were brothers Phydore, 4, and Phoelyx, 6, who were accompanied by their father, Patrick Lu of Garden Grove.

"This is my first time this year to be at the pool, but the boys have been here before with their mom," said Lu. "The pool is really safe because the lifeguards watch out for the kids and tell them, 'No running,' and give them proper discipline."

Also enjoying recreational swimming was Xander, 8, whose Westminster grandmother, Sandra Aarvig said she sees that he gets pool time every day so he keeps busy during the summer.

"They always have three or four lifeguards who watch the kids closely and see that the kids follow the rules," said Aarvig. "My grandson loves it here and there are really nice kids here at the pool for him to associate with."

Aarvig said Xander started out by bringing safe pool toys to share with others to make friends.

Two Garden Grove sisters, Faith, 10, and Hope, 8, are taking swimming lessons at the Gary Hall Pool. Asked what they like about the pool, their response was, "This pool has warm water and it's bigger than others we've been to. This is our fourth day of swimming lessons."

The sisters noted that last year they were "Guppies" (level 2 for 6-13 year olds) at the Magnolia Park Pool.

Their mom, Juliet Campbell, said her daughters want people to know that they love going to the Gary Hall Pool because it's so big and that the teachers are friendly, "And let you go to the bathroom whenever you need to, and they like how the lifeguards say, 'No running,' because it keeps people safe."

Warm water seems to be a big hit at the Gary Hall Pool.

"They also like Eastgate Park because it has a fun playground and basketball court with a lot of room for trees to grow and for kids to run and play," said Campbell. "I would like to say that this is the second year I've enrolled the girls in the Garden Grove Aquatics Summer program because it's the most affordable that I've found at \$50 a class and it's conveniently located."

The girl's teacher, Water Safety Instructor Melissa Bell, said that private lessons last 40 minutes, where students are taught safe swimming practices and they focus on the basics of swimming skills. Students learn what to do if they fall into a pool and also what steps they should take if someone else needs help in the pool, with the objective of swim lessons to teach safety to children in a fun and positive atmosphere.

Lifeguards take instructional courses to become certified; they need to know First Aid and CPR/AED, among other skills.

Children 6 months and older, plus adults, can take private, semi-private and group lessons. The lower the age of a child, the lower number of students in the swim classes and swimming is something children will remember for a life time.

The pool is named for Gary Hall, 66, who gained Olympic fame, and also grew up in Garden Grove; he's a former competition swimmer who made it a point to swim every day after his medical classes. He and his son, Gary Jr., formed "The Race Club," swimming club.

ORDINANCE NO. 2884

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE ESTABLISHING THE AMOUNT OF MONEY FOR PARAMEDIC SERVICES THAT MUST BE RAISED BY AN AD VALOREM TAX OVERRIDE AND THE SETTING OF THE TAX RATE OF SAID OVERRIDE THE CITY COUNCIL OF THE CITY OF GARDEN GROVE DOES ORDAIN AS FOLLOWS:

SECTION 1: In June 1974, over sixty percent (60%) of the Garden Grove voters approved an ad valorem tax override to provide emergency medical care service (Paramedic Services) to the community and thereby incurring a debt consisting of personnel and equipment payment obligations.

SECTION 2: Property taxes for indebtedness approved by the voters prior to July 1, 1978, are authorized pursuant to Section 93 of the Revenue and Taxation Code.

SECTION 3: The City Council of the City of Garden Grove hereby declares it is necessary to raise an estimated \$9,800,968 through the use of an ad valorem tax override on the taxable property within the City of Garden Grove to maintain and pay for the emergency medical care services. Such indebtedness to be paid includes personnel salaries, training costs, equipment purchases, and maintenance of all equipment acquired previously for paramedic services purpose.

SECTION 4: The tax rate for the authorized ad valorem tax override as approved by voters of all assessable real and personal property for the Fiscal Year 2017-18 shall be 8.0 cents (\$.080) per one-hundred dollars (\$100) of assessed valuation, using as a basis the value of the property as assessed and equalized by the County of Orange, State of California, and shown on the 2017-18 assessment roll of said county.

SECTION 5: This ordinance shall exclude from Section 4 annexations of assessable, real and personal property to the City of Garden Grove after July 1, 1978, indicated by the listing on the attached document designated Exhibit "A".

SECTION 6: Severability. If any section, subsection, subdivision, sentence, clause, phrase, word, or portion of this Ordinance is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance and each section, subsection, subdivision, sentence, clause, phrase, word, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, words, or portions thereof be declared invalid or unconstitutional.

SECTION 7: The Mayor shall sign and the City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same, or the summary thereof, to be published and posted pursuant to the provisions of law and this Ordinance shall take effect thirty (30) days after adoption.

The foregoing Ordinance was passed by the City Council of the City of Garden Grove on the 27th day of June 2017.

On or about July 10, 2017, the City of Garden Grove will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of Community Development Block Grant (CDBG) funds under Title I of the Housing and Community Development Act of 1974 (P.L. 93-383), to undertake a multiyear project in the City's Five Year Consolidated Plan (Fiscal 2017 – Fiscal 2019) known as the Small Business Assistance Loan Program.

The Small Business Assistance Loan Program provides, on a citywide basis, a loan of up to \$25,000 to eligible Garden Grove businesses. Loans have a maximum term of 5 years and an interest rate equal to the current US Prime Rate, plus up to an additional 5%. Loan funds may be used for minor interior/exterior rehabilitation, purchase of equipment, or working capital. The City has budgeted \$100,000 in Fiscal 2017-18 in CDBG funds to assist 4 businesses. Over a three-year period from Fiscal 2017-18 through Fiscal 2019-20, the City estimates the use of \$300,000 in CDBG monies for the Program that will assist approximately 15 businesses. In exchange for the loaned funds, each participating business must create at least 1 full-time employee job for a low-moderate income Garden Grove resident.

The activity proposed is categorically excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act (NEPA) requirements and was published on June 30, 2017. In accordance with Section 58.15, a tiered review process has been structured, whereby some environmental laws and authorities have been reviewed and studied for the intended program listed above. Other applicable environmental laws and authorities will be complied with, when individual projects are ripe for review. Specifically, the Small Business Assistance Loan Program has been studied and found to be in compliance with the following laws and authorities that have been established in this Tier 1 review: Airport Hazards, Clean Air Act, Sole Source Aquifers, Coastal Barriers Resource Act, and Coastal Zone Management Act, Farmlands Protection, Wetlands Protection, Endangered Species, Wild and Scenic Rivers Act of 1968 and Environmental Justice. In the Tiered 2 review, compliance with the following environmental laws and authorities will take place for proposed projects funded under the programs listed above: Historic Preservation, Floodplain Management, Flood Insurance, Contamination and Toxic Substances. Should individual aggregate projects exceed the threshold for categorical exclusion detailed at Section 58.35(a), an Environmental Assessment will be completed and a separate Finding of No Significant Impact and Request for Release of Funds published. An Environmental Review Record (ERR) that documents the environmental determinations for this project is on file at the City of Garden Grove Community and Economic Development Department, Neighborhood Improvement Division at City Hall, 11222 Acacia Parkway, Garden Grove, CA 92840 and the Garden Grove Regional Library, 11200 Stanford Avenue, Garden Grove, CA 92840 and may be examined or copied weekdays 8:00 a.m. to 5:00 p.m.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the City of Garden Grove Community and Economic Development Department. All comments received by July 7, 2017, will be considered by the City of Garden Grove prior to authorizing submission of a request for release of funds.

ENVIRONMENTAL CERTIFICATION

The City of Garden Grove certifies to HUD that Allison Wilson, in her capacity as Certifying Officer consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Garden Grove to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of Garden Grove's certification for a period of 15 days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Garden Grove; (b) the City of Garden Grove has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Section 58.76) and shall be addressed to HUD Office of Community Planning and Development, 300 N. Los Angeles Street, Suite 4054, Los Angeles, California 90012. Potential objectors should contact HUD to verify the actual last day of the objection period.

“Fill the Boot” fundraiser raises thousands for cause

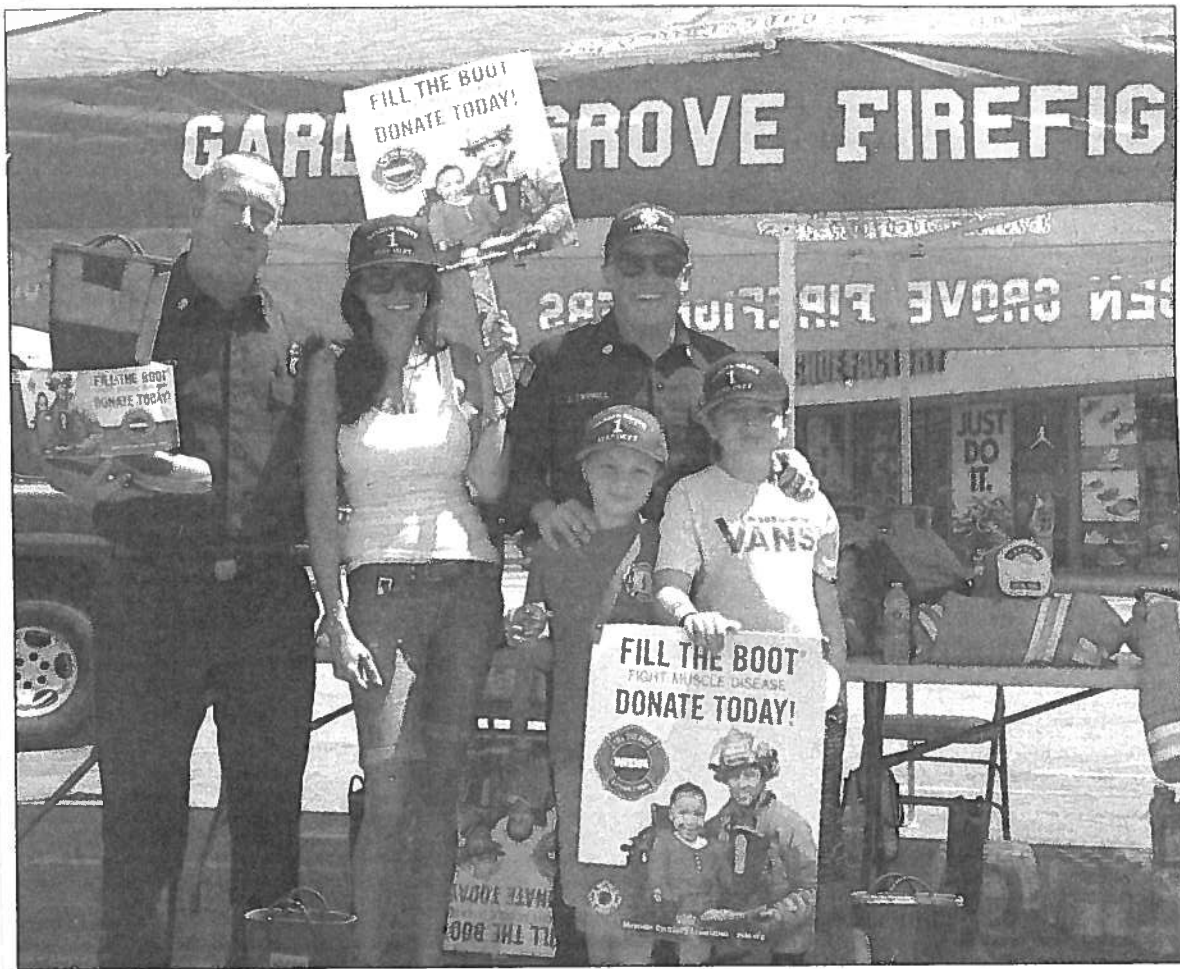

About 25 Garden Grove firefighters from Local No. 2005 walked in the crosswalks and worked the crowds of drivers at Harbor Boulevard and Chapman Avenue Saturday to "Fill the Boot" with money, an annual fundraiser for the Muscular Dystrophy Association.

After four hours, they donated nearly \$7,000 to MDA Area Director Liz Denny.

Battalion Chief Tustin Truhill's son Gavin, 10, has been affected by MD and has been helped by the Association. He was on site Saturday to help hand out junior firefighter stickers to children whose parents donated to the cause, along with carrying a donation sign on the sidewalk with his brother, Cooper, 9.

"I like to teach my sons the gift of community service and helping non-profits."

Capt. Steve Fellner said he's been helping for the 17 years he's been with the Garden Grove Fire Department. The department started the project in 1954.

"It's through the generosity of drivers that we can do this," said Fellner. "One person donated two, \$100 bills and some donate the change from their ashtray and we get tons of \$5 bills."

"This fundraiser is a humbling experience," said Denny.

"People give who don't have a lot of money and from my position, I'm proud to walk for MDA because they're committed to finding a cure and helping

MOSQUITO INFECTED WITH WEST NILE VIRUS FOUND IN GARDEN GROVE

The Orange County Mosquito and Vector Control District (OCMVCD) has confirmed and informed Garden Grove City officials of the first mosquito sample infected with the West Nile virus (WNV) in Garden Grove. The mosquitoes were collected in mosquito traps at the West Street Basin, in the vicinity of West Street and Chapman Avenue.

OCMVCD inspectors will be closely monitoring the area for any additional findings. District teams will be posting public health advisories in the area and alerting residents to the detection of WNV, and offering information on preventative measures against mosquitoes and WNV.

The City of Garden Grove encourages the community to take extra steps to protect themselves from mosquitoes, especially from dawn to dusk when mosquitoes are most active.

According to the OCMVCD, the first mosquito sample to test positive for WNV in Orange County this year, was on June 15, in the city of La Habra.

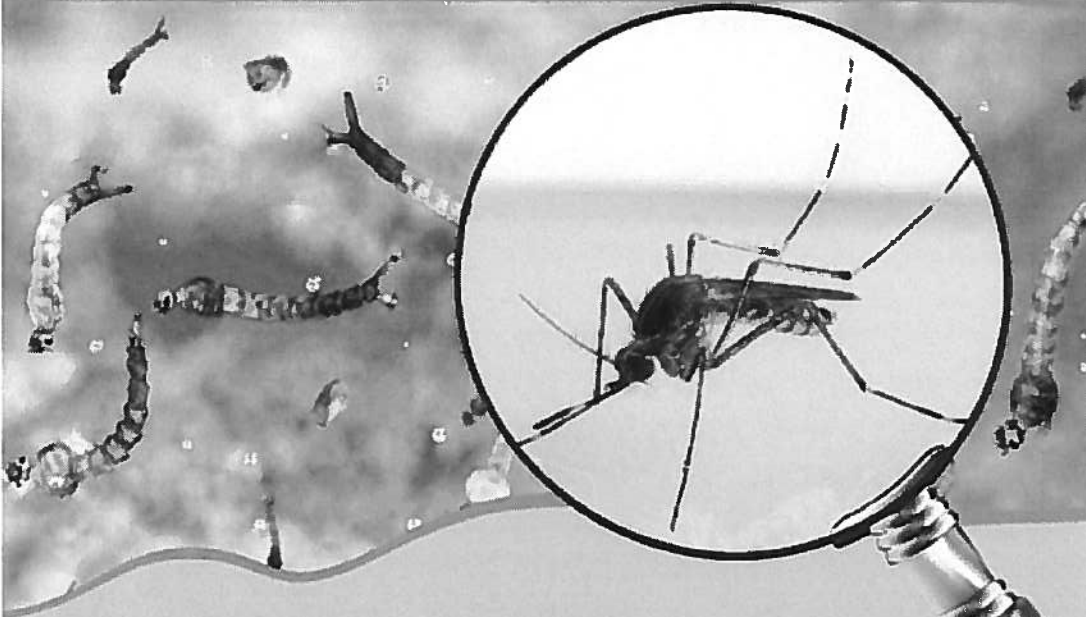

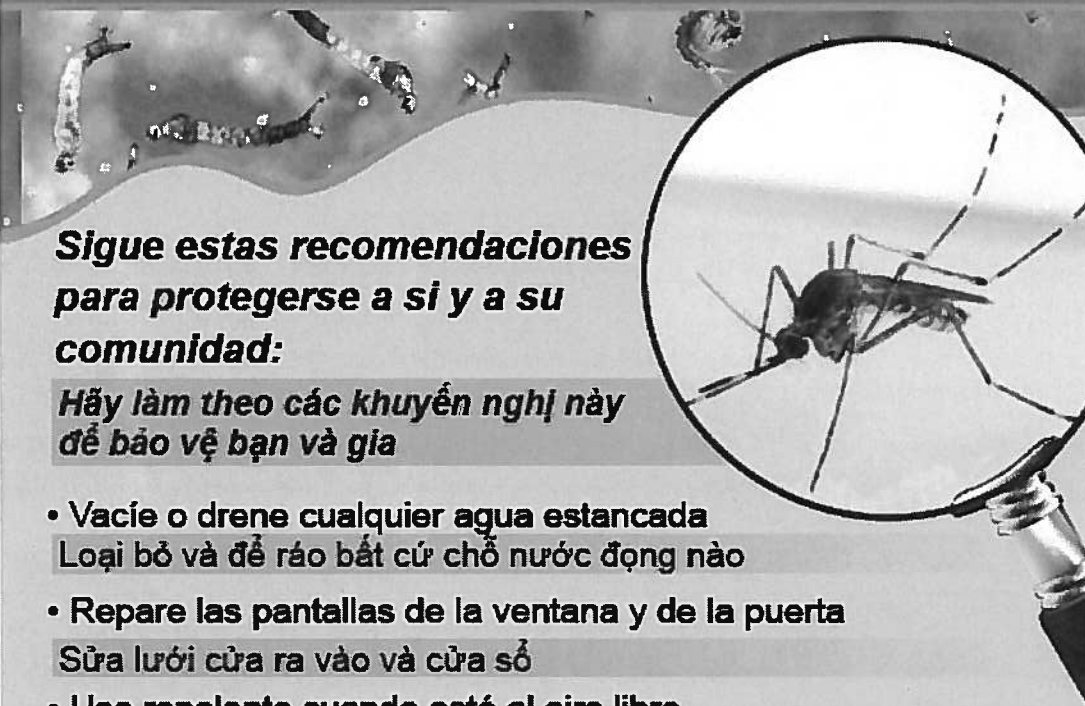

CITY OFFERING FIRST-TIME HOME BUYER AND HOME IMPROVEMENT PROGRAMS

The City of Garden Grove is offering First-Time Homebuyer and Home Improvement programs for manufactured housing in Garden Grove until October 1, 2017. The program is funded by CalHOME through the California Department of Housing and Community Development.

The First Time Homebuyer program assists low-income applicants purchasing their first home. In order to qualify for the program, the applicant cannot have owned a home in the past three years and must: purchase a manufactured home in Garden Grove; occupy the manufactured home throughout the life of the loan; attend a Department of Housing and Urban Development (HUD) approved Homebuyer Education Program; occupy the manufactured home throughout the life of the loan; and meet the program income requirements. The home purchase price cannot exceed \$120,000.

The City is also offering six, free, 8-hour, HUD approved, homebuyer workshops for anyone interested in the First Time Homebuyer program.

The applicant must occupy the manufactured home throughout the life of the loan and meet current income requirements. All repair/rehabilitation work must meet Garden Grove Municipal Code and Uniform Building Code standards. At a minimum, imminent health and safety hazards must be eliminated, as determined by the sole discretion of the City.

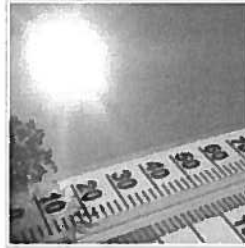

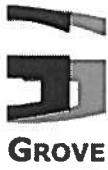

SMOKE ADVISORY

Issued Thursday, June 29, 2017

This advisory is in effect through Friday morning. SCAQMD will issue an update if additional information becomes available.

A brush fire, named the Christianitos Fire, is burning in San Diego County, at Camp Pendleton. The burn area was estimated this morning to be 700 acres with 10 percent containment. Winds are southerly this morning, bringing smoke mainly into Orange County and portions of Los Angeles, Riverside and San Bernardino Counties at times. Smoke impacts in the South Coast Air Basin are expected to improve as the sea-breeze increases from the west by late morning. Air quality may reach Unhealthy levels in areas directly impacted by smoke.

In any area impacted by smoke: Everyone should avoid any vigorous outdoor or indoor exertion; people with respiratory or heart disease, older adults, and children should remain indoors. Keep windows and doors closed or seek alternate shelter. Run your air conditioner if you have one and keep the fresh air intake closed and the filter clean to prevent bringing additional smoke inside. Avoid using a swamp cooler or whole-house fan to prevent bringing additional smoke inside. To avoid worsening the health effects of smoke, don't use indoor or outdoor wood-burning appliances, including fireplaces.

**Assembly Local Government Committee Passes Bill that Limits Local Discretion,

League-Sponsored Housing Bill Passes First Assembly Committee
SB 540 Now Moves to Assembly Natural Resources Committee

The Assembly Local Government Committee on June 28 unanimously passed League-sponsored SB 540 (Roth). This bill would provide a way to streamline the housing approval process and leads to more housing production, particularly in areas near jobs and transit. Importantly, SB 540 protects public input and environmental review while providing certainty to the development community. *For more, see Page 2.*



Legislature Considers Short-Term Changes to Bottle Bill Program

While the Legislature passed the FY 2017-18 budget several weeks ago, a number of budget-related issues remain under consideration by the Legislature and Gov. Jerry Brown. One of these issues is the California Beverage Container Recycling Program or “Bottle Bill” program. SB 102 (Budget and Fiscal Review Committee) contains a trailer bill proposal to offer short-term stabilization to this program, while a longer term solution can be negotiated. *For more, see Page 3.*

This measure would give wireless providers unfettered ability to install bulky cellular equipment on any street light or traffic light and even many public libraries, schools and other public buildings without permission from local governments, input from the public or fair compensation for city and county residents. The industry already has broad ability to use readily available public and private utility poles to attach their equipment.

This bill silences local voices and will cost taxpayers around the state tens of millions of dollars. SB 649 is a giveaway from Sacramento to the industry without requiring that the industry deliver any meaningful public benefits such as free Wi-Fi in public parks or network access for public safety first responders.

Mayor Liccardo testified on behalf of the city of San José and the over 175 cities opposed to SB 649 Wednesday afternoon. He began his testimony by reminding the committee of the letter sent by the mayors of six of California's largest cities who all oppose the measure. He focused his remarks on how SB 649 would have tax payers subsidize the wireless industry.

Also joining Mayor Liccardo were city officials from a number of other cities including:

- American Canyon Community Development Director Brent Cooper;
- Concord Mayor Laura Hoffmeister;
- Culver City Council Member Meghan Sahli-Wells;
- San Marcos Council Member Kristal Jabara;
- Vallejo Assistant City Manager Teri Kilgore; and
- West Hollywood Council Member Lindsey Horvath.

Representatives from dozens of other cities also testified in opposition to SB 649, along with the California State Association of Counties, the Rural Counties Representatives of California and the Urban Counties of California and representatives of dozens of counties.

Next Steps

SB 649 now moves to the Assembly Communications and Conveyance Committee.

Local officials are taking seriously their role in solving the housing crisis. SB 540 would give local governments new tools to plan for housing and create a more streamlined path that eliminates some of the delays and uncertainty that currently impede housing construction.

During his testimony, Sen. Richard Roth (D-Riverside) remarked that, "Access to housing is a basic human need, and ensuring Californians have access to an affordable place to live is critical to every Californian's quality of life. That's why I am proud to have authored Senate Bill 540, which will incentivize and streamline housing construction to meet our state's dire housing shortage. I thank the committee for recognizing the critical need for this measure, and look forward to sending this measure to the Governor for his signature."

Specifically, under SB 540 cities and counties would identify priority housing areas — called Workforce Housing Zones — within their boundaries. The local government would conduct enhanced planning, important environmental reviews and public engagement at the front end with specific details as to what type of housing would be built within the zone. Because the local government has fully conducted the extensive environmental reviews at the front-end, no project-specific additional environmental reviews would be necessary.

Sen. Roth continued that “SB 540 is a commonsense measure that will remove the barriers to housing construction in the areas most in need, helping ensure this crisis does not continue to grow and families do not continue to struggle.”

By some estimates, SB 540 would shave one to two years off the development timeline without compromising environmental protection, public health, local control or the rights of citizens to participate in local land use decisions.

Next Steps

The Assembly Natural Resources Committee will be the next stop for SB 540.

'Bottle Bill' Continued from Page 1...

As noted by a recent analysis by the Senate Budget and Fiscal Review Committee, over the past 18 months, 560 recycling centers in California have closed due to the lower commodities prices worldwide and an 11 percent reduction in state payments. This has resulted in a recycling rate of below 80 percent for the first time since 2008. During the last six months of 2016, 1.6 million more containers per day were taken to landfills compared to the same period in 2015.

The Legislature, the Administration, and other stakeholders continue to negotiate the proposed short-term solution. Details of the current proposal are as follows:

- Redefine “convenience zone” to 1 mile radius of supermarket;
- Narrow grocer obligation: limit in-store take-back to 24 containers, only applies to dealers with sales of \$2 million or more;
- Adjust processing payments & handling fees to reflect 2015 cost of recycling with COLA;
- Freeze calculations of recycling costs until Jan. 1, 2019 and redirects these funds for these calculations to unserved zones;
- Makes an entity eligible for handling fees that establishes a recycling in an unserved area that operates at least 30 hours per week;
- Up to \$3 million in supplemental handling fees for underserved/rural areas until July 1, 2020; and
- Extend sunset date on plastic market development program to Jan. 1, 2019.

League-Sponsored Bond Agency Issues \$96.1 Million in Tax-Exempt Bonds for Community Hospital in Monterey

Some of the most significant benefits of League membership for cities since 1988 have flowed from the League's co-sponsorship of the California Statewide Communities Development Authority (CSCDA).

This program provides a variety of public agencies and developers access to low-cost, tax-exempt financing and economic development tools. CSCDA recently issued a total of \$96,100,000 in tax-exempt bonds for Community Hospital of the Monterey Peninsula, in Monterey.

About Community Hospital of the Monterey Peninsula (CHOMP)

CHOMP, a California nonprofit public benefit corporation, owns and operates a 258 licensed-bed acute care hospital located in the Carmel Hill area of the Monterey Peninsula. CHOMP also owns and operates Westland House, a 28-bed skilled nursing and hospice facility, and an outpatient hospice facility located in Monterey and provides outpatient healthcare services at various outpatient facilities throughout Monterey County. CHOMP is the market leader for acute care services in its Primary Service Area, identified as the Monterey Peninsula, which includes the communities of Seaside, Monterey, Carmel Valley, Pacific Grove, Marina, Pebble Beach, Sand City, Del Rey Oaks, Big Sur, and unincorporated areas of Monterey County located on the peninsula.

CSCDA partnered with Piper Jaffray to place the \$96,100,000 in tax-exempt bonds for CHOMP. The bonds will be used to finance the cost of implementing an electronic medical records system as well as refinance CSCDA's previously issued Series 2011B Bonds.

Background

CSCDA is a joint powers authority created in 1988 and is sponsored by the League of California Cities® and the California State Association of Counties. It was created by cities and counties for cities and counties. More than 500 cities, counties and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently finance locally-approved projects. League Board Votes to Support SB 231

The League of California Cities[®] board of directors voted over the weekend to support SB 231 by Sen. Bob Hertzberg (D-Van Nuys), which would add storm water to the definition of "sewer" in the Proposition 218 Omnibus Implementation Act. The League undertook an extensive deliberative process to consider weighing in on SB 231, including multiple discussions over several months. Between March and June, two of the League's policy committees considered this bill: the Environmental Quality and Transportation, Communications & Public Works policy committees. This process culminated in recommendations to support by substantial majorities of both policy committees and a vote by the League's board of directors to support the bill last week. *For more, see Page 2.*

SB 1 provides new Road Maintenance and Rehabilitation Account (RMRA) formula funds for cities and counties to address road maintenance, rehabilitation, and critical safety needs on local streets and roads. In order to be eligible to receive RMRA funds, cities and counties must report projects they are funding with RMRA to CTC by Sept. 15.

The League of California Cities[®] and California State Association of Counties have been working with the CTC to draft these guidelines. The purpose of the guidelines is to describe RMRA reporting requirements and procedures for cities and counties. The guidelines also address the roles and responsibilities of the CTC and the State Controller in carrying out the statutory objectives of SB 1 related to RMRA formula funding for local streets and roads.

As storm water washes down city roads, parking lots, lawns and buildings it picks up major pollutants including sediment, oil and grease, metals and other toxins. State and federal clean water laws combine to require cities, counties, and other local governments that own storm water systems to reduce the level of pollutants discharged. This is established under the National Pollutant Discharge Elimination System (NPDES) and California's Municipal Separate Storm Sewer Systems (MS4s) permitting program.

Compliance with the state and federal requirements is costly, with local governments facing annual funding shortfalls. In 2015, the Public Policy Institute of California (PPIC) estimated the funding gap at approximately \$500-800 million annually. Failure to comply with state and federal requirements can result in fines of up to \$10,000 per contaminant per day. However, options available for cities to pay for such clean-up efforts are limited. SB 231 provides a needed tool to assist cities in complying with federal and state storm water requirements.

There is a recognized potential for litigation on the meaning of "sewer" and the League recognizes that an important function of the court is to interpret law. Should this issue come before a court, this bill offers the Legislature the opportunity to further clarify the meaning of the term "sewer".

SB 231 will next be heard on the Assembly floor.

**SB 540, Legislation by Senator Roth to Increase Housing Production, Passes
Assembly Natural Resources Committee**

*Bill part of League of California Cities Supported "Blueprint for Housing"
Legislative Package*

Monday afternoon, SB 540 by Sen. Richard D. Roth (D-Riverside) passed the Assembly Natural Resources Committee on a bipartisan vote. Sponsored by the League of California Cities®, SB 540 would streamline the housing approval process and lead to more housing production, particularly in areas near jobs and transit. SB 540 previously passed the Senate with overwhelming bipartisan support. It now will be heard in the Assembly Committee on Appropriations. *For more, see Page 2.*



New Cap-and-Trade Extension Plan Introduced

Vote Expected as Early as Thursday

Gov. Jerry Brown, Senate President Pro Tem Kevin de Leon (D-Los Angeles) and Assembly Speaker Anthony Rendon (D-Lakewood) on July 10 announced a new Cap-and-Trade extension plan and accompanying air quality program. The proposal was introduced in bill form late Monday. The two-bill package compares AB 398 by Assembly Member Eduardo Garcia (D-Coachella), which sets forth the extension plan, and AB 617 by Assembly Members Cristina Garcia (D-Bell Gardens), Eduardo Garcia (D-Coachella) and Miguel Santiago (D-Los Angeles), which would create the new air quality monitoring program. Sen. Roth commented, "Access to housing is a basic human need, and ensuring Californians have access to an affordable place to live is critical to every Californian's quality of life. That's why I am proud to have authored Senate Bill 540. SB 540 is a commonsense measure that will remove the barriers to housing construction in the areas most in need, helping ensure this crisis does not continue to grow and families do not continue to struggle."

Under SB 540 cities and counties would identify priority housing areas — called Workforce Housing Zones — within their boundaries. The local government would conduct enhanced planning, important environmental reviews and public engagement at the front end with specific details as to what type of housing would be built within the zone. Because the local government has fully conducted the extensive environmental reviews at the front-end, no project-specific additional environmental reviews would be necessary.

By some estimates, SB 540 would shave one to two years off the development timeline without compromising environmental protection, public health, local control or the rights of citizens to participate in local land use decisions.

Carolyn Coleman, executive director of the League of California Cities said, "SB 540 would give local governments new tools to plan for housing and create a more streamlined path that eliminates some of the delays and uncertainty that currently impede housing construction. Cities recognize our role in crafting solutions to our housing crisis. We're pleased to partner with Senator Roth on this important legislation."

The League also supports SB 2 (Atkins), the Building Homes and Jobs Act, and SB 3 (Beall), the Affordable Housing Bond Act of 2018. Both bills would increase funding for affordable housing to boost housing supply.

This announcement comes following weeks of discussion between the Administration, legislative leaders, and stakeholders from industry, business, environmental, agricultural labor, faith, economists, and local government. Lawmakers and stakeholders continue to weigh in with the language in print.

In addition to extending the Cap-and-Trade program through 2030, AB 398 would establish funding priorities for how the state would spend auction revenues over the next decade from the 40 percent share of proceeds that have been previously subject to annual allocations.

Details of both measures are outlined below.

The Cap-and-Trade extension plan in AB 398 would:

- Extend the cap and trade system through Dec. 31, 2030 with declining emissions limits;
- Require State Air Resources Board (ARB) to set cost containment measures, including a price ceiling, "speed bumps" to limit excessive price spike, offset credit limits, and industry assistance factors for allowance allocation;
- Establish a Compliance Offsets Protocol Task Force to advise the ARB on establishing new offset projects that have direct environmental benefits, while prioritizing disadvantaged communities, Native American or tribal lands, and rural and agricultural regions;
- Establish an Independent Emissions Market Advisory Committee to report to the ARB and the Legislature on the environmental and economic performance of Cap-and-Trade;
- Require the California Workforce Development Board to report on the need for increased education and job training to help transition labor-market changes;
- Require the ARB to update the Scoping Plan by Jan. 1, 2018;
- Establish funding priorities until Jan. 1, 2031 as follows:
 - air toxic and criteria pollutants from stationary and mobile sources;
 - low and zero-carbon transportation;

- sustainable agricultural practices that promote the transitions to clean technology, water efficiency, and improved air quality; healthy forests and urban greening;
- short-lived climate pollutants (such as methane); and
- climate adaptation and resiliency; climate and clean energy research.
- Prohibit local air districts from adopting additional emissions reduction rules from stationary sources that are subject to Cap-and-Trade;
- Suspend the existing fire prevention fees that apply to rural landowners until Jan. 1, 2031; and
- Extend an exemption from the state portions of sales and use taxes for certain purchases of property used for generation of electric power until July 1, 2030, but does not affect the collection of local shares of city and county sales and use taxes

The new air quality program as proposed in AB 617 would:

- Require stationary sources to report annually emissions of criteria air pollutants and toxic air contaminants; require the ARB to develop a new air monitoring plan and determine high priority locations to deploy community level air monitoring systems; authorize the local air district in selected locations to require stationary sources to deploy fence-line monitoring systems;
- Require the ARB to prepare a statewide strategy to reduce air emissions in communities with a high cumulative exposure burden and update the strategy every five years;
- Requires local air districts that have not attained air pollutant goals under the federal Clean Air Act to expedite retrofits of industrial sources; and
- Increases the penalty for air pollution violations from \$1,000 per day to \$5,000 per day and increases the maximum penalty annually based on the Consumer Price Index

Next Steps

Given the 72-hour print rule, the expected date for a vote for this package is Thursday. Many of the affected groups and organizations continue to review the language. It remains unclear if this proposal, absent changes, will garner the bi-partisan, two-thirds vote support desired by the Governor. Also unclear is if other legislative issues are part of the overall agreement. For instance, several legislators requested the passage of a major housing package, including funding and process streamlining measures, in conjunction with the cap and trade extension. Whether these of other conditions are attached to the package remains to be seen.
