**OBJECTIVE**

The purpose of this memorandum is to provide updated information on Temporary Outdoor Business permits, as a part of the City's Accessible Businesses Program.

**BACKGROUND**

In March 2020, the Community and Economic Development Department (CEDD) created the Accessible Eateries Program for restaurants to allow seating on a temporary basis in outdoor locations. By July 2020, the Accessible Eateries Program was expanded to the Accessible Businesses Program, to include retail and service-type businesses. Also in July, businesses on Main Street were afforded the option to create temporary "parklets," in the on-street parking spaces in front of their tenant space.

**DISCUSSION**

Since July, all restaurant, retail, and service-type businesses in the City can apply for a temporary outdoor business location. The application for a Temporary Outdoor Business Permit can be found on the City's website at: <https://ggcity.org/businesses>.

As of Wednesday, October 28, a total of 98 businesses have received a Temporary Outdoor Business Permit. An additional six businesses have inquired about the application process, but have yet to receive a permit. A further breakdown of permits that have been issued to date can be found in **Attachment A**.

It is a no-fee permit, valid for 60 days, but can be renewed for additional 60-day periods. CEDD is currently evaluating possible alternatives and continuation of the temporary outdoor business program, if and when state of emergency respective to the COVID-19 pandemic is lifted.

The Code Enforcement team has been instrumental in conducting business outreach to promote the Accessible Businesses Program. In particular, this collaboration has been helpful to remind many active businesses to renew their expired permits.

Implementation of the Accessible Businesses Program continues to be a quick and flexible way to encourage Garden Grove businesses to modify operations during COVID-19. ## FILING INSTRUCTIONS FOR TEMPORARY OUTDOOR BUSINESS APPLICATION



The following instructions are intended to provide the necessary information for processing your Temporary Outdoor Business Permit Application in the quickest manner possible. Please note that the Applicant must submit the completed application and all required materials as described in this application to the Planning Division at City Hall, located at 11222 Acacia Parkway, Garden Grove, CA 92840. Email submittals will also be accepted, at [planning@ggcity.org](mailto:planning@ggcity.org).

Once approved, a Temporary Outdoor Business Permit is in effect for 60 days. This period may be renewed upon approval of a request to the Planning Division, and in accordance with all applicable State and local health orders. If you have any questions regarding this application and the submittal requirements, please contact the Planning Division at (714) 741-5312.

## SUBMITTAL REQUIREMENTS

Please submit the following plans and information to obtain a Temporary Outdoor Business Permit:

- 1 A completed Temporary Outdoor Business Application with property owner authorization. A letter from the property owner may substitute for a signature on the application.
- 2 A legible business area layout that includes basic dimensions, path of travel/exiting, and furnishings legend (minimum 8.5" x 11" size). Please refer to the Site Plan and Business Layout Design Checklist in the Temporary Outdoor Business Application.
- 3 A detailed Operational Plan. A sample form is provided as an attachment to the Temporary Outdoor Business Application.
- 4 A completed Encroachment Permit Application, if outdoor seating is proposed on City-owned right-of-way. A copy of the Encroachment Permit Application can be obtained from the Planning Services Division. For questions regarding the submittal requirements should be directed to the Public Works Department, Engineering Division at (714) 741- 5887 for the Encroachment Permit Application and submittal requirements.

Animal owners currently under evacuation warning (voluntary) or evacuation order (mandatory) are strongly encouraged to evacuate with their pets as the emergency may prevent resources from entering impacted areas to assist with animals due to safety concerns.

Animal owners with disabilities, access or functional needs can call OC Animal Care at (714) 935-6848 (8:00 a.m. to 5:00 p.m.) and (714) 935-7158 (5:00 p.m. to 8:00 a.m.) or dial 911 for assistance.

Large animal owners under an evacuation warning (voluntary) order are encouraged to implement their personal evacuation plans. Horse owners who would like to evacuate their horses as a precaution may enter through the roadblock at Santiago and Live Oak near Cook's Corner. This is the only location allowing residents through.

Large animal owners under an evacuation order (mandatory) are directed to take their animals to OC Fair and Events Center at 905 Arlington Drive, Costa Mesa. Please call 714-708-1500 for more information. Please note that horse and livestock owners will need to provide care for their animals if taken there. Shavings will be provided, but all other items such as food, medications, etc. will be the owner's responsibility.

**NOTICE OF EXPEDITED APPLICATION**  
**Southern California Edison Company's Request to Increase Electric Rates**  
**APPLICATION A.20-10-007**

**Why am I receiving this notice?**

On October 9, 2020, Southern California Edison Company (SCE) filed its expedited application regarding Power Charge Indifference Adjustment (PCIA) Trigger (A.20-10-007) with the California Public Utilities Commission (CPUC). The application requests authority to increase the PCIA rate for departing load customers<sup>1</sup> to recover an approximate \$68.645 million undercollection, and simultaneously credit that amount to SCE's bundled service customers<sup>2</sup> who paid the undercollection.

If the CPUC approves this application, SCE will recover the increase in electric rates from departing load customers over a one-year period beginning in the first quarter of 2021. Departing load customers will see an increase in their monthly bill and bundled service customers will see a decrease in their monthly bill.

**Why is SCE requesting this rate increase?**

Both SCE's departing load and bundled service customers pay the PCIA rate.

- In 2020, the PCIA rate was capped for departing load customers, meaning departing load customers paid less than their actual PCIA rate.
- The CPUC required that bundled service customer rates be increased to recover the amount of revenue that SCE could not recover from departing load customers.
- The amount owed by departing load customers has reached a level that requires SCE to seek a rate change so that this balance does not continue to grow. If approved, this will result in an increase to departing load customer rates and a corresponding decrease to bundled service customer rates.

**How could this affect my monthly electric rates?**

If SCE's rate request is approved by the CPUC, the average residential monthly PCIA charge for departing load customers using 500 kWh per month would increase by approximately \$1.50-\$6.00 or 15%-55% per month in 2021, depending on when the customer departed from SCE's bundled service.

**How does the rest of this process work?**

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SCE's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding are currently reviewing SCE's application, including the Public Advocates Office, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. # 72nd Assembly District hopefuls tackle issues

By Jeannette Andruss

The race for California's 72nd Assembly District features Democrat Diedre Nguyen, a current Garden Grove Councilwoman, against Republican Janet Nguyen, a former state senator and former Orange County Supervisor.

The district covers Seal Beach, Rossmore, Los Alamitos, Westminster, Fountain Valley and parts of Garden Grove and Huntington Beach.

The candidates answered these questions from The Sun via email and were each given equal space to respond.

The COVID-19 pandemic and resulting economic crisis is arguably the biggest challenge facing Californians right now. What policies or funding would you support to stop the spread of the coronavirus, safely reopen schools and get businesses back on track?

Janet Nguyen:

"COVID-19 has devastated our community. We need to help small-businesses recover and get people working again while following health guidelines. We need to repeal AB5, the job-killing bill that made many independent jobs illegal when the pandemic was already costing so thousands of jobs.

I am the mother of two elementary aged children that attend public schools. As a working mom, I understand how difficult it has been for parents to give our children an education while working full time. It's time to get our schools the resources they need to make our schools a safe learning environment."

Diedre Nguyen:

"As a city councilmember in Garden Grove, I have worked with our small businesses to keep them afloat and preserve jobs, including zero interest loans, grants, and accelerated permitting for outdoor business. We've also offered rental assistance to keep people in their

homes. I will apply the lessons from this work to statewide efforts. As a cancer scientist, I believe in strong leadership that requires masks, social distancing, a safe process for vaccine development, and funding to make testing free and available to everyone. If we can more effectively contain the virus, we can start to get our lives back."

What do you think is the #1 issue for constituents in the district and how would you address it if elected?

Janet Nguyen:

"Our number one issue is the COVID-19 pandemic and how it has impacted our businesses, families and schools. Prioritizing public health while making sure we reopen our economy is the most important thing right now. People are suffering and the possibility of losing their homes and businesses are real. Small businesses are closing permanently, the number of homeless are increasing and workers who have lost their jobs are having trouble getting unemployment benefits. These will be my number one focus in the State Assembly."

Diedre Nguyen:

"COVID-19. It will dominate everything until we can get it under control with a vaccine and smart social interactions. Aside from the health concerns, re-opening schools and getting our economy back on track are the two most major hurdles we face. Both can be made significantly more stable if we implement better testing, contact tracing, and isolation protocols



that require more federal and state resources. I will urge the president and congress to fund these types of programs as well as increased unemployment payments, rental & homeowner assistance, and a large public infrastructure building program."

The 72nd Assembly district covers several cities with a diverse population. According to the OC Registrar's office, roughly 30% of registered voters in the district are No Party Preference voters or affiliated with smaller parties. How do you appeal to voters who aren't Democrats or Republicans?

Janet Nguyen:

"This office isn't about partisan politics, it's about being a representative. That's what the public wants right now, they want ramento. I will always be focused on serving our community. When I served as State Senator, my office worked tirelessly to make sure we responded to constituent needs, and I was engaged with our local businesses when they had problems. I secured funding for our local schools, hosted multiple annual free events including the health expo, free flu shots and even provided free tax preparation. I'm committed to serving the community."

Diedre Nguyen:

"I am a Democrat, but I am an American and a Californian first. I will be a leader for everyone. As a scientist, I find good judgments are best made by considering the facts and following the evidence. On the city council I have a reputation for working with everyone and bringing people together to solve problems. That's how I'll lead in the State Assembly."

Janet Nguyen:

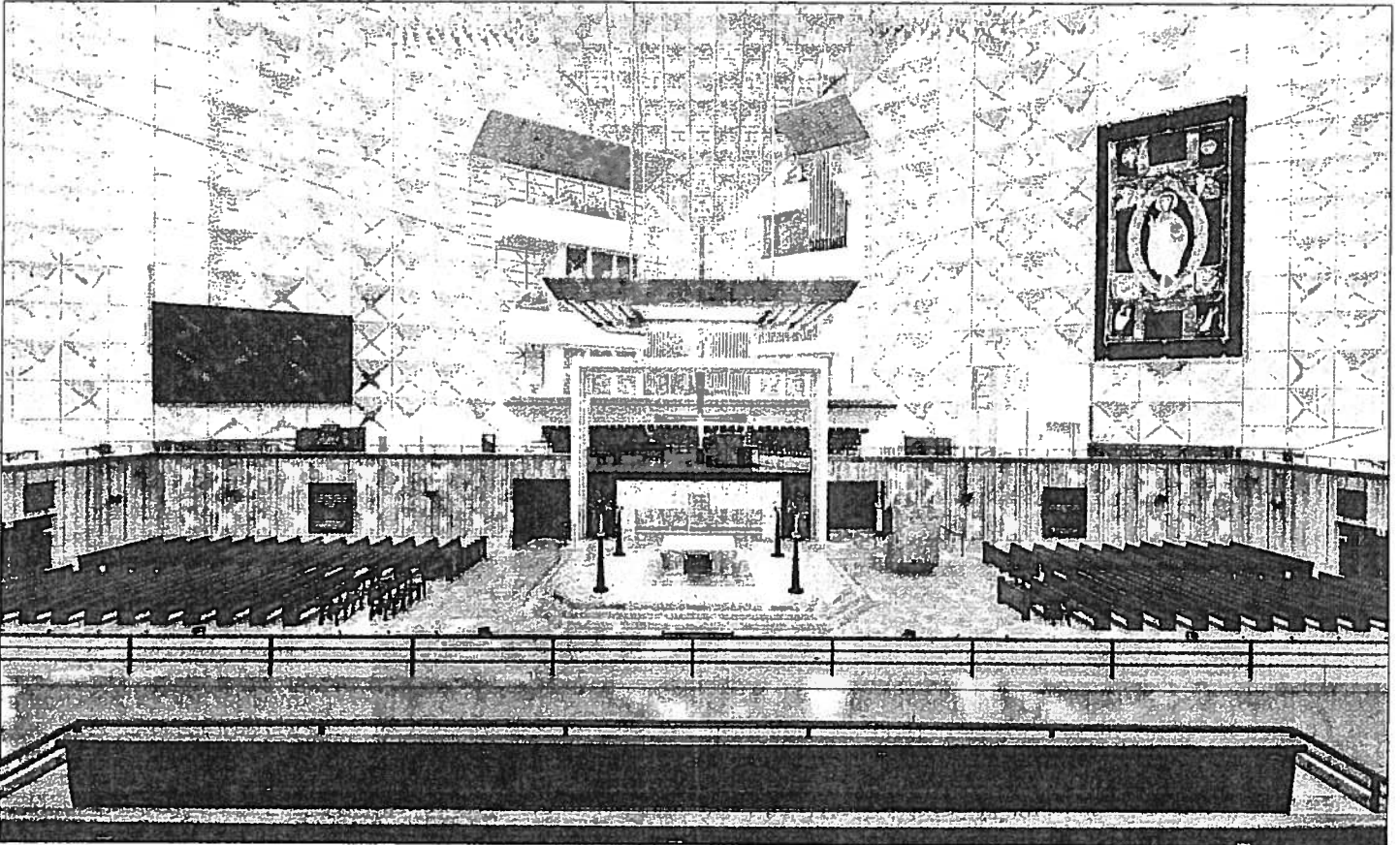
Anything else you think is important for voters to know.

## Christ Cathedral wins Beyond LA Category at big event

Christ Cathedral in Garden Grove recently won a prestigious architectural award at the 50th Anniversary Architecture Awards hosted by the LA Business Council.

Christ Cathedral was selected from a pool of hundreds of submissions to win the Beyond LA Category.

Epitomizing this year's emphasis on inclusive design, the grand prize was awarded to the South Park Historic East Area Renovation in downtown Los Angeles,

which transformed a once-blighted park in a historically underserved community into a welcoming greenspace that fosters well-being by giving residents a safe place to relax, exercise and play.

"Urban design is a vehicle for equity and a vital way for government to serve as a force for good in the life of our neighborhoods," said Mayor Eric Garcetti. "The real winners of this award are the Angelenos living across the South Park Historic East

Area – the families, friends, and households with a new community space that will lift up the quality of people's lives, improve public safety, and promote a healthier future."

A municipal design team led by the L.A. Department of Water and Power and the city's Bureau of Engineering's Architectural Division bested some of the most notable designers and architects in the world to win the grand prize for the park

renovation. Their efforts transformed a grassless, dormant park into an expansive greenspace, framed by winding paths and towering palm trees that is inviting to the community for healthy recreation, gatherings, and quiet reflection. The park is dedicated to the late R&B singer Barry White, who grew up nearby.

The win distinguished itself as the first time in the awards' long history that a landscape or park design has received top honors.

Overall, 23 winners emerged from an esteemed pool of hundreds of submissions in categories ranging from civic buildings to education to sustainability. Jurors comprised industry experts, including architects, construction firms, owners, and developers.

"In a difficult year that has challenged many of us to rethink the enormous value of safe public spaces, the winners of this year's Architectural Awards set a new standard for how inspired urban design can uplift life in our city," said Mary Leslie, president of the Los Angeles Business Council. "These projects are outstanding examples of how good design can play a vital role in including often-excluded communities, and advancing social,

cultural and economic equality in our society."

The Los Angeles LGBT Center, which opened last year, received the illustrious LABC Chairman's Award. The 2-acre Anita May Rosenstein Campus launched as the world's first intergenerational facility serving LGBT seniors and youth. The 180,000-square-foot, state-of-the-art facility in Hollywood includes more than 100 beds for homeless youth, a senior community center, a youth drop-in center and space for social services.

"This project sends a clear message that Los Angeles is better when we look out for our neighbors," said Nadine Watt, LABC chair and president of Watt Companies. "At the campus, youth and seniors will live together, learn from each other, and help one another in a safe environment surrounded by support services."

The Lucas Museum of Narrative Art, an architectural tour de force under construction in Exposition Park, won the Community Impact Award. Accepting the award on behalf of the Lucas team was Sandra Jackson-Dumont, director and CEO of the Lucas Museum of Narrative Art. The museum is designed by former LABC Architectural Award keynote speaker and winner Ma Yansong of Mad Architects. The Lucas museum is committed to hiring a diverse

and local workforce, sourcing and hiring local, minority, and women-owned businesses. More than 70 percent of construction workers on the project live in L.A. County.

Thom Mayne, founding partner of Morphosis, received the Legacy Award. Founded in 1972, the firm has been recognized for its imaginative and sustainable designs for cultural, civic and academic institutions. Mayne's many design recognitions in-

clude the prestigious Pritzker Prize and AIA Gold Medal.

Due to the Covid-19 pandemic, the LABC hosted the event as its first virtual award ceremony, with hundreds of participants logging onto the digital celebration. Speaking live from Copenhagen, the international architectural icon Dorte Mandrup – whose portfolio includes an unprecedented five UNESCO World Heritage-related buildings – delivered the keynote address.

Her remarks centered on architecture shaped by unique natural environments and the threat of climate change.

In another departure from past ceremonies, the LABC changed the rules to award one winner and one finalist for each category. # Candidate similarities end with monikers

Nguyen vs. Nguyen in the 72nd Assembly District to test influence of parties

Orange County's 72nd Assembly District soon will be represented by Assemblywoman Nguyen.

But that's the only certainty heading into Election Day. The Nguyen who takes the tight race could be former state Sen. Janet Nguyen, a Republican, or Garden Grove City Councilwoman Diedre Nguyen, a Democrat.

The race for the 72nd District became one of the state's most closely watched primaries earlier

this year, after first-term Republican incumbent Assemblyman Tyler Diep of Westminster lost the backing of the Republican Party of Orange County over some votes he cast in Sacramento were deemed by party officials to be too union-friendly. That sentiment prompted fellow Republican Janet Nguyen to enter the race, and she easily overtook Diep to grab the Republican vote during the March 3 primary. On the other side of the political divide, Diedre Nguyen also handily defeated another Democratic challenger to advance to the Nov. 3 ballot.

All of this played out even as the once-safe GOP district continues to shift. But unlike most other parts of Orange County, the change in AD-72 shows Republicans picking up new voters. The GOP's registration advantage in the district has grown to 2.3 points, giving Janet Nguyen a slight edge in a contest that pundits now say leans Republican.

But that's not a lock. In 2016, voters in the district chose Hillary Clinton for president, not Donald Trump. And Democrats are pouring big money into the race in hopes of flipping the seat, a trend that has given Diedre Nguyen a financial advantage. She's raised \$1.8 million this cycle, with \$1.3 million of that total from the California Democratic Party. Janet Nguyen has raised \$1.2 million, including \$326,202 from the California Republican Party.

Janet Nguyen, 43, of Fountain Valley has been the first woman and Vietnamese American to hold

several local and state seats. She started on the Garden Grove City Council in 2004, won a county Supervisor seat in 2007 and became a State Senator in 2014. In 2017, she was named legislator of the year by the Vietnam Veterans of America, but a year later was narrowly voted out of her SD-34 seat. She's now a board member on the Orange County Foundation.

Janet Nguyen touts her record fighting for lower taxes, tuition freezes at public colleges and securing grant money for local schools. She supports the repeal of Assembly Bill 5, fewer regulations to address climate change, and making housing more affordable by reducing regulations for builders.

Democratic challenger Diedre Nguyen is a cancer scientist who holds a second degree black belt in the Korean martial art Hapkido. She was elected to Garden Grove City Council in 2016 and reelected by a larger margin in 2018. She's also been active with community organizations and events, including serving as a board member for the Lunar New Year TET Parade Festival.

If elected, Diedre Nguyen wants to take on healthcare costs, college tuition hikes and securing retirement savings.

The Register asked the two AD-72 candidates about key issues facing California:

**Q** What is one thing California has done well and one thing that needs improvement in terms of its response to the coronavirus pandemic?

**A** **JANET NGUYEN:** Californians have done a

good job protecting themselves by wearing masks and practicing social distancing, but our local economy has been devastated by the government shutdowns and our children are suffering from the school closures. We need to safely reopen.

**A DIEDRE NGUYEN:** As a scientist I was impressed that California state leadership treated COVID-19 as a serious, deadly threat from the beginning and jumped into action right away trying to procure PPE, etc. The coordination between the state and local governments needs to improve, and my city council experience in Garden Grove, helping to keep businesses and jobs afloat, will be important. The state has treated some businesses unfairly, like allowing hair salons to re-open, but not nail salons. That makes no sense.

**Q** How would you help California balance its budget amid the economic hardships triggered by the pandemic with as few negative consequences for everyday residents as possible?

**A JANET NGUYEN:** No new taxes, period. We need to cut waste, fraud and abuse from the bloated state budget. We can start with the \$100 billion high speed rail project.

**A DIEDRE NGUYEN:** Under a President Biden Administration I'm confident we can secure more funding for California's budget and the shortfalls the pandemic has caused.

Trump has played politics with an aggressive blue state-vs.-red state set of policies. An American president should be for all the people, as I will be in the State Assembly.

**Q** Would you push for any changes to California law if federal rights to abortions and gay marriage are overturned by the U.S. Supreme Court?

**A JANET NGUYEN:** Before we talk about changing any state laws, we should wait until we have a specific decision and ruling details from the U.S. Supreme Court.

**A DIEDRE NGUYEN:** I will always defend reproductive healthcare rights and a woman's right to control her own body. The same goes for marriage equality and the rights of LGBTQ+ people throughout California. I marvel at the thought that these are settled issues in our society, except for the most extreme elements, which amazingly control the Supreme Court through unfair and cowardly gamesmanship by Republicans.

**Q** How would you help make California more affordable for low- and middle-income residents?

**A JANET NGUYEN:** California is a high tax, high fee state that discourages builders from meeting housing demand and discourages manufacturing jobs. We need to cut the red tape to streamline housing project permits and build manufacturing factories. We must lower taxes and make housing

more affordable by being able to build more. We must freeze tuition hikes and allow students an opportunity for higher education without the burden of high tuition costs.

**A DIEDRE NGUYEN:** There are many policies that need changing to make life more affordable. In addition to a living wage, we need to make it easier to build more hous-

ing. Our stagnating housing supply is the number one reason housing is more and more unaffordable. Healthcare needs to be expanded to cover more people at a reasonable price, state colleges need to be made more affordable so that more people can attend and fewer leave with choking debt. We need universal preschool and affordable childcare so that parents can get relief.

## Orange County sets up \$5 million coronavirus fund for local child care providers

A \$3,500 grant may not sound like a lot of money, but it could prevent Raissa Lee from having to close the child care business she's run out of her Irvine home since 2015.

The money would come from \$5 million in emergency CARES Act funds that the Orange County Board of Supervisors recently earmarked for child care providers who have been hurt by the coronavirus pandemic. Potential recipients range from small

home-based operations like Lee's to large child care centers and afterschool programs.

"Honestly, I don't know how much longer I can stay open," said Lee, whose ABC Mom Learning Center & Child Care downsized from 12 children prior to COVID-19 in March to four children this month.

Lee figures an award of \$3,500, the maximum available to a family child care home licensed for up to 14 children, could help pay down about \$1,000 in expenses on her credit card for cleaning and sanitary supplies, along with the possibility of hiring someone to help her out a bit while waiting for things to get better.

"If I could just have someone come once or twice a week so I could actually take a break, I would be so grateful."

### **Versatile money**

The idea behind the \$5 million is to help care providers like Lee, who are struggling during the pandemic but didn't close, to keep going, while also helping other operators who did shut down to reopen.

Figures reported as of Sept. 28 to the state's Community Care Licensing, which oversees licensed child care providers, indicate that 65 family home child care providers in Orange County and 10 larger centers closed permanently. Another 298 family home child care providers and 492 child care centers at that time said they had shut down because of the pandemic, but many have since reopened, said Sandy Avzaradel, project director for Early Childhood OC, a group focused on the development of young children.

But enrollment is down for an industry that was already operating on small revenue margins, and Avzaradel said the pandemic has only "made it worse."

The cost of personal protective equipment, cleaning supplies and making changes so children maintain appropriate physical distance is the biggest challenge, Avzaradel said. The money from the county can be used to offset payroll costs, upgrade physical environment under health and safety protocols, or pay for rent or mortgages.

The county fund was approved 5-0 by the board of supervisors at their last meeting on Tuesday, Oct. 20. Grant amounts will vary, from \$2,500 to \$3,500 for family child care homes, depending on whether they are licensed for eight or 14 children; \$175 per child for child care centers; and \$100 a child in school-age group care.

The online grant application process — to be handled by the nonprofit Charitable Ventures — opens on Friday, Oct. 30 at 9 a.m., and will be issued on a first-come, first-served basis for qualifying programs. More information is available at [charitableventures.org](http://charitableventures.org).

“The intent is to be really flexible with the money,” said Kim Goll, president and chief executive officer of First 5 Orange County, the local children and families commission. “It might help some of them come back.

“It might also help us not lose any more footing. This is the bigger problem.”

First 5 has orchestrated donations of supplies to child care providers since the pandemic began. The organization also is paying the \$150,000 needed for Charitable Ventures to administer the emergency funding, Goll said.

Fourth District Supervisor Doug Chaffee, a commissioner with First 5 since 2019, and First District Supervisor Andrew Do supported the idea of channeling some of the county’s \$554 million in federal Coronavirus Aid, Relief, and Economic Security Act dollars to child care providers.

Chaffee and Do, along with others involved in the effort, discussed Orange County’s COVID-19 Child Care Relief Grant Program during a news conference livestreamed Wednesday, Oct. 28, on Facebook. It is available to watch at [facebook.com/ocgov](https://facebook.com/ocgov). Chaffee’s work was informed by a recent [First 5-commissioned child care analysis](#) that showed how the county, pre pandemic, was already not meeting the child care needs of working families. Now, Chaffee said, “it’s just a greater need than ever” to shore up child care providers.

He added: “If it’s a question of funding, then we have to find it.”

## **Survival**

Lee had to lay off her staff of two full-time teachers and three part-time college students who helped run the dual-language English and Mandarin program at her program. Now, Lee, mother to three school-age children engaged in virtual learning at home, is handling all the child care and sanitization duties by herself.

Lee, who is in her 40s, is exhausted. A grant, she said, “would make a huge difference, at least to give me a breather.”

For Yessika Magdaleno, a child care provider for 20 years in Garden Grove, the money would help pay to enclose a patio where as many as 10 children in her care now spend much of their time. The area includes 100-square-foot squares designated as their personal spots. But the weather soon will be too cold to maintain that arrangement, and Magdaleno said her house is too small to hold that many children and still keep six feet of physical distance.

She believes the county money could help her business, Little Flowers Family Child Care, and will apply for a grant as soon as possible. “I hope to be one of the first ones. I’m telling you, I’m going to get myself up early with everything ready to submit.”



## 4 people, including police officer, hurt in Garden Grove crash

The woman behind the wheel of that car, along with a 16-year-old and a toddler riding with her, were taken to an area hospital with minor injuries as was the officer, Whitney said. The driver who failed to stop at the red light avoided injury, Whitney said.

The California Highway Patrol will investigate the crash, he said.

**GARDEN GROVE** — A woman died and a man was injured in a solo-vehicle crash in Garden Grove on Sunday, authorities said.

The deceased passenger was identified as Salena Hernandez, 41, of Pomona, said Supervising Deputy Coroner Larry Esslinger.

The crash was just before 6 p.m. Sunday at the intersection of Brookhurst Street and Trask Avenue, the Orange County Fire Authority reported.

The man and woman were in a northbound vehicle on Brookhurst when they crashed into a pole, Garden Grove police Lt. Carl Whitney said.

Hernandez was pronounced dead at the scene, Whitney said.

The 42-year-old man behind the wheel, whose identity was not immediately released, was hospitalized in critical condition but was expected to survive, he said.

Whitney said the driver had just passed through a green light, but then veered to the right for an unknown reason and slammed into a traffic signal pole.

Traffic investigators will be examining the accident to determine if speed was a factor, as well as drugs and/or alcohol.

## Man gets 50-plus years for killing woman who fought his mom at Garden Grove home

A man who gunned down a woman who had been fighting with his mother in the front yard of a Garden Grove home was sentenced Friday, Oct. 23, to 50 years to life in state prison.

A Santa Ana jury last year found Nathaniel Liscano guilty of first-degree murder with the use of a firearm for the slaying of an unarmed Kellie Louise Nichol in 2016. During Liscano's trial, there was no dispute that Nichol, 31, and Liscano's mother had argued through text messages, that Liscano and his mother drove to the Garden Grove house where Nichol was visiting a friend, and that Liscano, then 19, shot Nichol to death.

Deputy District Attorney Mark Birney told jurors that Liscano asked for Nichol, who walked out of the home and proceeded to fight with Liscano's mother.

Liscano watched the fight, Birney said, then walked up to Nichol and appeared to exchange words with her before pulling out a gun and shooting her in the jaw and the chest.

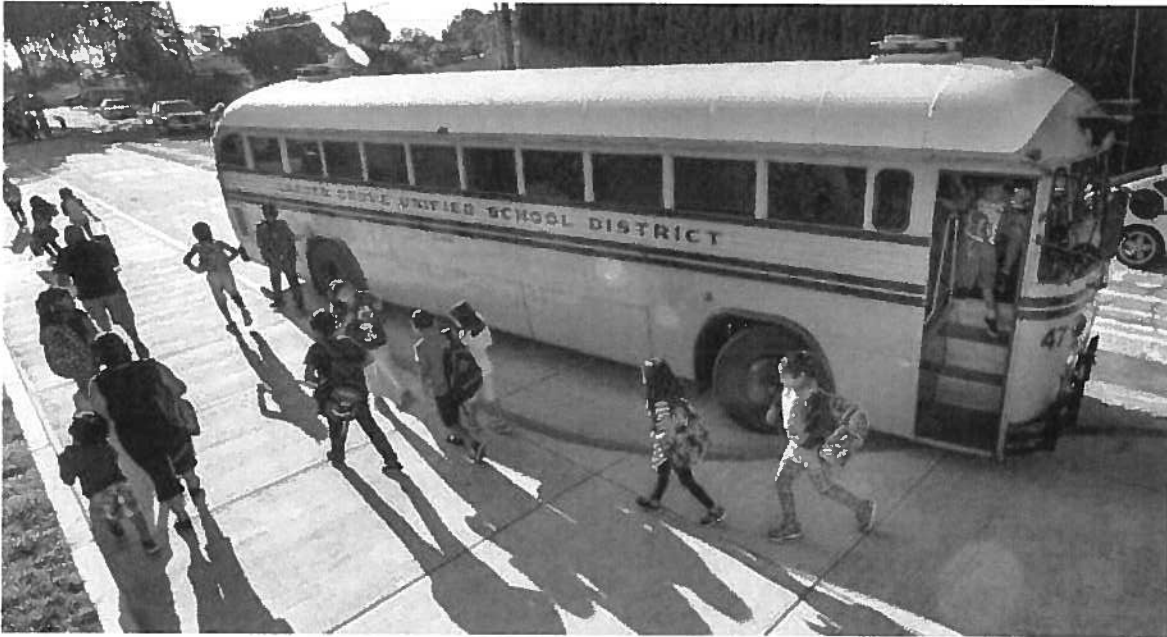
Nichol tried to run away, the prosecutor said, but Liscano shot her three more times in the back. One witness testified that Liscano said "Die, (expletive)" to Nichol as he fired the gunshots.

The prosecutor described the shooting as a "completely senseless" killing.

During the trial, Liscano's attorney, Roger Sheaks, argued that Nichol provoked Liscano and contended the killing occurred in the heat of passion.

Liscano didn't plan to kill Nichol, the defense attorney told jurors, and had brought the gun for protection, only to use it during a "momentary flash, a volcanic eruption."

Garden Grove Unified School District has a new, tiered strategy for reopening its classrooms for younger students.

Orange County's third-largest district has announced it will resume in-person instruction in three phases to help it navigate the coronavirus pandemic and meet the needs of families.

The first phase, or Tier 1, kicks off Oct. 28 with nine elementary schools, a special education center, two middle schools, Hare continuation high school and an adult transition program.

Then, on Nov. 12, 16 more elementary schools and three middle schools will resume some in-person learning.

Finally, 22 more elementary schools and five middle schools are set to begin on Dec. 1 as Tier 3.

The district will be following a hybrid model – a combination of in-person instruction and online learning.

The district didn't release a start date for its seven main high schools, but mentioned Dec. 1 as a potential target.

"Opening in phases allows the district to allocate additional resources to one set of schools at a time to ensure a safe and smooth transition to in-person learning for our students and staff across our nearly 70 campuses," the district said in a letter to parents on Oct. 21.

"A great deal of variation exists across our large, diverse district in respect to COVID-19 rates by ZIP code, parent and student interest in returning, staffing, and local community context," officials said.

The schools in Tier 1 are: Barker, Bryant, Eisenhower, Enders, Garden Park, Marshall, Monroe, Patton, Sunnyside, Mark Twain Special Education Center, Bell, Walton, Hare and Jordan adult transition.

The schools in Tier 2 are: Allen, Anthony, Clinton Corner, Cook, Excelsior, Gilbert, Hill, Mitchell, Morningside, Northcutt, Paine, Peters K-3, Riverdale, Wakeham, Woodbury, Zeyen, Irvine, McGarvin, and Ralston.

The district also plans to open some special education classrooms at the elementary level in Tier 2.

The Tier 3 schools are: Brookhurst, Carver and Early Childhood Education programs, Carrillo, Clinton, Crosby, Evans, Faylane, Hazard, Heritage, Lawrence, Murdy, Newhope, Parkview, Peters 4-6, Post, Rosita, Russell, Simmons, Stanford, Stanley, Violette, Warren, Alamitos, Doig, Fitz, Jordan and Lake.

In mid-September, the district of about 40,000 students reversed its reopening plans for in-person instruction in part because of feedback from parents.

The district originally planned to reopen elementary schools to in-person instruction on Oct. 5 and middle and high schools on Oct. 12.

"All return-to-school reopening dates remain contingent on local COVID-19 rates remaining low or improving," district officials emphasized.

A car caravan protest against schools reopening was planned by BAMN (By Any Means Necessary) in Garden Grove on Oct. 17. The group wants mass testing and a “safe” vaccine before schools reopen.

Another BAMN protest is planned for Friday, Oct. 23 starting at Rosita Park in Santa Ana at 3:30 p.m.

Garden Grove Unified says its students come from five different cities: Garden Grove, Santa Ana, Fountain Valley, Westminster and Stanton.

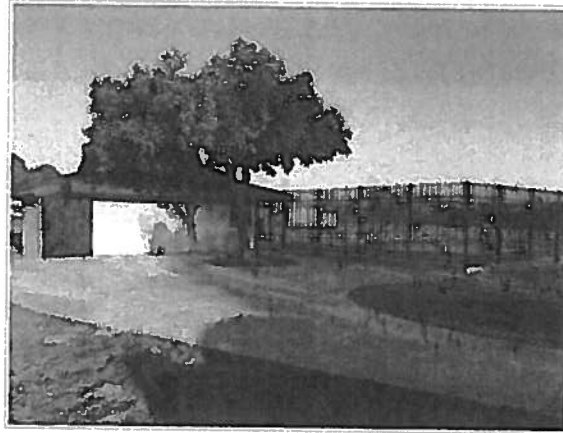

C.1. SITE PLAN NO. SP-091-2020

APPLICANT: PETE SHAVER

LOCATION: SOUTHWEST CORNER OF TRASK AVENUE AND BROOKHURST STREET AT 9898 TRASK AVENUE

REQUEST: Site Plan approval to expand the existing Hyundai car dealership showroom and service center. Currently, the store operates with an ABC Type "20" (Off-Sale, Beer and Wine) License without a Conditional Use Permit. The Garden Grove Municipal Code requires the approval of a new Conditional Use Permit when there is a change of ownership of an ABC licensed establishment not possessing a Conditional Use Permit approved after January 1, 1986. The site is in the C-2 (Community Commercial) zone. # League weekly COVID-19 update: Oct. 22-28

October 28, 2020

After months of advocacy efforts by a joint coalition of the League, California State Association of Counties, California Restaurant Association, and California Travel Association, Gov. Gavin Newsom issued an executive order on Oct. 28, granting our request for a process by the California Department of Transportation to issue temporary encroachment permits enabling commercial activities in the state highway right-of-way.

This order will support businesses located along state highways to expand their outdoor dining options onto sidewalks and parking areas, expanding on a safe opportunity for diners to enjoy a meal and help support local businesses struggling with the economic impacts of COVID-19.

Washington, Oregon, and Nevada joined the state's COVID-19 Scientific Safety Review Workgroup, which will independently review the safety and efficacy of any vaccine approved by the U.S. Food and Drug Administration for distribution. The workgroup consists of nationally acclaimed scientists with expertise in immunization and public health.

On Oct. 23, the Governor announced the Joint Legislative Budget Committee's approval to use an additional \$200 million from Coronavirus Relief Funding for Homekey. This brings the total funding available for Homekey to more than \$800 million, continuing California's program to purchase and rehabilitate housing for people experiencing or at risk of experiencing homelessness.

Additionally, as part of the \$200 million approved for Homekey use, the Governor announced \$81.4 million for the sixth round of Homekey. Cities selected in the sixth round of funding include Oakland with \$17.5 million for two projects totaling 103 units, and San Francisco with \$29.1 million to convert a 130-room property to permanent housing.

To date, more than \$709 million has been awarded to 45 applicants and 78 projects totaling 5,068 units. The average per-unit cost to Homekey is \$139,000 – well below the average cost in California to build new housing units. The additional funding will allow the state to clear most of the Homekey waitlist with two more award portions to local jurisdictions, including the sixth round that was just released.
