# Guide to Garden Grove's Construction & Demolition Recycling Ordinance

Updated 2/14/2022



#### WHY IS THERE A RECYCLING ORDINANANCE?

Effective January 2019, the City adopted a Construction and Demolition Waste Recycling Program Ordinance (Municipal Code Chapter 18.60) to help comply with the California Green Building Standards Code and Waste Management Act recycling requirements. State Law requires that construction and demolition projects divert 65% diversion of all non-hazardous construction materials from landfills. This program includes a requirement for refundable security deposits, diversion plans and diversion



reporting, that will assist the City in monitoring and obtaining compliance. The majority of construction debris can be reused or recycled, conserving natural resources and saving valuable landfill space.

#### WHAT IS CONSTRUCTION & DEMOLITION (C&D) DEBRIS?

Common C&D materials are non-hazardous waste that include lumber, drywall, metals, masonry (brick, concrete, etc.), carpet, plastic, pipe, rocks, dirt, paper, cardboard, or green waste related to land development.

#### **HOW TO COMPLY**

- □ **Step 1** When applying for a Building Permit or submitting plans at the Building Counter, it will be determined if a Construction Waste Management Plan is required. This application will need to be completed online using the Green Halo System at www.gardengrove.wastetracking.com
  - A Step By Step User Guide is included for reference.
  - If you do not have access to a computer, paper applications will be available. A separate processing fee will be incurred in addition to the admin fee.
- ☐ Step 2 Pay Security Deposit Fee. Read the instructions on the back page of the deposit invoice. SAVE your deposit invoice to obtain your refund.
- ☐ Step 3 Complete and submit the Construction Waste Management Application
  Online when plans have been approved and permit is issued. Identify which
  authorized recycling / transfer facility you will be using and what materials will be
  generated.
  - Options for Recycling & Disposal:
  - (1) Order a roll off bin through City's exclusive hauler Republic Services OR (2) Self Haul using City Approved Facilities (See Last Page)
  - When ordering your bin from Republic Services "Roll Off Bin" service, it must be specified as
     "Construction Bin"

- Information about the facility
- Tonnage Amounts
- Source/Origin- Garden Grove
- Appropriate coding to indicate that the material was properly recycled as construction and demolition debris- <u>It is incumbent upon the Contractor/Owner to tell the weight</u> <u>master/scalehouse attendant at waste processing facility to process waste as "Construction & Demolition"</u>, not Greenwaste or MSW/Trash and review tickets prior to leaving facility to ensure City receives diversion.

Contractor/Owner is responsible for thoroughly reviewing waste ticket(s) prior to submittal to Green Halo System at www.gardengrove.wastetracking.com. No correction or resubmittal of waste tickets is allowed. All decisions are final. It will take approximately 6-8 weeks from the date all required documents were submitted and deemed as "complete and compliant". Failure to submit required documents will result in Security Deposit Forfeiture.



#### SAMPLE WASTE TICKET





Three main steps are involved when creating your Construction Waste Management Plan (CWMP).

- 1. Create an account with <a href="www.gardengrove.wastetracking.com">www.gardengrove.wastetracking.com</a>
- 2. Log in to account and submit a CWMP plan
- 3. Upload weight tickets and submit for final review to complete the CWMP process.







Step 1 - Creating an Account

Click on "Create a Waste Management Plan"


Enter Project Name and Street Address and click on "New Account"

Enter your email and enter password twice and click on "Create"















#### Step 2 - Create and Submit a CWMP

After logging into system, click on "Add Another Project"



















Step 2 – Create and Submit a CWMP

For most projects, you will check "Mixed C&D". If you plan to separate materials, click on the materials under the "Source Separated Materials" section and select "Reuse" or "Recycled".

Select your hauling method (roll off service or self-haul) and agree to the Terms and Conditions. For Roll-Off Service, only one hauler, Republic Services, can provide this service.





Step 2 – Create and Submit a **CWMP** 

For self-haul, only City authorized haulers can be obtained. Select from the list provided. Each type of material must be accounted for by choosing a facility.






Step 2 – Create and Submit a CWMP

After reviewing the terms and conditions, check the box. Then type in your name and select your title. Once finished, click on "Submit Project for Approval"





With any option used, ensure the tickets are legible. All tickets must show the Net Weight, Origin-Garden Grove and must be from an approved facility.

Tickets that reference MSW (trash) are non-acceptable.


After information is entered, and reviewed for accuracy, then click on "Submit Ticket"

Step 3 – Uploading Weight Tickets for Final Review

After all tickets have been entered, click on "Submit for Final". City staff will review your tickets and when approved, you will receive an email confirmation from Green Halo.
